A regular meeting of the Executive Board (the Board) of the Yuma Metropolitan Planning Organization (YMPO) will be held on Thursday, December 14, 2023, starting at 1:30 p.m., either In-Person and/or using GoToMeeting Video/Teleconferencing from the YMPO Offices at 230 West Morrison Street, Yuma, Arizona, 85364, to discuss, consider, and/or take possible action concerning the items listed below. Members MAY attend in person, with the appropriate social distancing, if they wish, but may also choose to participate by video or teleconference, if they so desire.

1. Call to Order and the Pledge of Allegiance

The meeting will be called to order and members will be asked to recite the Pledge of Allegiance.

2. Roll Call Attendance and Declaration of Votes

Blenda Dale, YMPO Accountant II/Executive Assistant, will call the attendance roll, and if any members of the City of Yuma are not in attendance, those members that are in attendance will have the opportunity to declare the number of votes that each member will exercise, including any proxy votes.

3. Title VI Declaration and Call to the Public

Jesus Aguilar, Jr., YMPO Mobility Manager, will read a brief message reminding members of our Title VI obligations. In addition, this item provides an opportunity for comments by the public on subjects *not* on the agenda. 5. FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) Amendment #1 and Air Quality Conformity Update

The consultant Kittleson and Associates continues to work on the FY 2022-2045 YMPO LRTP Amendment #1 and Air Quality Conformity update for Yuma County, City of Yuma, and ADOT projects after receiving feedback from the Interagency Council (IAC). Some revisions were necessary after finding out that the Environmental Public Agency (EPA) rescinded the 2007 motor vehicle emission budgets and were inadequate to use. Because there are no established emission budgets for YMPO to use, EPA recommended conducting a build/no-build interim budget test for each analysis year for conformity purposes. This analysis requires a larger effort by the consultant and requires an amendment to the contract. A revised draft will be sent to the Interagency Consultation (IAC) for review of the conformity determination. YMPO staff will provide an update and revised anticipated timeline for completion and final approval.

6. FY 2022-26 YMPO Transportation Improvement Program (TIP) Amendment #11

The FY 2022-26 YMPO TIP was initially approved on July 29, 2021, and has since been amended ten times, most recently on August 24, 2023. During the review of the projects within the LRTP Amendment #1 and Conformity Analysis, YMPO was informed by Federal Highway Administration (FHWA) that an Air Quality Conformity Analysis was required for the newer YMPO FY 2024-28 TIP that was approved by the Executive Board on June 29, 2023, due to the off-cycle years to the update of the FY 2022-45 LRTP. The current federally approved TIP remains to be the FY 2022-26 TIP.

Some rework is required to get the federal approved FY 2022-26 TIP updated so projects can move forward. FHWA recommended moving all the projects from FY 2024-2028 TIP to the previously adopted FY 2022-26 TIP. The TAC is aware, informed and will possibly recommend action by the Board to rescind the FY 2024-28 TIP, Resolution #155 and subsequent amendment thereafter (#1 and #2) and possible action for the approval of the FY 2022-26 YMPO TIP Amendment #11 containing transfer of projects as explained.

This item is on the agenda for information, discussion, and possible actions by the Board:

(1) to Rescind the motion approved on June 29, 2023, of the YMPO FY 2024-28 TIP, Resolution #155, and subsequent amendments thereafter (#1 and #2) of the FY 2024-28 TIP adoption.

(2) to approve the YMPO FY 2022-26 TIP Amendment #11. Mr. Villegas will present this item and further information is contained in an information summary as Item 6.

7. FY 2026-2050 YMPO Long-Range Transportation Plan (LRTP) – RFP Status

On November 9, 2023, YMPO released the advertisement of a Request for Proposal (RFP) for the FY2026-2050 LRTP Update. The RFP electronically notified over 30 engineering consulting companies and an ad placed in the Yuma Sun. The deadline for submitting questions regarding the RFP was November 20, 2023, and the deadline for submitting the Proposals is December 7, 2023. Currently, only one company has submitted questions regarding the LRTP RFP.

This item is on the agenda for information, discussion, and possible action. Ms. Figueroa will present this item and further details are provided in an information summary that is included as Item 7.

8. Transportation Alternatives (TA) Program - Status

Under the Bipartisan Infrastructure Law (BIL)'s Surface Transportation Block Grant (STBG) Program, the TA Program set aside provides funding for projects that help States build a variety of smaller-scale alternative transportation projects that achieve safer, connected, and equitable on-road networks for all users. A call for projects went out in July, with applications accepted through the end of August. Three applications within the YMPO region were submitted for consideration; the TA Technical Advisory Committee completed their review and ranking in October. The ranked projects were referred to the State Transportation Board (STB), and during the STB meeting on November 17, 2023, the Board approved 30 projects across Greater Arizona for the FY 2024 cycle.

9. YMPO Legal Counsel Services

As requested during the September 2023 Board meeting, YMPO staff have carried out the process to advertise for Legal Services for the next three-year period. The recommendation is to retain the services with Benesch, Shadle & White, PLC.

10. FY 2024-25 YMPO Unified Planning Work Program (UPWP) Amendment #2

The FY 2024-25 YMPO UPWP and Annual Budget (UPWP/B) was approved by the Board on May 25, 2023. At the September Executive Board meeting, we discussed the Request for Proposal (RFP) for Legal Services. An administrative only amendment was needed to obtain a project number for the RFP to be advertised. Now we need to amend the UPWP to confirm monies carried forward, new fund amounts confirmed and adjust where some funding will be used.

This item is on the agenda for information, discussion, and possible approval of the FY 2024-25 UPWP Amendment #2. Ms. Figueroa will present this item and further details are contained in an information summary that is included with this agenda packet, as Item 10.

11. In-Kind Match for FY 2024-25

During the last few Executive Board meetings, we discussed the changes in "In-Kind" matching funds received from Yuma County and its effects on In-Kind match revenue to match federal grants. The indirect cost rate of the Yuma County

donated services has significantly decreased and requires other In-Kind sources to compensate for the lower rate. To that end, YMPO staff have identified other sources for In-Kind and will present them to the Board, including potential side effects on member entity dues moving forward.

12. FY 2023 YMPO Audit Update

The current FY 2023 Audit is underway. YMPO staff has been working with our financial consultants to produce the necessary annual financial statement that will be submitted as part of the annual audit process and will present an update on the progress and expected presentation of the Annual Comprehensive Financial Report to the Audit Committee and Executive Board.

13. FY 2024 Defense Community Infrastructure Pilot (DCIP) Program Opportunity

The DCIP Program is a competitive grant program that enables state and local projects to address deficiencies in community infrastructure that support a military installation. Last month, YMPO was notified of the upcoming opportunity for the 2024 grant cycle of the DCIP Grant; the Notice of Funding Opportunity is anticipated to be issued in March 2024. While Congress has yet to finalize the fiscal year 2024 appropriations and authorizations, eligible applicants are encouraged to start drafting their proposals for the DCIP now.

In FY 2022, YMPO, in collaboration with the Arizona Department of Transportation (ADOT) and support of the YPG commander, pursued a \$13.3 million grant application for US 95 to widen the segment of US-95 from Rifle Range Road to just north of the Wellton-Mohawk Canal. The application was successful, and the project is currently underway. The Board will be able to provide feedback and direction to the Executive Director in coordinating with grant stakeholders and pursuing a potential grant.

14. Arizona 2024 Safety Performance Projections (Targets)

The Federal Highway Administration (FHWA) requires that Metropolitan Planning Organizations either develop and adopt their own Transportation Performance Measures (TPMs) or adopt the State's. On August 31, 2023, the Arizona Department of Transportation (ADOT) formally established Safety Projections (SP) for the State of Arizona for 2024. These SP or (Targets) are based on the Safety Performance Measures established by the Federal Highway Administration's (FHWA) Safety Performance Management (Safety PM) final ruling and are based on five year rolling averages.

ADOT requests a letter from YMPO within 180 days of the effective date, August 31, 2023, indicating whether YMPO supports ADOT's Safety Projections or identifying YMPO's SP Projections. YMPO has reviewed the SP prepared by ADOT, and the TAC is currently reviewing and may recommend approval by the Board of the State SP by the December 14 TAC meeting.

This item is on the agenda for information, discussion, and possible action to adopt the State 2024 Safety Performance Projections (Targets). Mr. Villegas will present this item and further information is included in an Information Summary attached as Item 14.

15. Safety Action Plan Collaboration

The Bipartisan Infrastructure Law established the Safe Streets and Roads for All (SS4A) discretionary program with \$5 billion in appropriated funds over 5 years, 2022-2026. The SS4A program funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries.

The City of Yuma applied for and was awarded an FY 23 SS4A Planning and Demonstration Grant to develop, complete, or supplement a comprehensive Safety Action Plan. YMPO last conducted a Strategic Transportation Safety Plan Update for the region in 2019, developed using crash data from 2014-2018. YMPO currently has funding programmed to carry out a safety update for the region; however, to avoid duplication of efforts and considering the SS4A grant awarded to the city and the development objectives of the plan, the idea of collaboration to include the rest of the region in the Safety Action Plan at a cost to YMPO via an intergovernmental agreement is viable per communication with city staff.



MOTION: Councilmember Morales moved to approve the consent agenda for both items A and B. Councilmember Ortega seconded, and the motion was unanimously approved.

5. Introduction of Imperial County Representative

YMPO Executive Director, Crystal Figueroa said that YMPO is recognized as a bi-state metropolitan planning organization. As such, a portion of Imperial County, California is within YMPO's planning boundary, specifically the Winterhaven urban area. She stated that YMPO is responsible for coordinating transportation planning within the comprehensive area. Ms. Figueroa welcomed David Aguirre, Executive Director of the Imperial County Transportation Commission (ICTC) to the Executive Board.

The ICTC Executive Director, David Aguirre said he has been with the organization for two years. He explained the commission is the regional planning organization for the area. The commission handles the planning and preparation of county-wide plans such as the Long-Range, Short-Range transportation, transit plans, and climate action plans. Their region encompasses all the cities within Imperial County and the Imperial Irrigation District. Mr. Aguirre mentioned that they are also the

public transit provider for the county. They work with YCIPTA (Yuma County Area Transit) which provides service for Yuma to Quechan, El Centro, Winterhaven, and other rural areas. They provide administration for the Resource Management Agency of Imperial County and also undertake their own transportation and transit infrastructure projects.

Councilmember Knight mentioned that off the Interstate 8 offramp on Fourth Avenue westbound is virtually impossible to make a left turn due to traffic. He felt a stoplight would be of benefit to the area. Currently, drivers are turning right to make a U-turn further down the road to proceed south. He asked Mr. Aguirre for assistance in this matter.

Mr. Aguirre said he would speak with CalTrans and Imperial County regarding this intersection.

Ms. Figueroa mentioned that once Mr. Aguirre onboard a Transportation Planner for ICTC, YMPO will include the individual to attend the Technical Advisory Committee (TAC) meetings and continue to include him in the Executive Board agenda distribution.

6. Transportation Alternatives (TA) Program Update

YMPO IT Manager and Associate Planner, Jeff Heinrichs, reviewed that the TA Program is a 10% set-aside of the Surface Transportation Block Grant (STBG) Program. ADOT plans for FY 2022-2026 to receive an average of \$18.4 million annually for the TA program.

He said there were three projects that YMPO provided LOS (Letters of Support) for and these were accepted as part of the ADOT initial TA Screening Process. Statewide there were a total of 30 projects that were evaluated and scored. The TA TAC reviewed and scored the projects using criteria scoring for Technical Quality, Schedule, Community Support, and Plan Alignment. ADOT applied an equity criterion to normalize the scores for the various areas throughout the state.

The output of the scoring process provided a ranked list of the TA projects that will be submitted to the State Transportation Board for review and approval. The total TA funding requests for the 30 state-wide projects was around \$13M of an available \$18M funding. So, all of the thirty programs will most likely get funded this year for either design or construction planning. On November 17, 2023, the ranked list will go before the State Transportation Board for review and approval.

He went on to explain what types of projects could be eligible for this funding opportunity such as Safe Streets to Schools, multimodal planning, historical preservation, recreational pathways, and pedestrian and bike trails.

Ms. Figueroa explained that this program would continue and is currently funded for the next four to five years and will be a continued effort for the next round of call for projects likely to happen in March of 2024. She said it was a learning process to see how the program was established and moving forward YMPO expects to be able to provide even better guidance to the applicants to ensure they meet all the program criteria.

Mr. Heinrichs added to the discussion saying once they understood the scoring criteria, YMPO should be able to assist even more with this process.

Councilman Knight said that the City of Yuma was looking at a multi-use path from 28th Street to 24th Street to connect the existing path from 32nd Street to 28th Street. This will eventually extend down to Avenue C. This project could be eligible and has already gone through the planning process. He stated that the current budget for the project was estimated at \$300K around and the bid came a bit over \$500K. Ms. Figueroa stated that it seemed that the project was already designed and had gone over the planning phase and excess of funding may come out of the contingency fund. Mr. Knight confirmed that project is already on the November City Council agenda for possible approval, he recognized that it could have been a good candidate for the TA Program.

Ms. Figueroa suggested that YMPO reach out to Dave Wostenberg to discuss this project at the next Technical Advisory Committee (TAC) which meets on November 9, 2023.

7. FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) Amendment #1 and Air Quality Conformity Update

Senior Transportation Planner, Fernando Villegas explained that an amendment is needed for the FY 2022-2045 YMPO LRTP. The change is needed for three existing projects involving an Air Quality Conformity update. The consultant is carrying out the changes and are anticipated to be completed next week.

The three projects are:

1. Yuma County's Avenue E / Avenue D Extension: County 23rd Avenue to County 16th Street; they are extending the project limits by two miles.
2. City of Yuma's 40th Street Widening: Avenue 6 3/4 E to Avenue 7 1/2 E originally is expected to be amended all the way to Fortuna Ave in the Foothills; they wish to advance the project dates from FY2032-2036 to FY2022-2026.
3. YMPO/ADOT's US 95 widening from Wellton Mohawk to Aberdeen; they wish to advance the project dates from FY2032-2036 to FY2022-2026.

According to the consultant, the PM10/NOx/VOC emission analysis results are still within the established motor vehicle emissions budgets. The draft was sent to the Interagency Consultation (IAC) for review of the conformity determination. He explained that the TAC would then review the draft on November 9, 2023 to recommend to the Board for possible approval. It may be necessary to hold a special Executive Board meeting on November 16th for approval of Amendment #1. If this is completed, YMPO would then submit the final LRTP Amendment #1 and Air Quality Conformity update to the EPA.

Ms. Figueroa explained that the 40th Street project was discussed at the Rural Transportation Summit this month and it was determined that this project needs to be extended to Fortuna Road, since the City of Yuma is considering applying for an Multimodal Project Discretionary Grant (MPDG) Program. If this is done, the project horizon dates may need to be changed as well. This information was provided to YMPO yesterday evening and the additional information would be presented to the TAC at their next meeting. She explained that if this project is extended it would go into Yuma County's jurisdiction.

Mr. Villegas then stated that the City of Yuma boundary is up to 10E project boundaries would be discussed during the next TAC meeting and the final determination would then be presented to the Executive Board for consideration and approval of Amendment #1.

8. FY 2026-2049/50 YMPO Long-Range Transportation Plan (LRTP)

Mr. Villegas stated that YMPO is working on the request for proposal (RFP) for the LRTP. The LRTP plan is a federal requirement of Metropolitan Planning Organizations and is to be developed every four years for air quality non-attainment and maintenance areas. He provided a timeline to complete the RFP as follows:

11/9/2023 Release the RFP

12/7/2023 RFP submittals are due by 3 p.m.

12/18/23 Interviews, if needed, will be completed by the TAC sub-committee

1/4/2024 YMPO Executive Board approves the selected firm

1/4/2024 Letters will be sent to all firms regarding the selection

4/28/2025 The First draft of the LRTP is due for the TAC meeting

6/26/2025 Estimated YMPO FY 2026-50 LRTP final report due for Executive Board approval

Ms. Figueroa went on to explain that a special Executive Board meeting will need to occur both in person and/or virtually on January 4, 2024, in order to meet important deadlines for possible safety project applications and issue a notice to

proceed in early January. The next Executive Board meeting would be in December and would incorporate November and December.

9. 2023 Arizona Rural Transportation Summit (AZRTS) Recap

Ms. Figueroa said the Rural Transportation Summit was a year-long planning process. She reviewed some of the speakers and organizations that participated in the event. She explained the theme for the conference was very relevant to the rural organizations attending the Summit. The presentations included funding opportunities such as ROUTES, TA, and Off-System Bridge programs. She felt the event was very well planned and attended.

Councilmember Morales said he thought it was a great networking and educational experience where he got to speak about needs in the Yuma region. Councilmember Knight thought the event structure, with a single session, was better than several break-out sessions happening simultaneously; this ensured the audience could hear any or all the sessions they wished. Mr. Knight thanked the staff for their planning efforts.

Supervisor Pancrazi mentioned that she couldn't attend the conference but heard from several of her peers that the Summit was one of the best they'd participated in. She acknowledged the Director and staff for a well-planned conference.

Figueroa said one of the highlights of the Summit was the Rural Transportation Advocacy Council's (RTAC) initiative for \$400M of regional priority projects in rural Arizona. She explained that this effort would be introduced to the State Legislators as a proposed bill for infrastructure funding. She mentioned Mr. Knight showcased the number one YMPO regional priority project, US - 95, and is how the state allocated 33.3M of the financing through the legislative process.

Vice Mayor McCollough felt the agenda was focused on what Metropolitan Planning Organizations do, and staff planned a great welcome reception where guests could network.

Councilmember Ortega was pleased with the Tribal Partnership Program, which ended up being a well-attended session with Tribal members and various entity staff.

Board members congratulated and recognized YMPO staff planning efforts and a job well done.

10. FY 2024-25 YMPO Unified Planning Work Program (UPWP) Administrative Amendment #1

YMPO Accountant and Executive Assistant Blenda Dale explained that the current contract with our legal services ends this calendar year. Although not required, it was recommended that YMPO advertised for Legal Services through a request for Proposal (RFP) per YMPO Policies and Procedures regarding Procurement. To do so, YMPO needed to obtain a project number and a Disenfranchised Business Enterprise (DBE) number for the RFP to proceed.

Although the funds were budgeted in the Unified Planning Work Program for Legal Services, ADOT required YMPO to identify the Legal consulting services project as part of the anticipated Study Funding table in the approved FY 2024-25 YMPO Unified Planning Work Program Budget. She reported that an Amendment to the Unified Planning Work Program (UPWP) was needed to obtain a project number from ADOT to include in the RFP before advertisement. Ms. Dale confirmed that the approved funding amounts stayed the same.

Ms. Figueroa added that YMPO did have the legal services already budgeted in the Work Program (UPWP) but did not have the consulting activity listed.

Ms. Dale said that YMPO staff should complete the RFP process before the end of the year for the Executive Board's approval selection of a confirmed legal firm by the December 14 Board meeting.

SUBJECT: FY 2022-2045 YMPO LRTP Amendment #1 and Air Quality Conformity Status Update

SUMMARY:

The YMPO 2022-2045 YMPO LRTP was initially approved on July 29, 2021. The consultant Kittelson & Associates continues to work on the FY 2022-2045 YMPO LRTP Amendment #1 and Air Quality Conformity update for Yuma County, City of Yuma, and ADOT projects after receiving feedback from the Interagency Council (IAC).

After YMPO was informed by Environmental Public Agency (EPA) that YMPO 2007 emissions budget was withdrawn on June 16, 2022, and cannot be used. The consultant has been working on conducting a build/no build interim budget test for each analysis year for conformity purposes. This analysis requires a larger effort by the consultant and requires an amendment to the contract. YMPO staff provided the consultant a list of completed projects, roadway projects under construction, and new roadways in the YMPO area for the build/no build interim budget test.

A revised draft will be sent to the Interagency Consultation (IAC) for review of the conformity determination on December 11, 2023.

Below is an anticipated timeline for completion and final approval of the YMPO 2022-2045 YMPO LRTP Amendment #1 and Air Quality Conformity Update.

FY 2022-26 YMPO Transportation Improvement Program – Amendment #11

DATE: December 14, 2023

SUBJECT: FY 2022-26 YMPO Transportation Improvement Program (TIP), – Amendment #11.

SUMMARY:

The FY 2022-26 YMPO TIP was initially approved on July 29, 2021, and has since been amended ten times, most recently on August 24, 2023. During the review of the Long-Range Transportation Plan (LRTP) Amendment #1, YMPO was informed by the Federal Highway Administration (FHWA) that an Air Quality Conformity Analysis was not done for the most recently adopted FY 2024-2028 TIP approved by the YMPO Executive Board on June 29, 2023. For this reason, YMPO is not allowed to use the FY 2024-2028 TIP until an Air Quality Conformity Analysis is done, and it has been approved by the FHWA. The current federally approved TIP remains to be the FY 2022-26 TIP.

FHWA recommended moving all the projects from the FY 2024-2028 TIP to the previously adopted FY 2022-2026 TIP because an Air Quality Conformity Analysis was done for the previously adopted TIP, and it was approved and found in conformity by the FHWA. Only those new projects that are not in conformance with the LRTP will require an Air Quality Conformity Analysis and are included as part of the FY 2022-45 LRTP amendment #1 currently in progress.

By moving all the projects to the FY2022-2026 TIP YMPO members can continue with their projects if the projects are in conformance with the LRTP. Some of the existing projects are already part of the FY2022-2026 TIP, but they have been moved from a different fiscal year, replaced with another type of funding or local contribution has changed.

In the attached tables below, you will find the proposed changes. The tables only include projects that are being proposed to be removed from the TIP table in **red text**, modified or new projects are highlighted in colors.

SUBJECT: FY 2026-50 YMPO Long Range Transportation Plan (LRTP) – RFP Status

SUMMARY:

YMPO is required to update our LRTP at least every four years and the LRTP needs to have a minimum twenty-year planning horizon and forecast period. As a result, YMPO selects a 24-year-long LRTP (including the start and end years). Generally, the first five years of the LRTP comprise the YMPO Transportation Improvement Program (TIP). The last LRTP was the FY 2022-2045, and congruent cycle TIP FY 2022-2026.

On November 9, 2023, YMPO advertised a Request for Proposals (RFP) for the LRTP that was electronically sent to over 30 different engineering consulting companies, mainly in Arizona, with some in the Yuma region. The deadline for submitting questions about the RFP was November 20, 2023. Questions from one company were received and answers were provided and posted on the YMPO website.

The deadline for submitting proposals is December 7, 2023, and members of the YMPO Technical Advisory Committee (TAC) are expected to review submittals between then and their scheduled December 14, 2023, meeting. At that meeting, TAC members are expected to recommend a preferred consultant team if no interviews are needed, or additional time is requested for review.

FY 2024-25 YMPO Unified Planning Work Program Amendment #2

DATE: December 14, 2023

SUBJECT: FY 2024-25 YMPO Unified Planning Work Program (UPWP) Amendment #2

SUMMARY:

Every two years, the YMPO develops the UPWP and Annual Budget in steps over a several-month timeframe. The Executive Board originally approved the current FY 2024-25 UPWP on May 25, 2023, and since then an administrative amendment on October 26, 2023.

Based on the close-out of the State fiscal year and the start of the Federal fiscal year, FY 23 carried forward funds, and new FY 24 funds have been confirmed and included in the amendment staff report. Other changes include staff and fringe benefit changes and added funds to the Long-Range Transportation Plan to include the HSIP Application efforts to fund potential safety projects in the region. Also, increase the Safety Study Budget. Further details are shown in the four tables attached and explained in a Staff Report Memorandum. The only budget being directly affected at this stage is for the FY 2024 budget.

TECHNICAL: Many, but not all, of the Federal funds available to the region may be carried forward from one fiscal year to another. In addition, the Infrastructure Investment and Jobs Act (IIJA, also known as the Bipartisan Infrastructure Law, or BIL) and the change in local In-Kind donations may change the local match required by member agencies. This will be researched further and presented to the Executive Board in a future meeting.

POLICY: Title 23, Code of Federal Regulations (CFR) §450 et al., contains guidance on what projects need to be carried out by MPOs.

ACTION NEEDED:

This item is on the agenda for review, discussion, and possible action to approve Amendment #2 to the current FYs 2024 and 2025 UPWP, specifically, the FY 2024 budget.



The following is a list of the changes being requested to FY 2024 of the FY 2024-25 YMPO UPWP under Amendment # 2:

1. Corrected FY 23 SPR carried forward from \$160,811 to \$173,865.
2. Corrected FY 23 PL carried forward from \$128,215 to \$184,629.
3. Corrected FY 23 5305dCPG brought forward from \$3,168 to \$53,585.
4. Corrected FY 23 5310 carried forward from \$17,844 to \$16,628.
5. Decreased FY 24 5310 funds to reflect annual award from \$75,000 to \$71,000.
6. Decreased FY 24 PL Funds from \$463,940 to \$454,098 to reflect award amount. This includes \$70,247 from FY 23 apportionment that was obligated into the FY 24 award of \$383,851 as a result of the Bipartisan Infrastructure BIL.
7. Staff wages and fringe benefits were added as follows:
 - a. Promoted Mr. Heinrichs from part-time to full-time status
 - b. Addition of employee-dependent health insurance
8. Increased LRTP budget from \$360k to \$412k to include HSIP Application efforts for member agencies.
9. Increased Safety Study budget from \$92,400 to \$118,650 to incorporate regional safety efforts.

The amount of the total (Federal & State funds) budgeted for FY 2024 of the FY 2024-2025 UPWP was increased from \$1,570,745 to \$1,683,018, which represents a total increase of \$112,273.

SUBJECT: In-Kind changes for FY 2024-25

SUMMARY: The Yuma Metropolitan Planning Organization (YMPO) is largely funded by grants from the federal government. For many of these grants, member agencies are responsible for providing different non-federal match rates that may come from (state, local, and industry in-kind matches). This means that the value of an individual's time and any expenses incurred by members while attending a meeting or working on any items pertaining to the YMPO can be used to match our grants; this is only the value of time. Local match is important to the YMPO Unified Planning Work Program (UPWP) and Annual Budget each year, and in-kind matches from the industry and other participants help demonstrate the type of voluntary activity that has value to the YMPO organization and other constituencies in and outside of Yuma County.

YMPO uses these resources to "match" our expenditures and thus reduce the amount our member agencies pay in entity dues annually. In the past, the majority of the local match funds came from In-Kind generated from financial activities completed by Yuma County. However, since 2021, Yuma County Services have decreased. Management of the YMPO Treasures account was automated to go directly through the County Treasures rather than the Finance Department, which requires less work. Also, since the IT Manager Jeff Heinrichs' onboarding, YMPO no longer relies on the County for IT services except for emergencies. In addition, the calculation used to determine the amount of In-Kind is derived from their Cost Allocation Plan, which utilizes figures based on expenditures from two years prior. This means that the FY 2023 figures are based on 2021 expenditures.

To that end, there has been a significant decrease in In-Kind match generation from Yuma County. Currently, YMPO does not have enough In-Kind revenue to match expenditures and is utilizing the second source of local match in the form of cash from member entity dues to make up the difference.

Defense Community Infrastructure Pilot (DCIP) Program Grant

SUBJECT: Defense Community Infrastructure Pilot (DCIP) Program Grant Opportunity.

SUMMARY:

The DCIP Program is a Department of Defense effort administered by the Office of Local Defense Community Cooperation (OLDCC). The program is a competitive grant program to enable State and Local projects to address deficiencies in community infrastructure in support of Local military installations. YMPO was alerted to this program in late May 2022, through the Greater Yuma Economic Development Corporation (GYEDC). YMPO's first participation in the DCIP grant program was in FY22 and YMPO working together with YPG and ADOT, submitted a successful grant application and the grant agreement was executed for ~\$13M by ADOT at the end of September 2022 for US-95.

During the FY23 grant cycle 17 DCIP grants were awarded for a total of \$100M. For FY24 the grant program will again be available. OLDCC has communicated that the appropriations and authorizations have not yet been finalized, but they are encouraging perspective recipients to begin drafting proposals for this competitive grant program. This possible grant application would be targeted partial funding for construction of US-95 from Imperial Dam Rd to Aberdeen Rd.

More information on appropriations should become available in January 2024 and this will be followed by a notice of funding opportunity in March 2024.

On May 2023, the Board approved the FY 24-25 Unified Planning Work Program which outlines local funds to carry out discretionary grant opportunities.

SUBJECT: Arizona 2024 Safety Performance Projections

SUMMARY:

On August 31, 2023, the Arizona Department of Transportation (ADOT) formally established Safety Projections for the state of Arizona for 2024. These Safety Projections (SP) are based on the Safety Performance Measures established by the Federal Highway Administration's (FHWA) Safety Performance Management (Safety PM) final ruling and are based on five year rolling averages.

The 2024 Arizona Safety Performance Projections established by ADOT are as follows and increase or decrease compared to the 2023 Arizona SP:

1. Number of Fatalities: 1286.1, **86.1 increase**
2. Rate of Fatalities per 100 million VMT: 1.745, **.09 increase**
3. Number of Serious Injuries: 3636.0, **-23.4 decrease**
4. Rate of Serious Injuries per 100 million VMT: 5.001, **-0.038 decrease**
5. Number of Non-Motorized Fatalities & Serious Injuries: 883.5, **-89.9 decrease**

The SP Projections (Targets) set by ADOT are data-driven and realistic; and are intended to keep the state focused on improving safety while still striving for the goal of the Strategic Regional Transportation Safety Plan (SRTSP) and the State Strategic Highway Safety Plan (AZ-SHSP) of reducing the number of fatalities and serious injury crashes on Arizona's roadways.

ADOT requests a letter from your MPO within 180 days of the effective date, August 31, 2023, indicating whether the MPO supports ADOT's SP Projections or identifying your MPO's SP Projections.

A draft letter is attached that agrees that YMPO intends to adopt the 2024 Arizona Safety Performance Projections established by ADOT for consideration by the Board.

The SP Projections (Targets) set by ADOT are data-driven and realistic; and are intended to keep the state focused on improving safety while still striving for the goal of the Strategic Regional Transportation Safety Plan (SRTSP) and the State Strategic Highway Safety Plan (AZ-SHSP) of reducing the number of fatalities and serious injury crashes on Arizona's roadways.

Metropolitan Planning Organizations (MPO) has the option of supporting the ADOT Safety Performance (SP) Projections or of establishing their own SP projections within 180 days of state projections establishment. ADOT recommends adopting state SP projections. MPOs that choose to set separate projections must report VMT estimates used and the methodology to develop estimates and should maximize use of HPMS data when preparing estimates.

- Safety Projections are reported to ADOT, and made available to FHWA, upon request.
- MPO Safety Projections are not included in the assessment of whether a State met or made significant progress toward meeting its projections.
- Safety Projections are reported annually in the Arizona Highway Safety Improvement Program (HSIP) Report.
- 23 CFR 490.213(b) says: "The MPOs shall annually report their established safety targets to their respective State DOT, in a manner that is documented and mutually agreed upon by both parties."
- 23 CFR 490.209(c) (1) states: "The MPOs shall establish targets not later than 180 days after the respective State DOT establishes and reports projections in the state HSIP annual report."

ADOT requests a letter from your MPO within 180 days of the effective date, August 31, 2023, indicating whether your MPO supports ADOT's SP Projections or identifying your MPO's SP Projections.

A letter will not be required if the MPO had approved support of the ADOT SP Projections in perpetuity, a confirmation email from your MPO will be acceptable. I am attaching a presentation for the Arizona 2024 Safety Projections



The Yuma Metropolitan Planning Organization (YMPO) supports the ADOT 2024 Safety Performance (SP) Projections.

The 2024 Arizona Safety Performance Projections established by ADOT are as follows:

1. Number of Fatalities: **1286.1**
2. Rate of Fatalities per 100 million VMT: **1.745**
3. Number of Serious Injuries: **3636.0**
4. Rate of Serious Injuries per 100 million VMT: **5.001**
5. Number of Non-Motorized Fatalities & Serious Injuries: **883.5**

The SP Projections (Targets) set by ADOT are data-driven and realistic; and are intended to keep the state focused on improving safety while still striving for the goal of the Strategic Regional Transportation Safety Plan (SRTSP) and the State Strategic Traffic Safety Plan (AZ-STSP) of reducing the number of fatalities and serious injury crashes on Arizona's roadways.

YMPO adopted the Performance Measures/Targets established for the region during the December 14, 2023, YMPO Executive Board Meeting.

SUBJECT: Safety Action Plan Collaboration

SUMMARY:

The Bipartisan Infrastructure Law established the Safe Streets and Roads for All (SS4A) discretionary program with \$5 billion in appropriated funds over 5 years, 2022-2026. The SS4A program funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries.

The City of Yuma applied for and was awarded a FY 23 SS4A Planning and Demonstration Grant to develop a comprehensive Safety Action Plan. YMPO last conducted a Strategic Transportation Safety Plan Update for the region in 2019 and developed using crash data from 2014-2018. YMPO currently has funding programmed to carry out a safety update for the region; however, to avoid duplication of efforts and considering the SS4A grant awarded to the city and the development objectives of the plan, the idea of collaboration to include the rest of the region in the Safety Action Plan at a cost to YMPO via an intergovernmental agreement is viable per communication with city staff.

The Safety Action Plan identifies the most significant roadway safety concerns in a community and the implementation of projects and strategies to address roadway safety issues. The SS4A program requires an eligible Action Plan to pursue funding for the implementation of projects and strategies which is the second grant option under SS4A. This item is presented for consideration by member agencies to collaborate with the City of Yuma on a regional Safety Action Plan effort.
