#### 9. Roads of Regional Significance Study RFP Update

On January 21, 2025. YMPO released the request for proposal (RFP) to develop a Roads of Regional Significance Study (RORS) in the YMPO region. Consultants have until 3:00 PM on Monday, February 24, 2025, to submit their proposals. During the March TAC meeting, TAC members will recommend a preferred consultant for this study.

#### 10. AZ SMART Program Overview

The AZ SMART Fund was established by the Arizona Legislature in 2022 to assist eligible cities, towns, counties, and the Arizona Department of Transportation (ADOT) in competing for federal discretionary surface transportation grants. Only those applicants pursuing a federal discretionary grant may apply for AZ SMART funding.

In 2024, the Legislature significantly amended the AZ SMART program. Applications are continuously accepted based on the availability of funding.

#### 11. Proposal for the Gary Knight Memorial Highway- Status

On December 30, 2024, a proposal was submitted to the Arizona State Board on Geographic and Historic Names to name U.S. 95 from milepost 31 to 48 the Gary Knight Memorial Highway, including Resolution 156 by the Executive Board supporting the effort. Naming a feature is a collaborative and multi-stage process.

Community stakeholders will have the opportunity to support and provide feedback for the State Transportation Board (STB) consideration at the April 22nd meeting.

#### 12. FY 2022-26 Transportation Improvement Program (TIP) Amendment #19

The FY 2022-26 YMPO TIP was initially approved on July 29, 2021, and has since been amended eighteen times, most recently on December 3, 2024, through an administrative amendment.

Amendment #19 will include a planning document that has received federal funding. YMPO was awarded \$400,000 in federal funding to develop a Comprehensive Safety Action Plan and YMPO is responsible for \$100,000 in local

match. Currently, YMPO is working with FHWA on the grant agreement. Approval of this amendment will include this project as part of the TIP in FY 2026 and allow YMPO to apply for the AZ SMART Fund reimbursement for the non-federal match.

#### 1. <u>Call to Order and Declaration of Votes</u>

Chairman Frank Sanchez called the meeting to order at 9:00 a.m. The City of Yuma declared votes: Dave Wostenberg (3), Erika Peterson (2).

#### 2. <u>Title VI of the Civil Rights ACT of 1964</u>

YMPO Title VI Coordinator/Mobility Manager JR Aguilar read the YMPO Title VI Nondiscrimination Notice to the Public. YMPO has survey cards on the TAC website, for the public to complete. Please send these to JR Aguilar, YMPO Mobility Manager, at jraquilar@ympo.org.

#### 3. Call to the Public

There were no announcements from the public or TAC members.

#### 4. Approval of Minutes

Approval of the December 12, 2024, TAC minutes. Dave Wostenberg, City of Yuma, City Engineer, moved to approve the December 12, 2024, minutes, with one correction. Mr. Wostenberg's last name was misspelled in the last line in Item #7. Charles Gutierrez, Public Works Director, City of Somerton, seconded the motion, which was unanimously carried.

#### 5. <u>Election of Officers</u>

YMPO Senior Transportation Planner, Fernando Villegas, informed members regarding the process of electing the officer structure for the year according to YMPO Bylaws. Mr. Villegas also informed members that the Executive Board meeting is coming up, and there will also be an election of officers. Mr. Villegas presented a possible rotation table, which was included in the information summary. According to YMPO Bylaws, TAC members shall serve on a rotation basis, whereby when the Chair's Position is vacated, the Vice Chair assumes the position of Chair, and the TAC must elect another TAC member to serve as Chair Vice. The TAC's Chair and Vice Chair shall be from jurisdictions other than those same officer's jurisdictions on the YMPO Executive Board.

Mr. Villegas presented the rotation table, showing that the next rotation for Vice-Chair would be from the Town of Wellton or the City of Yuma. The Town of Wellton, at the time of the meeting, needed to appoint a new member, leaving the City of Yuma members as the only other option for Vice-Chair.

YMPO consultant Paul Ward stated that the Committee could elect a Vice-Chair pending the appointment of a new member from the Town of Wellton. Executive Director Crystal Figueroa stated that any member from the Town of Wellton would be new to the TAC, and it may take time for the Town of Wellton to appoint a new representative.

Charles Gutierrez, Public Works Director, City of Somerton, made a motion to approve Charles Gutierrez as Chair and nominate Dave Wostenberg from the City of Yuma as Vice-Chair contingent upon the Town of Wellton either

accepting the vice chairman position or releasing it to Dave Wostenberg. Kelly Fricke seconded the motion. No further discussion. The motion carried.

At this time, the Chairperson's responsibility has been transferred from Mr. Shanchez to Mr. Gutierrez.

#### 6. <u>Transportation Alternatives (TA) Program Update</u>

Mr. Villegas, presented information regarding the TA Program. The TA Program set-aside provides funding for projects helping member agencies build various smaller-scale alternative transportation projects to achieve safer, connected, and equitable on-road networks for all users. The latest update indicates a call for projects will likely occur in January 2025.

Mr. Villegas suggested getting applications ready since they needed to be submitted through YMPO. Mr. Sanchez asked whether Jeff (Heinrichs) would be the point of contact for the application. Mr. Villegas stated Jeff would be the point of contact. Mr. Wostenberg asked if the applications were due to YMPO before January 21st. Mr. Villegas stated the call for projects was going out on January 21, 2025, and the application deadline had not yet been set.

Mr. Wostenberg gave an overview of the application process the City of Yuma went through for the TA program. Steve Wilson, at the City of Yuma, would be a good resource for additional information regarding the application process.

This item was on the agenda for information and comments only.

#### 7. Revised 2025 Pavement Target

Mr. Villegas presented information regarding the ADOT performance targets. In 2022, the Arizona Department of Transportation (ADOT) established performance targets for the 2022-2025 performance period as required by the federal legislation Moving Ahead for Progress in the 21<sup>st</sup> Century Act of 2012 (MAP-21).

ADOT exceeded the poor condition targets of 2.0% for Interstate pavement and 6.0% for non-interstate NHS pavement. Therefore, ADOT has decided to revise the poor pavement condition targets for the interstate and the non-interstate NHS to 4.5% and 10%, respectively.

ADOT is requesting a letter from YMPO indicating whether YMPO supports the revised pavement targets or identifying YMPO targets for the poor condition pavement measures.

Mr. Wostenberg asked why ADOT was not able to meet the targets. Ms. Figueroa stated ADOT failed to meet the targets due to bad winter weather conditions in

2022 and 2023. This failure would have consequences in the long term with their asset management fund. ADOT has the option to change the targets, and YMPO has the option to set its own targets but has consistently accepted the state's targets.

Mr. Wostenberg made a motion to approve the revised 2025 pavement targets. Mr. Sanchez seconded the motion. The motion carried.

#### 8. <u>Possible Future Studies for YMPO</u>

Paul Ward, Principal Engineer, presented this item and informed members that during the last two TAC meetings, several outlines for studies were presented for consideration for possible inclusion in future Unified Planning Work Programs (UPWPs).

The TAC requested that staff send the suggested prioritization matrix to members for further review and that members respond to staff before this meeting. This review and prioritization have now occurred, and the information summary attached to this agenda contains the results of each member's responses.

Mr. Ward presented the results of the member ranking. Three members, Cocopah, Somerton, and Wellton have not submitted rankings. Mr. Ward offered to allow Cocopah and Somerton members to submit their rankings and suggested returning to this agenda item. Chairman Charles Gutierrez agreed to move forward with the agenda and return to this item after the rankings are updated

Item resumed after Item 10.

Mr. Ward presented a matrix of the member rankings of the proposed studies. The top two studies in the rankings were TMA Upgrade Study and the Regional Sales Tax Study.

Mr. Sanchez asked about the anticipated timelines for these studies. Mr. Ward and Ms. Figueroa stated that the studies would be in the next UPWP and likely start around July 2025.

Mr. Wostenberg made a motion to present the recommendations and current rankings of the top two studies and possibly the third-ranked study to the Executive Board for approval. Mr. Sanchez seconded the motion. The motion carried.

#### 9. Roads of Regional Significance Study RFP Update

Ms. Figueroa, Executive Director, provided the update. ADOT has reviewed the request for proposal (RFP) to develop a Roads of Regional Significance Study in the YMPO region. For this reason, the release date has been moved to the end of the month. The anticipated release date is January 27, 2025. However, it may be

released sooner to give consultants time to submit their proposals. Ms. Figueroa provided the anticipated timeline for the Roads of Regional Significance Study, with the estimated final report due in February 2026.

**DATE**: February 13, 2025

**SUBJECT:** Arizona Sun Cloud Data Portal Statewide Implementation.

#### **SUMMARY:**

The Arizona Sun Cloud is a data portal for sharing information and statistics on everything from roads, traffic flow and transportation information to broadband connectivity and socioeconomic data. In 2017 Sun Cloud was initially funded by federal grant money – with \$1M coming from the Federal Highway Administration. Over a five-year period, Sun Cloud developers collaborated with numerous partners across the Sun Corridor megaregion to develop the data portal that currently exists. The Sun Cloud portal is a useful tool that can be used to enhance and strengthen the regional planning process. The portal is accessible to use by everyone.

Recently, a second round of federal funding has been provided for the Arizona Sun Cloud project, and they are looking to expand the portal to cover greater Arizona. As part of this effort MAG in support with ADOT are reaching out to regions outside the Sun Corridor to see if there is interest in being a contributor or a technical partner. To be a contributor there is a one-time cost of \$5,000 in in-kind funds or local funds to have a voice in the Arizona Sun Cloud project decision making process, or we can choose to be a technical partner at no expense in in-kind funds, but we will be unable to provide decision making input.

**SUBJECT:** Roads of Regional Significance Study Update

#### **SUMMARY:**

The Roads of Regional Significance Study (RORS) was identified in the FY 2025-45 Long Range Transportation Plan as a recommended study for the region selected by the TAC and Board to be conducted during the FY 24-25 two-year Unified Planning Work Program. The study is partially funded in the current FY 25 and is expected to be completed in FY 26.

The purpose of the study is to identify which roadways and/or highways in the YMPO region should be classified as RORS and, possibly, whether they will be in line for regional funding for their construction, ongoing maintenance, and/or preservation of rights-of-way for identified routes when development occurs throughout the county.

YMPO released the RFP on January 21, 2025. The deadline for submission is no later than 3:00 PM local time on February 24, 2025. YMPO staff will deliver all the proposals to the TAC members on the same day, and the TAC members will evaluate and rate the proposals. The most qualified, in the opinion of the TAC members, will be recommended to the Executive Board during the March TAC meeting.

The YMPO Executive Board will review and approve the recommended firm selected for the RORS on March 27, 2025, Executive Board meeting.

# YMPO INFORMATION SUMMARY for Agenda Item 10 Arizona SMART Fund

DATE: February 13, 2025

**SUBJECT: AZ SMART FUNDS** 

#### **SUMMARY:**

The Arizona Legislature amended the AZ SMART program in 2024. The AZ SMART Fund was established by the Arizona Legislature in 2022 to assist eligible cities, towns, counties, and the Arizona Department of Transportation (ADOT) in competing for federal discretionary surface transportation grants. Applications to the AZ SMART funds must first be approved by the Metropolitan Planning Organization (MPO). ADOT administers this fund, and the State Transportation Board (STB) approves all awards.

Today, with the recent changes, MPOs, tribes, non-profits, and for-profit entities are eligible for funding if the entity is competing for a federal discretionary surface transportation grant.

Applicants may request AZ SMART Funds for:

- Reimbursement of up to 50% of the eligible costs associated with Grant Development and Submission of an application for a federal discretionary grant. Limited to counties with a population of less than 100,000 and cities and townswith a population of less than 10,000. (Town of Wellton).
- Reimbursement of non-federal match for a federal grant.
- Reimbursement of design and other engineering services expenditures that meet federal standards for projects eligible for a federal grant.

YMPO intends to apply for the AZ SMART Funds this year to reimburse the non-federal match awarded for the Safe Streets and Roads for All (SS4A) Grant program. YMPO was awarded \$400,000 in federal funds to develop a Comprehensive Safety Action Plan, and the local match is \$100,000.

During the December 12, 2024, Executive Board meeting, Resolution 157 was approved to support the AZ SMART Fund application being submitted by YMPO to fulfill the local match requirements for the Comprehensive Safety Action Plan.

The City of Yuma has also expressed interest in applying for two projects: the 1-8/Avenue 8-1/2 E Traffic Interchange Design Concept Study and the Hacienda Estates Storm Drainage Improvements.

Section V of the Request for Grant Application and Agreement (RFGAA) explains the scores and rankings of the applications in detail. Projects that include safety improvements get more points, and projects listed on the TIP, CIP, municipal General Plan, or County Comprehensive Plan with evidence of public support also get more points. ## Renaming - U.S. Route 95 in Honor of the Late Gary Knight

DATE: February 13, 2025

**SUBJECT:** Naming of U.S. Route 95 in Honor of the Late Gary Knight

#### **SUMMARY:**

As a distinguished Yuma resident, the late City of Yuma Councilmember, and Arizona State Transportation Board member, Gary Knight was a tireless champion for transportation improvements in his region, particularly US Highway 95. On August 22, 2024, the Executive Board approved Resolution 156, formally recommending that the Arizona State Board on Geographic and Historic Names (ASBGHN) consider the permanent, posthumous designation of US-95 as the Gary Knight Memorial Highway.

The ASBGHN has a statutory responsibility for reviewing application proposals and determining the most appropriate names for places in Arizona. The proposal was submitted to ASBGHN in December of 2024. As part of the collaborative, multi-stage process, every proposal receives thorough research and opportunities for community stakeholders to provide feedback to the ASBGHN Board in its considerations. ASBGHN recommended gathering community feedback on the "Gary Knight Memorial Highway" proposal through letters of support and by using the <a href="Proposed Name Response Form">Proposed Name Response Form</a>.

The approval process is a minimum of two months long, and the naming of the Gary Knight Memorial Highway will be eligible for a vote at the April 22, 2025, ASBGHN regular Board meeting. Gathering support for the naming of the Gary Knight Memorial Highway prior to the April 22<sup>nd</sup> ASBGHN Board meeting is crucial to this overall effort.

A draft letter of support was approved by the Executive Board on January 30th and will be forwarded for your respective council's support. TAC members are encouraged to provide support using the Proposed Name Response Form for the late YMPO Executive Board Chairman and City of Yuma Councilmember Gary Knight.

Approval of this amendment will include this project as part of the TIP in FY 2026 and allow YMPO to apply for the AZ SMART Fund reimbursement for the non-federal match.

During the December 12, 2024, Executive Board meeting, the Board approved Resolution 157 to support the AZ SMART Fund application submittal by YMPO.
