After the TAC recommendation, the YMPO apportionments for FY 2024 with ADOT were reviewed, and the Executive Board was informed that the maximum HURF exchange amount is \$1,015,863.



1. Call to Order and Declaration of Votes

Chairman Frank Sanchez called the meeting to order at 9:00 AM. The City of Yuma declares votes. Dave Wostenberg (5 votes) .

2. **Title VI of the Civil Rights ACT of 1964**

The YMPO Title VI Nondiscrimination Notice to the Public was read by YMPO Mobility Manager, JR Aguilar.

3. **Call to the Public**

There were no announcements from the public or TAC members.

4. **Approval of Minutes**

The March 14, 2024, TAC meeting minutes were included with the agenda. Greg Ellingson, Public Works Director, Town of Wellton, motioned to approve the minutes, and Dave Wostenberg, City Engineer, City of Yuma, seconded the motion. The motion carried. Gary Magrino, Business Development Manager, Cocopah Indian Tribe, abstained from voting for this item.

5. **FY 2026-2050 Long-Range Transportation Plan (LRTP) Update/ Highway Safety Improvement Program (HSIP) Application Update.**

Vamshi Yellisetty, Kittleson & Associates, provided the committee with a brief update on the progress of the LRTP and how the first Technical Working Group meeting went. He reminded the committee to submit any suggestions on events happening in our area that they could attend to inform the public about the LRTP.

Mike Blankenship, Greenlight Traffic Engineering, presented a list of potential FY 2027 Highway Safety Improvement Program (HSIP) projects in the YMPO region for review and possible HSIP applications. They also informed the committee that the application deadline is May 3rd, 2024. Seven projects were recommended for HSIP applications: five in the City of Yuma, one in Yuma County, and one regional project.

6. **Arizona Strategic Highway Safety Plan (SHSP) and Active Transportation Safety Plan (ATSAP) presentation.**

Mark Hoffman, Senior Planner, ADOT presented this item. Mr. Hoffman provided updates on historic safety trends, an overview of the SHSP and ATSAP projects, and the next steps in those projects.

7. **FY 2022-26 Transportation Improvement Program (TIP) Amendment #14**

Fernando Villegas, Senior Transportation Planner, presented this item to the committee by stating that Amendment #14 includes changes to the City of San Luis US 95 raised median design since the federal funding and the local math amount are incorrect. The second change is a request by Yuma County to move the Avenue 3E Bridge over the "A" Canal construction from FY 2025 to FY 2024. The final change is to add a construction project for US 95, Imperial Dam Road, to Aberdeen Road. Mr. Wostenberg motioned to recommend approval to the Executive Board, and Kelly Fricke seconded the motion. Motion carried.

8. **Safe Streets and Roads for All (SS4A) Grant Program**

Crystal Figueroa, Executive Director of YMPO, presented this item by informing the committee that the Executive Board authorized YMPO to apply for the SS4A Grant on behalf of the region (excluding the City of Yuma) and approved YMPO to contact a consultant to submit the grant application to develop a Regional Safety Action Plan.

9. **Complete Streets Concept Study RFP**

Mr. Villegas presented this item to inform that staff was still working on the request for proposal (RFP) to develop the Complete Streets Concept Study for road improvements and to design cross-sections for roadways in the YMPO region.

TAC members discuss whether member agencies will be interested in adopting the Complete Streets Concept Study to ensure that the Complete Streets Concept Study will be useful for the rest of the member agencies. This item was on the agenda for information and discussion only.

SUBJECT: FY2026-2050 Long-Range Transportation Plan (LRTP)/ Highway Safety Improvement Program (HSIP) Application Update.

SUMMARY:

Kittleson & Associates will briefly update LRTP progress and Greenlight Traffic Engineering will inform on the applications submitted for the FY 27/28 Highway Safety Improvement Program (HSIP).

Greenlight Traffic Engineering provided eight draft applications for review, including the regional project. ADOT has \$32,700,00 in HSIP funds in FY27 and \$56,100,000 in FY28. YMPO submitted eight applications; the total YMPO HSIP request amount was \$27,959,534.

During the April TAC meeting, the TAC recommendation for the Avenue 3E Bridge over the “A” canal construction project was for an amount of \$1,031,194 in HURF exchange funds. However, after reviewing YMPO apportionments for FY 2024 with ADOT, the maximum amount in the HURF exchange is \$1,015,863. For this reason, the Executive Board was informed that the maximum HURF exchange amount is \$1,015,863 and this project was not approved as recommended by the TAC.

Frank Sanchez, Yuma County Engineer, agrees with the new amount, and the TAC is being notified of the change.

SUBJECT: ADOT Tentative FY 2025-2029 Transportation Facilities Construction Program

SUMMARY:

Each year, ADOT develops a five-year Transportation Facilities Construction Program, which is usually approved by the Arizona Transportation Board in June, in time for the start of the new fiscal year on July 1. The development process usually starts in January of the previous year and takes up to 15 months to complete, so the process for the next program is already well underway. The program contains those projects to be carried out on interstates and state highways systems for up to five years, but many major projects are still being considered through the detailed scoping process for the outer two years of the program, so projects are usually only approved for the first three years.

During this year's program, Yuma County is expected to receive approximately \$39.3 million in projects over the five-year program, and these are shown in the attached pages. The projects utilize a variety of State and Federal funding sources that flow into the Highway User Revenue Fund (HURF). The major problem facing ADOT is a chronic lack of funding from both state and federal resources, as neither of these funding streams has changed in the past 32 years. Funding will continue to be pressured as consumers transition to more fuel-efficient vehicles, and inflation continues to erode the value of the state gas tax. The funding streams are primarily based on cents per gallon so, as the price of gasoline has increased, the amount of money going to fund highway improvements has NOT increased, but has stayed the same, per gallon of fuel.

This continued decline of the sources that primarily fund the system has finally reached the point where ADOT is no longer able to fund roadway widening projects in the Greater Arizona area (including Yuma County).

Regardless of the lack of overall funding, ADOT continues to program a much lower proportion of funds for the State highway system in Yuma County than in other counties that have similar sizes and who contribute about the same amount of fuel taxes into the system. This is primarily due to the number lane miles of State Highways in the counties in question. ADOT exerts a very high level of control over the (discretionary) funding available to the counties in Greater Arizona and refuses to provide as fair 'return to sender' to counties like Yuma. As a result, funds paid into the State Highway system will continue to be taken from Yuma County to fund 'needs' in other areas of the State based on ADOT's perceived 'need' for those roadways to be repaired and/or maintained, regardless of where the funds come from in the first place. Projects are not selected based on region but on a priority basis identified in its Long-Range Transportation Plan, plans recommended investment choice, and ADOT's planning to programming process. Revenues are programmed based on three major investments

categories: Preservation (78%), Modernization (15%), and expansion (7%).

PUBLIC INPUT:

TECHNICAL & POLICY IMPLICATIONS:

TECHNICAL: ADOT's control mechanism does not allow for effective regional influence in the decision-making of the programming of State Highway Funds. This is partially due to an overall lack of funds. ADOT allocates just over \$1 million in Surface Transportation Block Grant (STBG) Funds to the YMPO region each year. MAG, which has approximately 20 times more population than YMPO, receives approximately \$60 million in STBG funds each year.

POLICY: Until the YMPO region becomes classified as a Transportation Management Area and/or until the region implements some form of regional tax for transportation purposes, Yuma County will continue to have to rely on ADOT's discretionary largesse for transportation funds for large regional projects.
