## **AZ Local Technical Assistance Program (LTAP)**

**DATE:** February 7, 2022

**SUBJECT:** AZ Local Technical Assistance Program (LTAP)

### **SUMMARY:**

#### **What is LTAP and what does it offer?**

The National Local Technical Assistance Program (LTAP) was established in 1981 as the Rural Technical Assistance Program (RTAP). It is the primary way that the Federal Highway Administration (FHWA) helps local transportation agencies learn about maintaining and improving their roads, innovative methods and materials, and ways to work smarter.

The Arizona Local Technical Assistance Program (AZLTAP) exists to help local agencies use existing resources more efficiently and to cope with transportation problems by increasing their expertise through technical and management materials, training, and advice.

The AZ LTAP brings together governmental, academic, and private resources and information to ensure a safe, effective, and efficient transportation system in the state of Arizona. By delivering new concepts and ideas, training, technical assistance and by disseminating research results and new technologies for both transportation providers and users, the AZ LTAP is paving the way as a leader in transportation information exchange.

#### **Contributing Agencies**

AZ LTAP provides an annual membership option that allows local public agencies the opportunity to receive training at no additional cost to their agency. This membership fee is often paid for through an agency's Council of Government/Metropolitan Planning Organization.

YMPO has been paying for these services and have reached out in the past to check who is using this system of training.

We do not know who has been using the system but would like to know who uses the system. Here is the history for the 2021 year.

We do not know who is using the program or not.

There were 112 people who attended the program trainings.

Is the LTAP Program a program that the TAC uses frequently or occasionally.

The cost is \$5,000.00 per year.
