# 1. Call to Order and Declaration of Votes

Chairman Charles Gutierrez, Public Works Director, City of Somerton, called the meeting to order at 9:00 a.m. The City of Yuma declared votes: Dave Wostenberg (3), Erika Peterson (2).

# 4. Approval of Minutes

Approval of the April 10, 2025, TAC minutes. Arturo Durazo, Tribal Planner, Cocopah Indian Tribe, moved to approve the April 10, 2025, minutes. Dave Wostenberg, City Engineer, City of Yuma, seconded the motion, which was unanimously carried.

#### 5. Roads of Regional Significance Study (RORS) Kick-off

A Notice to Proceed was issued to Kimley-Horn and Associates Inc. on April 24, 2025. The timeframe to complete the Roads of Regional Significance Study (RORS) is ten months. A kickoff meeting with YMPO staff was held, and collaboration from each YMPO TAC member is encouraged during the study's development.

Chris Joannes, Transportation Planner at Kimley-Horn, provided a progress update on the Road of Regional Significance Study, which focuses on recommendations for transportation infrastructure, strategies to address any existing or anticipated future deficiencies along these corridors, identify potential funding sources for implementing those improvements, identify environmental concerns and right-of-way impacts, and develop a 25-year implementation plan.

During the presentation, Frank Sanchez, County Engineer, Yuma County, questioned whether there was a multi-modal or bike component to the study used for these evaluations. Mr. Joannes responded that during the development of their

definition and prioritization of projects they would like to include multimodal prioritization factors.

# 6. Call for Projects STBG funds

Fernando Villegas, Senior Transportation Planner, YMPO, informed TAC members YMPO is drafting the FY 2026-2030 Transportation Improvement Program (TIP), which will be finalized during the adoption and approval of the FY 2026-2050 Long Range Transportation Plan (LRTP) update. The TIP should include significant regional transportation projects, and no Surface Transportation Block Grant (STBG) Program funds have been programmed for future fiscal years.

Member agencies will be asked to submit STBG projects for consideration for the YMPO FY 2026 - 2030 Transportation Improvement Program (TIP) to be programmed.

Mr. Villegas informed that, assuming that YMPO will receive similar funding and the Obligation Authority rates remain the same, the member agencies can start the project selection process by submitting new projects

Mr. Villegas reminded TAC members that projects being submitted to the LRTP need to have their Air Quality Conformity analysis approved prior to submission. Mr. Gutierrez stated that previously, the TIP was developed to include any new projects because of the Air Quality Conformity analysis. Mr. Villegas commented that he believes TAC members will not have sufficient time to make selections for new projects, as it is expected to adopt the LRTP by the end of July, but if TAC members would like to attempt to meet the deadline, they could. Mr. Gutierrez stated that TAC members will be attempting to meet this deadline and push it back to August if necessary.

Mr. Villegas also informed members of the increase in project costs for the Town of Wellton, leading to insufficient funds. Discussion on options to fund the outstanding balance was postponed as the representative of Wellton was not available during this meeting.

Yuma County is requesting an administrative amendment to increase the federal and non-federal funding for the Shared Pathway at the West Main Canal from Avenue B to Avenue C.

Mr. Sanchez moved to recommend approval of TIP Amendment #23 as presented by staff. Mr. Wostenberg seconded the motion, which was unanimously carried.

# YMPO SUMMARY AGENDA ITEM #8 CALL for PROJECTS STBG Funds

**SUBJECT:** Call for Projects STBG Funds

#### **SUMMARY:**

YMPO is drafting the FY 2026-2030 Transportation Improvement Program (TIP), which will be finalized in conjunction with the adoption of the FY 2026-2050 Long Range Transportation Plan (LRTP) update. The TIP will identify significant regional transportation projects and must remain fiscally constrained. At the May 8, 2025, TAC meeting, members were informed that no Surface Transportation Block Grant (STBG) Program funds have been programmed for the upcoming fiscal years. The committee was also presented with the available STBG funding levels for the whole 5-year period.

Members agreed to submit mini-Design Concept Reports (DCRs) during the same TAC meeting for review and possible programming. Only one project was submitted for consideration: the Somerton Canal at County 10 ¼ Street Bridge Replacement project in Yuma County. This proposed bridge replacement is located over the West Main Canal on Somerton Avenue, between County 10<sup>th</sup> and 11<sup>th</sup> Street.

The estimated construction cost for the project is \$1,279,028. According to the mini DCR, the design could take place in FY 2027 and construction in FY 2028. If selected for programming, YMPO recommends allocating \$1M in STBG funds, with the remaining \$379,028 covered by local funds, as shown below, considering a HURF Exchange. The mini DCR has been included for TAC members' review and consideration.

The design will be funded entirely with local funds. The FY 2027 design project should reflect the associated design cost accordingly.

# Town of Wellton Project Information:

The construction cost for the Town of Wellton's project increased from \$548,000 to \$1,040,755 for FY 2026. In response, the Town is currently revising the project scope to reduce the overall costs, given the available \$367,785 in STBG funds in FY 2026. Should the Town of Wellton wish to pursue additional funding for the project, an official request must be submitted to YMPO for consideration.

# MINI DESIGN CONCEPT REPORT

# **SOMERTON CANAL at Co. 10<sup>1</sup>/<sub>4</sub> STREET** BRIDGE #9481 REPLACEMENT PROJECT

#### **INTRODUCTION:**

Structure number 9481 is a bridge over the West Main canal on Somerton Avenue between County 10<sup>th</sup> and County 11<sup>th</sup> Streets. This bridge is considered an on-system bridge and was originally constructed in 1978. Somerton Avenue at this location is identified as a minor arterial in the YMPO 2022-2045 Long-Range Transportation Plan Update and the FHWA functional classification map. Somerton Avenue between County 10th and County 11th Streets has been identified as a significant route in the YMPO Long Range Planning documents. Yuma County would program \$200,000 of local monies in FY2027 for the bridge replacement design. The County is proposing to construct the new structure using STBG/HURF Swap. The estimated construction costs for this project is \$1,279,028 with construction starting in 2027/2028 depending on the Year programmed. The County is requesting the FY 27/28 STBG funds allocation to possibly apply for HURF Swap funds with ADOT. Yuma County would be responsible for any construction costs in excess of the HURF Swap.

#### **BACKGROUND DATA:**

Somerton Avenue has experienced a significant increase in traffic volume in this area due to the combined growth of agricultural and residential development in the surrounding area. It serves the community by providing a continuous north-south corridor between County 19<sup>th</sup> Street & County 8<sup>th</sup> Street to the North. The other available north-south corridors are either Avenue D or Avenue G, which only runs between County 19th Street and Co. 11<sup>th</sup> Street. Avenue D is 1.5 miles east and Avenue G is 1.5 miles west. Somerton Avenue at this location is heavily traveled by agricultural trucks to access the Northwest areas of Yuma.

The existing bridge consists of steel I-beam girders with steel deck pans welded to the I-beams. The pavement section is AC applied directly on top of the steel deck pans. Yuma County Public Works has been performing maintenance on this bridge at least once a year and often two or more times a year. Each time maintenance is needed to be performed, it involves closing the road for 3-5 days and detouring traffic. Guardrails on the bridge are not to standards.

The properties within the vicinity of the project area are primarily agricultural.

Somerton Avenue, at this location, consists of two 12' thru lanes with 7' shoulders. It currently has no sidewalks, curb or gutter or street lighting present. It is posted at 50 MPH. It is anticipated that the pavement structural design of Somerton Avenue will be a minimum of 5" of asphaltic concrete. The final thickness of the structure pavement overlay will be based on a geotech/pavement report. The roadway at the bridge is on a crest vertical curve which limits the line of sight of Northbound and Southbound vehicles.

#### **PROJECT SCOPE:**

The project objective is to replace the aging bridge structure with a precast box culvert to meet current and future additional traffic demands by widening the bridge to a total width of 90'. This will allow for future widening to accommodate 4 lanes of thru traffic with bike lanes, sidewalk and curb & gutter. The existing signing in the project limits will be evaluated to ensure that they meet current FHWA reflectivity standards. The project will also increase the line of sight by lowering the crest vertical curve. The project will need to be scheduled to be constructed during the 10-day irrigation water outage that normally occurs in late November of every year.

#### **PROJECT DEVELOPMENT:**

1. Environmental requirements as determined by the project scope:

The project will follow standard Yuma County guidelines for environmental project development criteria. The project does not anticipate any 404 permit, floodplain, Wetlands or Section 4(f) requirements. Somerton Avenue is not a scenic or historic route. No significant archaeological or biological efforts are anticipated.

# 2. Critical Outside Agency Involvement:

Critical outside agency involvement would be needed from Yuma County Water Users Association (YCWUA) and the U.S. Bureau of Reclamation (BOR), as the canal is owned by BOR and managed by YCWUA. A license is anticipated to be issued by both agencies.

### 3. Right-of-Way Requirements:

No new right-of-way will be required to construct this project. Construction easements might be needed depending on the contractor's method of construction. The bridge has a current executed license with the B

# 4. Utility Relocation Requirements:

No utility relocations are anticipated for this project.

#### 5. Seasonal Considerations:

The construction of the project will need to be coordinated with YCWUA to ensure work occurs during normal outages or that the contractor is able to provide necessary bypass flows. In addition the construction would have a lesser impact on the community and businesses during late spring and summer. This is the time when the winter visitors have left for the summer and the vehicular traffic is at a minimum. Agricultural vehicular traffic is at minimum during this time.

# 6. Traffic Requirements:

Temporary detours will need to be implemented during construction. It is anticipated that these temporary detours will be for minimal time duration.

#### 7. Design Criteria:

A geotechnical/pavement report will evaluate the proper structural pavement section as well as to determine the limits of structural excavation and backfill. A structural engineer will provide the bridge/culvert design to accommodate current and future traffic loads and volumes. Also, precast structure will be used in design to minimize the construction time and traffic detours. The striping design plan will be developed to ensure it meets current standards. The existing signing will also be evaluated to ensure that the reflectivity of the signs are to standard. If found to be substandard, they will be replaced.

#### **SELECTION CRITERIA:**

# 1. Safety:

There has been 4 vehicle accidents,1 injury accident, 2 non-injury accidents, and 1 fatality at this location in the last five years. The continuous deteriorating pavement conditions, caused by the high truck volume traffic and the current bridge design, poses a safety concern for bicycles and motorcycles as their tires can easily get stuck in the pavement cracks. (See attached pictures).

The proposed new bridge will be a reinforced concrete box culvert with a typical AB-AC pavement section on top. This will aid in the life cycle of the bridge/ culvert and the roadway surface on top and thus improve the safety conditions for all users. YCWUA has tentatively approved the concept of constructing a precast box culvert.

The new signing for the roadway will meet current FHWA reflectivity standards and guidelines. The new roadway striping will be in compliance with federal and state requirements.

#### 2. Level of Service:

The level of service of Somerton Avenue between County 10th and County 11th Streets is estimated to be "B" per the guidelines of the RTP. The peak ADT for the road is 3735 (2020), the anticipated ADT for 2045 as per the YMPO 2022-2045 Long-Range Transportation Plan is from 5000 to 10000. Truck traffic represents 10% of all vehicle traffic. The capacity of the roadway which is classified as a minor arterial is listed as a two-lane roadway.

#### 3. Community Transportation Benefits/(multimodal)

The Somerton Avenue bridge replacement at the West Main Canal project is environmentally compatible as the road improvements can be built within the existing right of way and/or BOR easements. Since this can be accomplished within the right of way there is no impact to historic or cultural resources. The amount of disruption to agriculture, homes and business during construction would be very minimal, especially if construction is scheduled in late spring or summer and between growing seasons. This project will also accommodate for future road widening including bike lanes and sidewalk without the need for complete road closure and detours.

#### 4. Functional Classification:

Somerton Avenue, the project area, is classified as a Minor Arterial on its entire length from Co. 19<sup>th</sup> Street to Co. 8<sup>th</sup> Street according to the YMPO 2022-2045 RTP and the FHWA Functional Classification Map.

#### 5. Pavement Condition:

Due to the condition of the bridge and the volume of heavy truck traffic, asphalt pavement quickly deteriorates and large areas of pavement need to be replaced frequently. This is caused by the vibrations causing breaks in the welds holding the steel pan to the girders. These broken welds then cause excess vibrations that crack and break up the AC pavement. Replacement of the bridge with a box culvert would resolve these issues and minimize the need for pavement repair and disruption to the traveling public.

## 6. Regionally Significant Route:

Somerton Avenue is labeled as a Regionally Significant Route in the YMPO Long Range Plan.

# **OTHER REQUIREMENTS:**

Yuma County is applying for STBG funds for the construction of this project. Allocations from STBG funds in FY 27 of FY 28 are being sought for the construction costs.

It is anticipated that the County will apply for a HURF Swap with ADOT. The County will retain a consultant for the design, review the design, advertise for construction and administer the project through construction. The County will use local HURF monies to cover the difference in cost of construction.

#### **ESTIMATED COST:**

The cost for Design will be funded with local money.

The total estimated construction cost for this project, is \$1,279,028.



# YMPO INFORMATION SUMMARY for Agenda Item #9 The Transportation Alternatives Program (TAP)

**DATE**: June 12, 2025

**SUBJECT:** The Transportation Alternatives Program (TAP).

#### SUMMARY:

The TA Program is a set-aside from the Surface Transportation Block Grant Program under the Bipartisan Infrastructure Law (BIL). In FY2025 the TA Program for Greater Arizona has \$17M available in competitive grant funding. The TA screening application submission window was open from March 24<sup>th</sup> to May 5<sup>th</sup>, since this time ADOT has been reviewing the TA screening applications and working with project sponsors on screening application errors, missing information, recommendations and then inviting project sponsors to submit final applications. The final application submission deadline was extended from May 27<sup>th</sup> until June 6, 2025.

After June 6, ADOT will assemble the list of TA Program applications and provide them to the TA TAC members, who will be reviewing the TA Program applications and providing judgement-based scoring input covering several categories of criteria. Once the TA TAC finishes their scoring inputs, ADOT will produce a ranked and prioritized TA Program list will be generated and forwarded for recommendation to the State Transportation Board at their July 18, 2025 meeting.

The Yuma region had the following TA Program project submissions:

- City of Yuma Shared Use Pathway, Avenue 6E 32<sup>nd</sup> Street to 36<sup>th</sup> Street
- Yuma County Shared Use Pathway, East Main Canal from Yuma Co. 12<sup>th</sup> St to Yuma Co. 14<sup>th</sup> Street

# YMPO TAC INFORMATION SUMMARY for Agenda Item 9 RTAC Regional Priority Projects

**DATE**: June 12, 2025

**SUBJECT:** Regional Priority Projects

#### SUMMARY:

The Rural Transportation Advocacy Council (RTAC) continues to work to provide State funding for local transportation projects in rural Arizona. This item is on the agenda to inform TAC members of the pursuance of a 2026 RTAC priority project legislation and funding allocations approved by the RTAC Board on May 19, 2025.

Last year, the RTAC Board approved the direction to support the Regional Priority Project with a 20% inflation adjustment for the 2025 project legislation.

The population-based division of that amount estimated the possible allocation of funds to the YMPO region at about \$58 million.

The table below shows the allocation of funds with the 20% funding increase for 2025.

The 2025 Legislation round is not as promising as it was initially portrayed. While the estimated available revenues are well over \$600M, the legislature finance advisory committee recommended not obligating more than \$277M as a conservative approach

due to uncertainties at the federal level. It is still unknown how much will be directed for transportation purposes.

This year, the RTAC Committee and Board initiated discussion of supporting another round of the Regional Priority Projects for the 2026 legislation. At their meeting on May 19, 2025, the RTAC Board approved the following regional allocations to be used in developing the 2026 RTAC priority project legislation.

The YMPO allocation was reduced by \$243,984 primarily because a Bull Head City MPO was formed.
