6. Call for Projects STBG funds

The FY 2026-2030 Transportation Improvement Program (TIP) was finalized and approved by the YMPO Executive Board on July 31, 2025. While the TIP outlines major regional transportation projects, no Surface Transportation Block Grant (STBG) Program funds have been programmed for the outlying fiscal years 2027-2030.

Member agencies will have the opportunity to review STBG funding available and submit potential projects for programming consideration under the approved TIP. At this time, one project has been submitted for review and consideration.

 Program \$1,022,077 in STBG funding for FY 2027 and \$1,022,077 in FY 2028 to the 32nd Street Pavement Rehabilitation Project, Phases I and II. • Program the remaining STBG balance in fiscal year 2026 for the Shared Pathway Project along the West Main Canal, from Avenue B to Avenue C, in Yuma County.

7. RTAC Regional Priority Projects for 2026

The Rural Transportation Advocacy Council (RTAC) continues to work to provide State funding for local transportation projects in rural Arizona. This item is on the agenda to review priority projects and recommend the 2026 Regional Priority Projects to the YMPO Executive Board.

This year, the RTAC Committee and Board discussed supporting another round of the Regional Priority Projects for the 2026 legislation. However, the population-based division of the estimated funds allocated to the YMPO region was reduced by \$243,984.

8. Transportation Alternatives (TA) Program Update

The TA Program is a set-aside from the Surface Transportation Block Grant Program under the Bipartisan Infrastructure Law (BIL). In March 2025, ADOT announced the opening of application submissions for the Transportation Alternatives Program (TAP). The FY 2025 TA Projects have been scored and ranked by the TA TAC committee, and the recommended project priority list will be delivered for recommendation to the State Transportation Board for their August 15, 2025, meeting.

9. AZ SMART Program Update

The AZ SMART Fund was established by the Arizona Legislature in 2022 to assist eligible cities, towns, counties, and the Arizona Department of Transportation (ADOT) in competing for federal discretionary surface transportation grants. Only those applicants pursuing a federal discretionary grant may apply for AZ SMART funding.

In 2024, the Legislature significantly amended the AZ SMART program. Applications are continuously accepted based on the availability of funding. Information on available AZ SMART available funding will be provided.

1. <u>Call to Order and Declaration of Votes</u>

TAC Member Frank Sanchez, County Engineer, Yuma County, called the meeting to order at 9:00 a.m. The City of Yuma declared votes: Steve Wilson (3), Erika Peterson (1), Susan Cowey (1).

2. <u>Title VI of the Civil Rights ACT of 1964</u>

A brief message will be read, reminding members of our Title VI obligations. YMPO has survey cards on the YMPO Website for the public to complete. Please send these to JR Aguilar, YMPO Mobility Manager, at iraguilar@ympo.org.

3. Call to the Public

This item provides an opportunity for the public to comment on items that are NOT on the agenda. Individuals who wish to address the committee need not request permission in advance, but each presentation is limited to three (3) minutes.

4. Approval of Minutes

Approval of the June 12, 2025, TAC minutes. Fernando Villegas, Senior Transportation Planner, YMPO, noted the declaration of votes for Yuma County had to be removed due to a miscalculation of votes. Kelly Fricke, Public Works Director, Yuma County, motioned to approve the June 12, 2025, minutes with the stated correction. Steve Wilson, Assistant Director of Engineering, City of Yuma, seconded the motion, which was unanimously carried.

5. FY 2026-50 Long-Range Transportation Plan (LRTP)

Vamshi Yellisetty, Multimodal Transportation Planner, Kittleson & Associates, presented the final report for the FY 2026–2050 Long Range Transportation Plan. He noted that the public comment period is set to close on July 12, 2025. To date, 548 visits and 427 unique users have accessed the project website, with 16 public comments submitted. Mr. Yellisetty confirmed that most feedback aligns with the plan's current recommendations and that additional comments will be addressed before the final submission.

Mr. Yellisetty recommended the FY 2026-2050 YMPO LRTP be presented to the Executive Board for possible approval on July 31, 2025.

Mr. Wilson motioned to recommend approval for the FY 2026–2050 Long Range Transportation Plan, contingent upon addressing any comments received during the public review. Erika Peterson, Senior Planner, City of Yuma, seconded the motion, which was unanimously carried.

6. YMPO FY 2026-2030 Transportation Improvement Program (TIP)

Mr. Villegas presented the FY 2026–2030 TIP, noting it includes transportation projects from member agencies for the next five years and must be consistent with the LRTP. Mr. Villegas presented the list of projects for each member agency, including a list of illustrative projects.

The public comment period ends July 12, 2025. Any additional comments or funding revisions (not involving scope or capacity changes) may still be submitted.

Mr. Yellisetty mentioned major changes would require a complete update of LRTP and Air Quality conformity process.

Mr. Wilson motioned to recommend approval of the FY 2026–2030 TIP on behalf of the Executive Board, including the list of unfunded projects, contingent on incorporating comments from the public and member agencies. Mrs. Fricke seconded the motion, which was unanimously carried.

7. 2025 Air Quality Conformity Analysis (AQCA)

Mr. Yellisetty presented the Air Quality Conformity Analysis, which supports the LRTP and TIP. Due to the YMPO region's non-attainment status for PM10 and ozone, conformity analysis is required. Minor editorial comments were received from EPA and ADEQ, and no public comments were received as of July 10, 2025.

Mr. Wilson motioned to recommend that the Executive Board approve the 2025 Air Quality Conformity Analysis. Mrs. Peterson seconded the motion, which was unanimously carried.

8. Complete Streets Concept Study (CSCS) Final Report

Ryan McKell, ACIP Planner, Kimley-Horn, presented an update on the final draft of the Complete Streets Concept Study. The public comment period will continue through July 12, 2025. Outreach has been conducted via social media, press releases, and newspaper notices.

Mrs. Fricke motioned to recommend approval of the Complete Streets Concept Study Final Report, pending any significant public comments, on behalf of the

Executive Board. Mr. Wilson seconded the motion, which was unanimously carried.

9. Roads of Regional Significance (RORS) Update

Mr. McKell provided an update on the Roads of Regional Significance Study. He reviewed the scoring based on functional classification, route continuity, travel impact, and connectivity to regional destinations. Any route scoring three points or more was designated as regionally significant.

TAC members discussed adding specific road segments, including 40th Street, Avenue D-E, and Avenue 9E north of I-8. Mr. McKell confirmed the team would evaluate and incorporate these roads if they met the criteria.

10. Call for Projects STBG funds

Mr. Villegas reminded TAC members that YMPO is accepting projects for FY 2027–2030 STBG funds. One application has been received for Yuma County. The Somerton Canal bridge replacement project. The project has since received \$1.3 million in state funding, making STBG funds likely unnecessary.

Additionally, the Town of Wellton submitted a revised estimate and requested additional STBG funds for their FY 2026 project. The project was reduced by one block, and the updated cost is \$784,098.60, an increase of \$262,331.78 from the original amount. The remaining FY 2026 STBG funds will cover the increased amount.

Adolfo Ponce, Assistant Public Works Director, Town of Wellton, motioned to include the increase of STBG funds for the Wellton project as part of the FY 2026-2030 TIP. Mrs. Fricke seconded the motion, which was unanimously carried.

11. RTAC Legislative Update

Kevin Adam, Legislative Liason, Rural Transportation Advocacy Council (RTAC), provided an overview of the recent Arizona state budget process and its implications for transportation funding. The state narrowly avoided a shutdown and allocated \$110 million to transportation, including \$1.3 million for a Somerton Avenue bridge in Yuma. He highlighted that the Arizona Smart Fund did not receive additional funding and may be depleted within a year, despite its effectiveness in leveraging federal dollars. A rebalancing of the remaining Smart Fund is expected, with approximately \$2.6 million per category potentially becoming available. Mr. Adam encouraged continued legislative engagement and swift action on funding opportunities.

12. <u>FY 2025 Defense Community Infrastructure Pilot (DCIP) Program Opportunity</u>

Mr. Villegas informed TAC members that in collaboration with Yuma Proving Ground (YPG) and the Arizona Department of Transportation (ADOT). YMPO and Wilson & Company submitted a \$9 million federal funding request under the Defense Community Infrastructure Pilot Program for the U.S. 95 Roundabout Project.

The roundabout is part of the bigger US-95 safety improvement and enhancement project phase from Imperial Dam Road to Aberdeen Road. In 2022, the effort resulted in a successful ~\$13 million grant award, executed by ADOT, for improvements along US-95. YMPO did not apply during the FY 2023 cycle but reengaged with YPG and ADOT to submit a strong proposal for FY 2024. The FY 2024 application was not selected for funding.

The Notice of Funding Opportunity for the FY 2025 DCIP grant opportunity was released on May 27, 2025, and YMPO submitted the DCIP proposal for \$9M on Tuesday, July 1st, 2025.

13. <u>Transportation Alternatives (TA) Program</u>

Mr. Villegas notified TAC members that ADOT and the TA review committee were meeting later that day to rank all submitted projects. On August 15, 2025, the recommendations would go to the State Transportation Board for potential funding.

Two local projects were submitted: a shared-use path on Avenue 6E (City of Yuma) and the East Main Canal path from County 12th to 14th Street (Yuma County).

Mr. Sanchez requested an update on the outcome of the TA meeting.

Lucia Zamudio, Bookkeeper/ Administrative Assistant, YMPO, reminded TAC members of this year's ACEC Arizona Conference on Roads and Streets, taking place on September 24 -26, 2025, at the Conquistador Hilton Resort in Tucson. Ms. Zamudio encouraged TAC members to notify her of their attendance before July 31st, 2025, for a better rate.

Mr. Sanchez confirmed his attendance.

SUMMARY:

The YMPO FY 2026-2030 Transportation Improvement Program (TIP) has been approved by the Executive Board in conjunction with the adoption of the FY 2026-2050 Long Range Transportation Plan (LRTP) update. The TIP identifies significant regional transportation projects and must remain fiscally constrained. During the last three TAC meetings, members were informed that no Surface Transportation Block Grant (STBG) Program funds have been programmed for fiscal years 27, 28, 29, and 30. The committee was also presented with the available STBG funding levels for the next 5 years.



During the May TAC meeting, the TAC members recommended submitting mini-DCRs for possible STBG funding. The City of Yuma recently submitted a mini-DCR, attached to this information summary, requesting STBG funding for FY 2027 and 2028.

The proposed request is a pavement rehabilitation project on 32^{nd} Street from Catalina Drive to Avenue 8 ½ E. The project will be divided into three phases, and it will consist of mill and fill of asphalt pavement, upgrading pedestrian facilities at intersections, and minor signal modifications where necessary.

STBG funding is being requested for Phases I and II. Phase I will rehabilitate 32nd Street from Avenue 3E to Avenue 6E, with a construction cost of \$5,485,000 in fiscal year 2027. Phase II will rehabilitate 32nd Street from Avenue 6E to Avenue 8 ½ E, with a construction cost of \$5,670,000 in fiscal year 2028.

The Rural Transportation Advocacy Council (RTAC) continues to work to provide State funding for local transportation projects in rural Arizona. This item is on the agenda to recommend the 2026 Regional Priority Projects to the YMPO Executive Board. The same projects have been submitted for funding consideration over the past two years; however, no funding has been allocated to the Yuma region.

Last year, the RTAC Board approved the direction to support the Regional Priority Project with a 20% inflation adjustment for the 2025 project legislation.

The population-based division of that amount estimated the possible allocation of funds to the YMPO region is \$57,748,800.

The YMPO allocation was reduced by \$243,984 primarily because the Bullhead City MPO was formed. YMPO TAC members will have the opportunity to discuss current priority projects and whether they should remain or add a project. Each project fact sheet, including requested funding amounts, must be updated.

A list of priority projects last updated in 2023 was sent to the member agencies for review. The list was used to select the Priority Projects in 2023. The same projects have been submitted for consideration since 2023 focused on improvements along US 95, one of the most critical corridors in the region, and a portion previously considered the highest priority from Wellton Mohawk Canal Rd. to Aberdeen Rd.

Today, the TAC members have the opportunity to update the project list and recommend the 2026 Regional Priority Projects to the YMPO Executive Board. The Board must approve the 2026 Regional Priority Projects by the end of September before the Rural Transportation Summit in October.

US 95: Wellton-Mohawk Canal to Aberdeen Road



Project Overview

This project is located on US 95 in southwestern Arizona, close to the Arizona-California state line and the U.S. - Mexico border. It is east of the City of Yuma, in Yuma County, within the jurisdiction of the Yuma Metropolitan Planning Organization (YMPO). US 95 begins (milepost 0) at the US-Mexico International Port of Entry I (POE I) in San Luis and proceeds northward and eastward through the City of Yuma before heading northward through Arizona and California, ultimately reaching the Canadian border. Regionally, US 95 connects east-west Interstate 8 in Yuma to east-west Interstate 10 in Quartzsite (milepost 109), making it a logical connection for heavy truck traffic, including cargo going into or out of Mexico. Unfortunately, it is a two-lane highway in need of modernization and expansion improvements to efficiently serve this important function. Locally, US 95 is the main route providing access to Yuma's largest employer of civilians, the U.S. Army YPG.

US 95 east of Yuma, Arizona is a rural two-lane undivided highway with very few passing and left-turn lanes and is one of the busiest two-lane highways in the State. It has long been identified as a safety concern, and sadly, there have been fatal and serious injury crashes on just this segment of highway. US 95 is the main route providing access to YPG (Yuma's top employer of civilians), so crashes that close this highway for hours at a time are highly detrimental to the region.

The remaining 10 mile section of US 95 from the Wellton Mohawk Canal to Aberdeen Road received funding with the recent 2023 RAISE Grant award for final design. This funding will facilitate the corridor being shovel ready for construction. This 10 mile section is currently being designed as two projects. First, is the Wellton Mohawk Canal to Imperial Dam Road portion (5.3 miles), current estimated cost is \$123.5 million. Second, is the Imperial Dam Rd. to Aberdeen Rd., section is at 4.7 miles, current estimated cost is \$71.8 million.

In FY 24, \$33M was appropriated from the State general fund. This State funding request is for \$48 million. A request of \$44 million for FY 26 to fund construction of the 4.7 mile segment from Imperial Dam Rd to Aberdeen Rd. An additional \$4 million in FY 26 is being requested for funding of preconstruction development activities (e.g. right of way, utilities, project clearances, design) associated with the 5.3 mile segment of US 95 from Wellton Mohawk Canal to Imperial Dam Rd.

US-95 Corridor: 3 Segments

County 22nd Street (San Luis) to County 11th Street (Yuma) Phase II (Co. 17th to Avenue D)



Project Overview

This project is located in Yuma County in southwestern Arizona, close to the Arizona-California state line and the U.S.- Mexico border. It is South and West of the City of Yuma, in Yuma County, within the jurisdiction of the Yuma Metropolitan Planning Organization (YMPO). This roadway, US-95, is a major arterial roadway on the NHS, is the highest Yuma County Project being submitted for consideration. The roadway serves as the Western Canamex corridor and connects the Ports of Entry I and II, through San Luis, Somerton, Cocopah, City of Yuma and Yuma County.

This project limit is 18 miles. Project will mill and overlay three inches along the whole corridor, in three phases of approx. equal lengths and costs. The project serves five local agencies in the Yuma region. Phase I was funded in FY24 for approx. \$5.9M and construction is currently scheduled to start in September 2024. This request is to fund Phase II which is estimated to cost \$8.64M.

This roadway upon completion will serve the five communities will consist of a new pavement layer that will serve Regional and International traffic for future conditions. This roadway is characteristically challenged due to high concentrations of agriculture and winter visitors and is an established corridor of Regional Significance for the Yuma Metropolitan Planning Region for International Commerce and Agriculture.

Phase 2 of 3 of the entire project will be constructed with the \$8.34M State funding request and a local contribution of Highway Users Revenue Fund (HURF). This project was nominated by the Yuma County staff as the highest priority project. Local Partnering agencies are Cities of Yuma Somerton and San Luis, Cocopah Indian Tribe, and Yuma County.






Main Street (SR 95) Improvements **Downtown Redevelopment Phase 1**



Project Overview

This project is in the City of Somerton in Southwestern Arizona, near the Arizona-California state line and the U.S.-Mexico border. It is southwest of the City of Yuma in Yuma County and falls within the jurisdiction of the Yuma Metropolitan Planning Organization (YMPO). The focus is on Main Street (SR 95), a crucial East-West corridor, and the surrounding Somerton Avenue/Sanguinetti Park area, a key North-South route.

This project is a top priority for the City of Somerton, addressing essential upgrades and replacements. The traffic signal at the intersection of Main Street (SR 95) and Somerton Avenue will be replaced and upgraded to improve traffic flow and safety. Existing sidewalks and ramps will be replaced and widened to meet ADA standards, ensuring accessibility for all pedestrians. Additionally, the project will address traffic congestion and enhance the Level of Service at the intersection by improving circulation and replacing old, damaged asphalt.

This project is a significant benefit to the local and regional community by creating ADA accessible pedestrian sidewalks and ramps, reduce traffic congestion, and improve the Level of Service at the intersection.

This project will be designed and constructed in phases with \$1,652,784 requested from State funding local contribution of \$52,000. This project was nominated by city staff as the high priority project. Design is anticipated 2025 and construction expected in 2026.

SUBJECT: The Transportation Alternatives (TA) Program

SUMMARY:

The TA Program is a set-aside from the Surface Transportation Block Grant Program under the Bipartisan Infrastructure Law (BIL). In FY2025, the TA Program for Greater Arizona has \$17M available in competitive grant funding. The TA screening application window was open from March 24th to June 6th. There were 38 Transportation Alternatives applications submitted throughout greater Arizona.

The TA TAC reviewed and scored the TA project applications. On July 10^{th,} ADOT presented the ranked list. All construction-ready projects were selected to be funded with FY2026 TA funding. The remaining TA projects will be eligible for funding during FY27 and FY28. ADOT will provide the ranked and prioritized TA Program list of projects for recommendation to the State Transportation Board at their August 15, 2025, meeting.

The Yuma region had the following TA Program project submissions:

- City of Yuma Shared Use Pathway, Design phase, Avenue 6E 32nd Street to 36th Street
- Yuma County Shared Use Pathway, Design phase, East Main Canal from Yuma Co. 12th St to Yuma Co. 14th Street

DATE: August 14, 2025

SUBJECT: AZ SMART FUNDS

SUMMARY:

The \$50 million AZ SMART Fund was established by the Arizona Legislature in 2022 to assist eligible cities, towns, counties, and the Arizona Department of Transportation (ADOT) in competing for federal discretionary surface transportation grants. Applications to the AZ SMART funds must first be approved by the Metropolitan Planning Organization (MPO). ADOT administers this fund, and the State Transportation Board (STB) approves all awards.

In 2024, the Arizona Legislature amended the program, including an additional \$12M, MPOs became eligible applicants, and the State Transportation Board was allowed to redistribute funding across funding categories.

Applicants may request AZ SMART Funds for:

- Reimbursement of up to 50% of the eligible costs associated with Grant Development and Submission of an application for a federal discretionary grant. Limited to counties with a population of less than 100,000 and cities and towns with a population of less than 10,000. (Town of Wellton).
- Reimbursement of non-federal match for a federal grant.
- Reimbursement of design and other engineering services expenditures that meet federal standards for projects eligible for a federal grant.

YMPO INFORMATION SUMMARY for Agenda Item #10 Gary Kight Memorial Highway Update

DATE: August 14, 2025

SUBJECT: Naming of U.S. Route 95 in Honor of the Late Gary Knight

SUMMARY:

YMPO is pleased to report that on July 22, 2025, the Arizona State Board on Geographic and Historic Names (ASBGHN) unanimously approved the proposal to designate a portion of U.S. Highway 95 (milepost 31 to 48) as the Gary Knight Memorial Highway.

This proposal, originally approved by the YMPO Executive Board through Resolution 156 on August 22, 2024, was a collaborative effort between YMPO staff, the Arizona Department of Transportation Southwest District, and consultant Doug Eberhart from Wilson & Company, who initially informed about the proposal opportunity to honor Gary Knight. Family submitted support, community stakeholders such as member jurisdictions in Yuma County, including the City of Yuma, friends, and partners across the state.

During the ASBGHN public meeting, multiple speakers from the region, including YMPO Director, Mayor Nicholls, Mr. Knight's widow Bonnie Knight, daughter Missy, and RTAC liaison Kevin Adams, provided in-person public comments in strong support of the proposal. In addition, the Director of the Greater Yuma Port Authority virtually spoke in support. Speakers emphasized Gary Knight's legacy of leadership and his tireless advocacy for transportation infrastructure in Yuma County, specifically on US Highway 95 and throughout rural Arizona.

This successful naming approval is a meaningful tribute to the public servant Mr. Knight embodies and the many contributions as a City of Yuma Councilmember, YMPO Board Member, Arizona State Transportation Board Member, and Chairman of the Rural Transportation Advocacy Council.

The next steps will include coordinating with ADOT and local jurisdictions regarding the official installation of highway signage and potential opportunities for a formal dedication event.
