**2. Declaration of Votes.**

**5. Approval of Minutes**

Approval of the December 11, 2025, Meeting minutes.

**MOTION:** Dave Wostenberg, City Engineer, City of Yuma, moved to approve the December 11, 2025, Meeting Minutes. Susan Cowey, CIP Administrator, City of Yuma, seconded the motion, which was unanimously carried.

**6. TAC Officer Rotation - Election of Vice-Chair**

Fernando Villegas, Senior Transportation Planner, YMPO, noted that according to the YMPO Bylaws, elected officers of the Technical Advisory Committee (TAC) serve on a rotation basis. When the Chair's position is vacated, or the term concludes, the existing Vice Chair assumes the position of Chair, and the TAC must elect another TAC member to serve as Vice Chair. The TAC's Chair and Vice Chair, respectively, shall be from jurisdictions other than those of the same officers' jurisdictions on the YMPO Executive Board.

Dave Wostenberg, City Engineer, City of Yuma, will assume the role of Chairman. Members from Town of Wellton, Yuma County, or the City of San Luis were eligible for Vice-Chairman/ Vice-Chairwoman. Adolfo Ponce, Assistant Public Works Director, Town of Wellton, declined the Vice Chair role due to current obligations.

Kelly Fricke, Public Works Director, Yuma County, confirmed via email her willingness to serve as Vice-Chairwoman for the upcoming year.

**MOTION:** Mr. Ponce moved to appoint Mrs. Fricke as the Vice-Chairwoman for the 2026 calendar year. Mrs. Cowey seconded the motion, which was unanimously carried.

**7. FY 2026-2030 YMPO TIP Amendment #3**

Mr. Villegas informed TAC Members the FY26-30 YMPO TIP was initially approved on July 31, 2025, and has since been amended two times, most recently on December 11, 2025, by the Executive Board.

This amendment will add two TA projects to the TIP. Scoping for the shared use pathway at the East Main Canal from County 12th St to County 14th St, in Yuma

County, and the design and construction of the shared use pathway from 32nd Street to the East Mesa Community Park in the City of Yuma.

The scoping for the shared use pathway at the East Main Canal, from County 12th Street to County 14th Street, consists of \$183,885 in federal funds and \$11,115 in local funds in FY26.

The design of the shared-use pathway from 32nd Street to the East Mesa Community Park consists of \$424,350 in federal funds and \$25,650 in local funds in fiscal year 2027.

The construction consists of \$1,200,722 in federal funds and \$72,578 in local funds in fiscal year 2029.

Jennifer Hobert, Regional Planner, ADOT, noted a process change for the FY 2026 scoping-only project due to fiscal year timing and schedule constraints. Now, staff will directly initiate the FY26 scoping and study projects without submitting an initiation packet. Agencies will receive an establishment letter for these projects rather than the typical LPA initiation documentation.

**MOTION:** Erika Peterson, Senior Planner, City of Yuma, motioned to recommend approval of the FY26-30 YMPO TIP Amendment #3 to the Executive Board. Jason Giard, Senior Civil Engineer, Yuma County, seconded the motion, which was unanimously carried.

8. **Transportation Alternatives (TA) Program Next Round**

The Crystal Figueroa, Executive Director, YMPO, noted the TA Program is a federally funded competitive grant program that supports community-based transportation alternative projects. Funded through a set-aside of the Surface Transportation Block Grant Program under the Bipartisan Infrastructure Law (BIL).

Two Transportation Alternatives projects have recently been advanced for the Yuma region. The first is Yuma County's East Main Canal Multi-Use Pathway project, which will extend the region's canal-based shared-use path network south of the City of Yuma. This project was awarded \$183,885 in FY26 TA funding to complete project scoping activities, following the reallocation of funds from a project declined elsewhere in the state. The pathway is intended to improve safety and connectivity for pedestrians and bicyclists while supporting long-range regional bikeway plans.

The second project is the City of Yuma's Shared Use Pathway connecting 32nd Street to East Mesa Community Park at 36th Street. The project includes a multi-use pathway along Avenue 6E and a HAWK beacon at 36th Street and received \$424,350 in FY27 TA funding for design and \$1.2M in FY29 TA funding for construction.

The third Transportation Alternatives (TA) program cycle is expected to open in February 2026. Program updates are underway to streamline the application and review process. For FY27, \$16.98M is available, with \$5.85M awarded to

January 8, 2026, YMPO Technical Advisory Committee Minutes remaining second-cycle projects, leaving \$11.13M available for the third cycle. More information is available on the ADOT TA website.

Mrs. Figueroa asked Chairman Wostenberg about the status of previously submitted Transportation Alternatives projects and whether agencies plan to advance them to the next phase. The Chairman noted some projects, including those from the school district, may still be in the scoping phase, while others were anticipated to move into design and construction.

Mr. Villegas observed the TA Program appears to have shifted to prioritize project completion. One TA project has now been awarded both design and construction funding, whereas earlier cycles focused primarily on scoping and design.

Mr. Villegas encouraged agencies with projects in the scoping or design phase to consider moving them into the next phase.

**9. Comprehensive Safety Action Plan (CSAP) RFP Update**

YMPO was awarded the SS4A grant in FY24. The SS4A program funds regional studies to prevent roadway deaths and serious injuries. YMPO is presenting this item to the TAC members for recommendations in preparing the RFP and the Scope of Work.

Mr. Villegas provided TAC Members with a timeline indicating YMPO planned to release the RFP January 8, 2026. YMPO had submitted the required form for signing the agreement on November 12, 2025, but it is still under review and has not yet been signed. As a result, the RFP release date may have to be moved to February 2026, and the project timeline will need to be adjusted. YMPO cannot move forward until the agreement is finalized.

**10. BUILD Grant Program FY 2026 Notice of Funding Opportunity**

The U.S. Department of Transportation (USDOT) released the Notice of Funding Opportunity (NOFO) for the Better Utilizing Investments to Leverage Development (BUILD) grant program. This program offers grants for surface transportation infrastructure projects that have a significant local or regional impact. The eligibility requirements of BUILD allow project sponsors, including state and local governments, counties, Tribal governments, transit agencies, and port authorities, to pursue multi-modal and multi-jurisdictional projects that are more difficult to fund through other grant programs

Mr. Villegas noted for FY26, approximately \$1.5 billion is available, with minimum award sizes of \$1 million for rural capital projects and \$5 million for urban capital

January 8, 2026, YMPO Technical Advisory Committee Minutes projects. Planning projects have no minimum award size. The maximum award is \$25 million. Urban projects require a 20% match, while rural projects, disadvantaged communities, and areas of persistent poverty have no match requirement.

He noted that Yuma County has historically applied for BUILD funding for the Avenue D/E project and may submit again. Applications are due February 24, 2026, and application instructions are available on the program website.

Mr. Giard noted Yuma County is working on an updated application at this time.

## **The Transportation Alternatives (TA) Program**

**DATE:** February 12, 2026

**SUBJECT:** The Transportation Alternatives (TA) Program

### **SUMMARY:**

As a federally funded program, the Transportation Alternatives Program supports community-based projects that focus on improving safety, connectivity, and quality of life, while reducing reliance on motor vehicles. The TA Program is a competitive grant program that is funded through a set-aside of the STBG or (Surface Transportation Block Grant) Program under the Bipartisan Infrastructure Law.

Two Transportation Alternatives projects have recently been advanced for the Yuma region. The first is **Yuma County's East Main Canal Multi-Use Pathway** project, which will extend the region's canal-based shared-use path network south of the City of Yuma. This project was awarded **\$183,885 in FY26 TA funding** to complete project scoping activities. The pathway is intended to improve safety and connectivity for pedestrians and bicyclists while supporting long-range regional bikeway plans. YMPO commends the Yuma Region Bicycle Coalition for its dedication to improving our community's infrastructure and advocating for this important project.

The second project in our region is the **City of Yuma's Shared Use Pathway connecting 32nd Street to East Mesa Community Park at 36th Street along Avenue 6E**. This project will construct a multi-use pathway that includes a High-Intensity Activated Crosswalk (HAWK) beacon to improve pedestrian safety at 36th Street. The project has been awarded **\$424,350 in FY27 TA funding** to support design activities and **\$1.2M in FY29 TA funding** for construction. This project will provide a key non-motorized connection to the new East Mesa Community Park from 32<sup>nd</sup> Street.

Looking ahead, the next call for Transportation Alternatives projects for FY27—representing the third cycle of the program—is expected to occur on **February 27, 2026**. Program updates have been drafted and are pending final approval. These updates are intended to streamline the application and review processes, making it easier and more efficient for communities to pursue future TA funding opportunities.

For **FY27**, there was initially **\$16.98M** in funding available, from this amount **\$5.85M** was awarded for continuing advancement of the second TA cycle projects, leaving **\$11.13M** dollars in funding available during this next TA call for projects beginning in February. **SUBJECT:** FTA Section 5310 Funds for Regional Mobility Management

**SUMMARY:**

The Arizona Department of Transportation (ADOT) has issued a Notice of Funding Availability (NOFA) for Federal Transit Administration (FTA) Section 5310 funds, exclusively for Regional Mobility Management activities in FY2026 and FY2027. This competitive, two-year application cycle (with awards issued in one-year increments) is open only to Councils of Governments (COGs), Metropolitan Planning Organizations (MPOs), or designated entities that provide regional mobility management for an entire planning region.

YMPO is qualified to serve as the MPO responsible for regional mobility management in the Yuma area and will submit a funding application in this cycle. Funds support coordination, planning, information and referral, prioritization, and other mobility management strategies for seniors and persons with disabilities. The federal share is 80% for capital activities, requiring a 20% local match (cash or pre-approved in-kind).

## **Fortuna Road Crossing Resolution/Letter of Support**

**DATE:** February 12, 2026

**SUBJECT:** Fortuna Road Crossing Resolution/Letter of Support

### **SUMMARY:**

During the December 11, 2025, YMPO Executive Board meeting, Supervisor Simmons expressed his concerns regarding the recurring and prolonged closures of the Fortuna Road Railroad Crossing. Since that time, the Yuma County Board of Supervisors has approved a Resolution naming Union Pacific, expressing the supervisors' concerns about the ongoing disruption and safety risks, and urging the railroad company to invest in permanent repairs to the signal wiring and infrastructure at the crossing. He further indicated that he was willing to engage with congressional offices to seek assistance and advocated for coordinated action to prompt corrective measures. Supervisor Simmons also requested that YMPO support the Yuma County Resolution.

During the Executive Board meeting on January 29, 2026, YMPO Principal Engineer, Paul Ward, suggested that YMPO could write an immediate letter of support to the railroad company. In addition, he suggested that YMPO could also produce a Resolution supporting the County's Resolution for approval by the Executive Board during YMPO's February meeting. The Board unanimously supported this approach.

A Letter of Support has been written and sent to Union Pacific, and a draft Resolution of Support is attached to this Information Summary for review and comment by the Technical Advisory Committee, and possible recommendation to the Executive Board.

The YMPO Resolution supports the County approach, requesting a permanent, durable solution to the electrical and signaling infrastructure at the Fortuna Road crossing to prevent future weather-related failures. The Resolution also requests assistance and engagement from Arizona's congressional delegation, the Federal Railroad Administration, and other appropriate federal agencies to facilitate oversight, accountability, and, if necessary, funding solutions to ensure the repair and maintenance of the Fortuna Road Crossing.

## **YUMA METROPOLITAN PLANNING ORGANIZATION RESOLUTION NO. 161**

**A RESOLUTION OF THE EXECUTIVE BOARD OF THE YUMA METROPOLITAN PLANNING ORGANIZATION, SUPPORTING YUMA COUNTY'S SUGGESTED REPAIRS TO THE RAILROAD CROSSING AT FORTUNA ROAD, YUMA COUNTY, ARIZONA**

**WHEREAS:** The Yuma Metropolitan Planning Organization (YMPO) is a multiagency transportation planning agency formed in 1983, governed by an Executive Board, for the purpose of preparing a regionwide transportation plan that provides for mobility and safe travel for citizens, economic growth, and environmental enhancements; and

**WHEREAS:** The Union Pacific Railroad Owns and operates a railroad line in the Yuma County area that crosses Fortuna Road between Interstate 8 and US Route 95, and the crossing of Fortuna Road is controlled by on-demand crossing arms controlled and maintained by the Union Pacific Railroad;

**WHEREAS:** Fortuna Road is a critical transportation corridor in Yuma County, providing essential access for residents, emergency responders, agricultural operations, commercial traffic, and personnel and operations associated with the Yuma Proving Ground; and

**WHEREAS:** Repeated and extended closures of the Fortuna Road railroad crossing have occurred over the past several years, including but not limited to closures on August 19, 2023; January 24, 2024; and multiple multi-day closures in 2025, including periods of two to five consecutive days; and

**WHEREAS:** Yuma County Public Works and officials associated with the Yuma Proving Ground have advised that the closures are frequently caused by electrical wiring failures that short out during rain events, resulting in the crossing being shut down for extended periods until repairs are made; and

**WHEREAS:** These prolonged closures substantially disrupt daily travel, create detours that significantly increase travel time, impede the movement of goods and agricultural products, negatively affect workforce access, and raise serious public safety concerns related to emergency response times; and

**WHEREAS:** The County has been informed that while temporary measures may be undertaken, the underlying wiring and infrastructure issues persist and require a permanent, capital-level fix to prevent continued failures; and

**WHEREAS:** Railroad crossings are subject to federal regulation and oversight, and meaningful corrective action may require coordination among the railroad operator, the Federal Railroad Administration, the U.S. Department of Transportation, and congressional offices; and

**NOW, THEREFORE, BE IT RESOLVED** that the Yuma Metropolitan Planning Organization:

1. Formally expresses its concern regarding the recurring and prolonged closures of the Fortuna Road railroad crossing and the ongoing disruption and safety risks these closures impose on Yuma County residents, businesses, and agencies;
2. Urges the responsible railroad operator to promptly implement a permanent and durable repair to the electrical and signaling infrastructure at the Fortuna Road crossing to prevent future weather-related failures;
3. Offers assistance and requests engagement from Arizona's congressional delegation, the Federal Railroad Administration, and other appropriate federal agencies and State agencies to help facilitate oversight, accountability, and, if necessary, funding solutions to ensure the crossing is repaired and maintained to reliable operating standards;
4. Directs YMPO staff to transmit this Resolution to Arizona's congressional offices, relevant federal agencies, and other stakeholders, as appropriate, and to continue coordinating with the Yuma Proving Ground and other affected partners; and
5. Affirms YMPO's commitment to pursuing all reasonable advocacy avenues to protect public safety, mobility, and economic activity in Yuma County.
