1. Call to Order and Declaration of Votes

The meeting will be called to order and the City of Yuma will declare their number of votes.

2. Call to the Public

This item is to provide an opportunity for comments by the public. Individuals wishing to address the committee need not request permission in advance and are limited to three (3) minutes.

3. TIP Amendment #3

The City of Yuma has requested additional HSIP and STBG funds for the COY-16-01C: HAWK Pedestrian Hybrid Beacon. The project is in need of \$42,291 of additional funding. Yuma County has requested additional STBG funds that will be turned into HURF Exchange funds. The Yuma County YC-18-01C County 14th Street: Ave A to Ave D will receive the balance of the STBG funds to complete this project will be \$213,557 of HURF Exchange funds.

Option #1:

City of Yuma: \$42,291 = \$26,625(HSIP) + \$15,666 (STBG/Fed - \$14,773/Local Match - \$893)

Yuma County: \$237,286 (STBG/HURF Exchange Swap @ .90 = \$213,557)

Option #2:

City of Yuma - \$42,291 (STBG/Fed - \$39,880/Local - \$2,410)

Yuma County - \$238,804 (STBG/HURF Exchange Swap @ .90 = \$214,923)

Motion: TO recommend approval to the Executive Board Option #1 to add additional funds to the City of Yuma and the Yuma County

4. Selection of the Regional Strategic Transportation Safety Plan Update Proposal

The YMPO TAC will select from the prospective proposals that were submitted to the YMPO. The TAC will make a recommended approval based off of specific criteria and send this recommendation to the YMPO Executive Board for approval to go into negotiations with the selected consulting firm.
