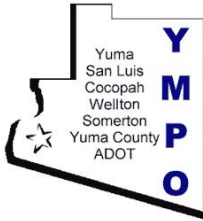

1. Call to Order and Declaration of Votes

YMPO TAC Chairwoman, Jennifer Albers, called the meeting to order at 9:05 am. The City of Yuma declaration of votes: Jeff Kramer, 2 votes; Susan Cowey, 2 votes; and Jennifer Albers, 1 vote.

Gene Dalbey greeted everyone present.

3. **Approval of Minutes** **Discussion and Possible Action**

Mark Hoffman made corrections to the minutes of September 13, 2018. Under item 8 Project Updates for ADOT the correction should be Storm *Water* Study. Under item 8 Project Updates for YMPO the correction should be Planning to *Program* process.

Mark Hoffman motioned to approve the September 13, 2018 TAC minutes with corrections noted.

4. **YMPO Safety Plan Update**.....**Information and Discussion**

Mike Blankenship, Greenlight Traffic Engineering, supplied the TAC with examples from Lake Havasu MPO's Public Bicycle Survey and Pinal County's Strategic Transportation Safety Survey. Mike Blankenship asked the TAC to review the surveys and to submit comments by October 25.

Mike Blankenship shared data that includes fatal crashes and the types of crashes that has occurred in the Yuma region.

4th Avenue had 5 fatal crashes: 3 occurred between 1st Street and 8th Street 2 pedestrian crashes and 1 was an angle crash at Giss. Between 8th Street and 16th Street on 4th Avenue there was a fatal pedestrian crash. On 37th Street there was a fatal angle crash. County 16th had 4 fatal crashes: 2 were near Avenue C 1 crash was a head on and the other was a pedestrian, both occurred at night.

Avenue G had 5 fatal crashes: 2 fatal crashes at County 14th and County 11th had a few fatal crashes.

8th Street between Avenue A and B there was a pedestrian fatal crash and 1 bicycle fatal crash at Magnolia Avenue.

County 11th and Frontage Road had 5 fatal crashes: 1 was an angle, 1 was a pedestrian and 3 were single vehicle crashes.

32nd Street had 6 fatal crashes: 2 crashes were near Catalina and the big curve including a pedestrian and an angle crash, a few left turn crashes, single vehicle, and pedestrian crash.

5. **STBG Funds Loaned to ADOT**.....**Information and Discussion**

Charles Gutierrez informed the TAC of the Surface Transportation Block Grant (STBG) funds that were credited to the YMPO Ledger, in late September 2018. The credit was for \$61,559 and came from the San Luis Juan Sanchez Blvd Project (10th Ave to SR 195). Due to timing YMPO could not successfully program the funds in FY 2018. During the September 2018 YMPO Executive Board Meeting, the Board approved to loan funds to ADOT and return the funds to the YMPO in FY 2019.

7. Adoption of Arizona MAP-21 Performance Targets.....

Information, Discussion, and Action

The TAC had an opportunity to review and discuss the adoption letter for the Arizona MAP-21 Performance Targets. Chairwomen Albers had a few questions that Mark Hoffman was able to answer. The TAC agreed the letter need more support, but agreed on the targets for the performance measures as shown below:

- Percent of National Highway System (NHS) Bridges Classified as in Good Condition based on deck are: 2 and 4-year targets – 52%
- Percent of NHS Bridges Classified in Poor Condition based on deck area: 2 and 4-year targets – 4%
- Percent of Interstate Pavements in Good Condition: 4-year target – 48%
- Percent of Interstate Pavements in Poor Condition: 4-year target – 2%
- Percent of Non-Interstate NHS Pavements in Good Condition: 2 and 4-year targets – 31%

- Percent of Non-Interstate NHS Pavement in Poor Condition: 2 and 4-year target – 6%
- Freight Reliability on the Interstate (Truck Travel Time Reliability Index): 2-year target – 1.21%; 4-year target 1.23%
- Interstate Travel Time Reliability (Percent of person-miles that have Reliable Travel Times on the Interstate): 2-year target 86%; 4-year target 85.8%
- Non-Interstate NHS Travel Time Reliability (Percent of person-miles that have Reliable Travel Times on the Non-Interstate NHS): 4-year target 74.9%
- Congestion Mitigation and Air Quality (CMAQ) Emissions Reductions (Kilograms per day)
 - Volatile Organic Compounds: 2-year target – 210; 4-year target – 385
 - Carbon Monoxide: 2-year target – 3,720; 4-year target – 6,985
 - Nitrogen Oxides: 2-year target – 418; 4-year target – 761
 - Particulate Matter (≤10 microns): 2-year target – 873; 4-year target – 1,399
 - Particulate Matter (≤2.5 microns): 2-year target – 69; 4-year target – 112

STBG Call for Projects and Funding Availability

DATE: November 5, 2018

SUBJECT: STBG Call for Projects and Funding Availability

SUMMARY:

The YMPO is evolving to be doing a Transportation Improvement Program every year and will be going out to the TAC and finally approval to the Executive Board. Each year the YMPO receives approximately \$1,080,229 of Apportionment and with Obligation Authority (OA) Rate at 94.9% in the amount of \$1,025,137 or a HURF Exchange rate of 90/10% Split which equates to \$922,656.

Currently, YMPO will be paying a loan to Northern Arizona Council of Governments (NACOG) for a loan for SOM-TE-02 Main St: Somerton Ave to Bingham for \$185,000 that occurred on the 2014-2018 TIP Amendment #2 t on June 26, 2014.

YMPO loaned to ADOT in the current TIP for payback in FY 2019, \$256,271 total and payout \$185,000, STBG total for FY 2019 of \$71,271 of extra funds. In the last agenda item, you heard that it is possible that ADOT could be asking for approximately \$18,000 for the San Luis Project on Juan Sanchez Blvd that closed already in which YMPO received \$61,559 back and was loaned to ADOT. So, the approximate amount of funds that can be utilized over and above the available unprogrammed is \$53,271 of STBG funds This amount can be used for a FY 19 project on Urban Minor Collector and Rural Major Collector for design/construction or added to any project in the current fiscal year of the TIP.

- **I-8 @ Araby Interchange Spot Improvements-** Project consists of constructing roundabouts at the Araby Road and I-8 ramp intersections. J. Banicki Construction, Inc. was awarded the project. Contractor has completed all the work on phase I of the project which included the construction of the north roundabout. Contractor working on Phase II, construction of the south roundabout. They are installing signs, fence, placing decomposed granite & rock mulch, painting bridges and bridge barrier. Contractor scheduled to have the project complete by next week.
- **Statewide DMS Ph. 11** – Project is complete.
- **Statewide Weigh-In-Motion Project-** Project consists of installing weigh-in-motion systems that include installation of loop detectors, quartz piezoelectric sensors, poles, cabinets, foundations, equipment and solar panels. Project was awarded to Roadway Electric, LLC. Contractor has completed work on SR 85. The contractor will be coming back to the locations on I-8 and SR 85 to calibrate the WIM systems.
- **I-8, Gila Bend Rest Area to I-10 Sign Rehab (MP 125-178)** – Project complete
- **I-8, MP 96-Paloma Road Pavement Preservation-** project consists of milling and replacing existing pavement. FNF construction Inc. was awarded the project. Contractor is working on slope paving, shoulder build-up, and cattle guard installation.

Interstate 10

- **I-10 Ehrenberg Port of Entry Phase II** – The proposed work consists of reconstructing the existing Port of Entry building, constructing new operations building, new satellite credential booths, building canopy, and new PCCP pavement. Additional items of work include constructing sewer and roadway lighting systems, concrete sidewalks, pavement markings, signing, and other misc. items. Project was awarded to FNF Construction, Inc. Contractor is placing PCCP in the truck parking lot, placing curb & gutter, pouring barrier wall, and installing security fence.

US/SR 95

- **SR 95 @ Mohave Road Intersection Improvement Project-**Project consists of installing a new traffic signal at the intersection. Project was awarded to Paveco. Project is on hold, waiting for the traffic signal poles and mast arms to be delivered in late November.

- **US 95 @ Ave 8E Intersection**- Consists of constructing a traffic signal at the intersection of US 95 & Ave 8E. The project is advertised and will bid open on Oct. 26th.
- **SR 95, Beacon Road – E. of Riverside Dr. Pav. Preservation** – Pavement preservation project for full width roadway. Project bid opened and is scheduled to go before the Transportation Board for award consideration on Nov. 16th.

SR 72

- **SR 72, MP 29.86-49.91 Pavement Preservation**- the final project assessment has been submitted for the project. Project consists of 3” overlay on the roadway and drainage improvements. Project is advertised and bid opens on 11/9/18.
- **SR 72 & Joshua Drive Intersection Improvement**- Intersection improvement project to added left and right turn lanes. Project is advertised and will bid open on 11/9/18.

Local Projects

- **County 12th Street @ Ave D over Central Canal Bridge Replacement project**- Project is complete.
- **Texas Hill Bridges** – project consists of bridge rehabilitation. Project was awarded to Pulice Construction, Inc. Contractor is working on pouring the abutments, installing the voided slabs, and constructing the bridge barrier for structure # 7753.
- **8th St. & 21st Ave Pedestrian Hybrid Beacon** – project consists of installing a pedestrian hybrid beacon at the intersection of 8th Street and 21st Ave. Project was awarded to AJP Electric, Inc. The contractor waiting on poles and cabinet to be delivered to the project site.

Interstate 8

- **Coyote Wash Multi-use Pathway**- project consists of extending a multi-use pathway across the Coyote Wash in Wellton. The 100% comments submitted and C&S reviewing the project. Project is scheduled to advertise by Nov. 2018.
- **I-8, MP 141-147.6 Micro Seal Project**- The project funding has been moved to fiscal year 2020. Pre-scoping document complete.
- **I-8, MP 0.1 – 31 Various Bridges Deck Rehab**– Bridge deck rehabilitation project. Final design funding is in place and will have a kick-off meeting in a few weeks.
- **I-8, Avenue 36E to MP 46 Pav. Preservation**- Project consists of pavement rehabilitation from milepost 37 to 46 on I-8. Design will kick-off meeting was held. The designer is working on finalizing the project assessment. Construction is programmed for FY 20’.
- **I-8, MP 82-96, E. of Yuma/Maricopa County Line** – Pavement preservation project for EB & WB roadways. Construction programmed for FY 20’, but the project may be moved into FY 19’. 100% plans submitted for final review and comments sent back.

- **I-8, MP 134.6 – 141 Pavement Preservation**- The pre-design scoping document is complete.
- **I-8, MP 46 SW of Dateland Pavement Preservation**- project consists of milling and paving mainline and crossroads on I-8 for 20 miles. Construction funding programmed

in fiscal year 2019. Final Project Assessment is complete. 60% plan submittal has been submitted for review and comments are due back 10/25/18.

- **I-8, Sentinel Rest Area-** Design and construct waste water and water repairs. Design in FY 21' and construction programmed in FY 22'.
- **Statewide Port of Entry Truck Screening Project-** Consists of design and construction of truck screening systems at the port of entry's statewide. This is a design-build project. Roadway Electric was the lowest bidder for this project.
- **Statewide LED Project-** Project consists of replacing lighting statewide and installing new LED lights. Designated locations have been identified. 60% plans submitted for review.

Draft Final Project Assessment complete. Construction funding programmed in fiscal year 2020. Project kick-off meeting is scheduled for this week to discuss final design.
- **I-10, MP 11.7-24 Pavement Preservation-** Pre-scoping document is complete.
- **I-10, MP 80-90 Pavement Preservation -** Pre-scoping document is complete.
- **I-10, MP 90-105.95 Pavement Preservation -** Pre-scoping document is complete.
- **I-10, MP 105.95-112.33 Pavement Preservation -** Pre-scoping document is complete.
- **I-10, Hassayampa Bridge –Sun Valley Parkway (Spot Repair) -** Mill and replace AC lanes and Spot Repairs on PCCP test panels. Design will begin in FY 2017.
- **I-10, W. Quartzsite TI (Exit 17) Pre-scoping –** Pre-scoping document will be developed to identify scoping elements and construction costs for a new interchange that includes a wider bridge. Pre-scoping document complete.
- **I-10, Bouse Wash Rest Area Rehabilitation Project-** rehabilitating the rest area. Project programmed for FY 22'. Team met at the site. Designer will put together a scope of work proposal for the project and final design will kick-off in Dec. 2018/Jan. 2019.
- **I-10, MP 105.95-Jct. SR 85 Pavement Preservation-** pavement preservation project from MP 105.95-114. Construction programmed in FY 21'.
- **I-10, SR 85 to Verrado Way Widening –** project is in the initial design stages. Designer is working on finalizing the DCR.

US 95

- **US 95, Ave 9E to Aberdeen Road-** Corridor is in the beginning design stage. 30% design of the corridor is complete. Project consists of widening US 95 to a 5 lane section for the southern portion and a divided roadway further north. Phase I was split into two projects. Fortuna Wash Bridge project has been completed. Additional funding will need to be established to move forward with r/w and utility work for the second half of phase I.
- **US 95, MP 42-Cibola Lake Road-** The design concept report for the project has been finalized.
- **US 95, MP 98-104 Corridor Study-** The study will look at widening the roadway to a five lane section (2 lanes in each direction with 1 continuous left turn lane) with drainage

improvements. The design kick-off meeting was held 11/6/12. Project assessment has been finalized.

- **Juan Sanchez Boulevard Corridor Study-** The study will look at widening Juan Sanchez Boulevard to a four lane facility with concrete median separation. Design will look at drainage and evaluate intersections. Design Kick-off meeting was held 11/14/12. Draft 30% plans have been submitted for review and comments sent back. Environmental team will begin their survey work and finish up the clearance. Once complete, geotechnical work can begin and the 30% plans can be finalized.
- **Wellton Mohawk Canal Bridge Rehab-** project consists of rehabilitation of the existing bridges. Design Kick-off meeting held. Project expected to advertise in Jan. 2019. The 60% comment resolution meeting held. 95% plans expected in October 2018.
- **US 95 & Dome Valley Road Intersection Improvement –** project funding approved. Project design will kick off sometime in FY 19’.

SR 85

- **SR 85, Warner Street Bridge-** Construction of new bridge. Project is 5-year program for construction in FY 2019.
- **SR 85, MP 142.3-148.85 Pavement Preservation -** Pre-scoping document is complete. Project in the new 5-year program. Design funds in FY 19’.

SR 95

- **SR 95, MP 116 to MP 135 Double Chip Seal-** Project is programmed in FY 20’.
- **SR 95 Colorado River Indian Tribe Sidewalk Improvement Project-** construction of 10’ sidewalk pathway with lighting. Locations along Airport Road, 4th Street/SR 95, and Bluewater Resort. Pre-scoping document complete.
- **Farmers Bridge-** Bridge rehabilitation project. Construction programmed in FY 20’.

SR 195

- **Ave E, SR 195 to Co. 18th Street Corridor Study-** This is a Local Government project. The study will look at continuing Ave E from SR 195 intersection through to County 18th Street. Final Design Concept Report has been sent out. Working to get the environmental clearance finalized.
