1. Call to Order and Declaration of Votes

Chairman Eulogio Vera called the meeting to order at 9:00 A.M. The City of Yuma declared votes as Jennifer Albers 5.

2. <u>Title VI of the Civil Rights ACT of 1964</u>

A brief Title VI Nondiscrimination Notice to the Public was ready by Jesus R Aguilar Jr.

3. Call to the Public

Gene Dalbey, Yuma Region Bicycle Coalition (YRBC), notified the TAC that he has resumed his position as President of the YRBC and mentioned what a great year he had working with local agencies to improve bicycle lanes from a safety perspective, which will promote tourism in the region.

4. Approval of Minutes

The December 8, 2022 minutes were approved. Jennifer Albers motioned for approval. ADOT Senior Planner Mark Hoffman seconded the motion. The motion carried.

5. Rail/Heavy Freight Study Final

Charles Gutierrez, YMPO, briefly updated the TAC on the current status of the Rail/Heavy Freight Study. Although it's become a lengthy process, at this time, there is no recommended alternative due to the issues that must be mitigated: the Barry M. Goldwater Air Force Range Easement, Public input, and a continuation of the Rail Line in Mexico. The Final Report will be presented to the Executive Board for approval.

Joseph Grant, Town of Wellton, motioned to accept the Study from Kimley-Horn as not feasible. Kelly Fricke, Yuma County, seconded the motion. Motion carried.

6. San Luis POE Impact Study

Chris Joannes, Kimley-Horn, presented the San Luis POE Impact Study. Mr. Joannes began by giving the TAC a quick refresher on the Origin Destination Analysis. Origin Destination Data was collected by setting up Wi-Fi, Bluetooth, data collection devices at several locations around the region strategically placed on major routes that go between San Luis and other Local Cities, such as Somerton and Yuma. This allowed the ability to identify trips that came through the Port and stayed in San Luis, trips that came to the port and went somewhere in the region outside of San Luis, and those who were passing through the region and going to other areas outside the Yuma region. The data compiled determined that during the week over 52% of trips remained in San Luis after crossing through the Port of Entry, 28% left San Luis but remained in the Yuma Region and 19% of trips were leaving San Luis and the Yuma Region altogether. The weekend data showed that 53% of trips remained in San Luis, 24% of trips left San Luis but remained in the Yuma Region and 23% of trips left San Luis and the Yuma Region.

Frank Sanchez, Yuma County, asked if the data collected also included pedestrian activity?


Mr. Joannes said that because the Study is at a regional scale, it is vehicular data that's being collected. However, the way the collection functioned was that cell phone signals were picked as they went past one of the receivers that were set up. Thus, it also included people walking past the receivers.

Mr. Gutierrez asked what the survey size was.

Mr. Joannes said it included 1,200 sample trips on the weekday and 1,100 sample trips on the weekend, originating from the Port of Entry.

Mr. Joannes continued with the Circulation Analysis. He explained that a traffic simulation model was developed to represent traffic activity in downtown San Luis. The benefit of doing this is that it shows all vehicles and pedestrians passing through at once to evaluate the impact on the intersections that are causing congestion and further upstream issues. With the expansion of the Port of Entry, this will help understand what changes may be needed to the downtown street network to handle the increase in both vehicular and pedestrian volume coming through at peak times. Moreover, a simulation model was developed and was calibrated to the existing conditions that were collected through an extensive collection effort, which included turning movements at 30 intersections in the downtown area, as well as classification counts to better understand the traffic over the course of a day. The information gathered resulted in the development of the preferred alternative.


The network changes needed are shown below:



Eric Holland, Cocopah Indian Tribe, asked what constituted a failing movement?

Mr. Joannes said explained that as the traffic comes out of the Port of Entry the traffic flowing out is congested already and wit the addition of 16 lanes open for traffic the failure of the infrastructure needs of the city are greatly reduced.

Mr. Joannes continued by explaining what is causing the delay in the network. The 5 intersections causing congestion in the network are identified below:



The recommended alternatives for each intersection that is causing congestion in the network are illustrated below:



Although the above image shows the recommendation for Cesar Chavez Boulevard and Mesa Street is a Circulating Route, the recommendation was changed to a Connection between Mesa Street to San Luis Plaza Drive because the circulating seems to be too difficult for people to navigate.

Mr. Holland asked if the calculations are based on traffic patterns/flow or any additional input on development in the area, such as housing that will increase traffic delay.

Mr. Joannes said the Study includes relatively aggressive growth to reflect a large amount of development in the San Luis area, especially in the 20-year model. However, the study balanced both traffic congestion and the City's interest in having redevelopment in the Downtown area along with a more attractive pedestrian experience.

Mr. Sanchez asked if there was any consideration of San Luis opening POE II for personal vehicles or if it will remain for commercial vehicles only?

Mr. Joannes said POE II was not included in the study. However, if there were an interest in opening POE II, most of the recommendations would still be needed, but some may need modifications.

Eulogio Vera, City of San Luis, said that per General Service Administration (GSA), there is currently no interest in opening POE II for personal vehicles.

Mr. Gutierrez added that opening POE II for personal vehicles was previously mentioned in the past, but GSA later stated it was not possible.

Mr. Vera said GSA wants to keep personal vehicles and commercial traffic separate.

7. Regional Coordination Plan Update

Mr. Aguilar JR mentioned that on October 27, 2022, the Executive Board approved providing LSC Transportation Consultants, Inc (LSC) a Notice to Proceed, which was later signed October 31, 2022. During this time, YMPO and LSC have collaborated with member providers to collect the necessary data needs for the project. Additionally, LSC has been diligently compiling data for Technical Memorandum 1. Mr. Aguilar mentioned that two Public Engagement events will be held on February 1, 2023 at the San Luis Library from 1:00pm to 2:30pm and Yuma Main Library from 4:00pm to 5:30pm. He continued to state that the final Regional Mobility Committee (RMC) Workshop is scheduled for March 13, 2023 following a recommended approval from the TAC to the Executive Board on April 13, 2023. The final report will be due on April 27, 2023. Mr. Aguilar JR presented Justine Marmesh from LSC who will be discussing the Technical Memorandum 1.

Ms. Marmesh began by stating that a Regional Coordination Plan is essentially required, per the Federal Transit Administration (FTA). The federal requirements of a Coordinated Plan are:

Assessment of available services for all transportation providers

- Assessment of needs for target population
- Strategies and/or activities to address identified gaps and achieve efficiencies in service delivery.
- Prioritization of strategies for implementation.

The goal is to effectively provide a meaningful document, Regional Coordination Plan, that will act as a guide for YMPO and other transit and human service agencies to offer better means of transportation for the most transit dependent population, which are:

- Older adults (Age 65 and older)
- Individuals living with disabilities
- Low-income households

Currently, Technical Memorandum 1 has been completed and includes an overview of demographics of the YMPO Region, previous Plans summary and provides an inventory of current transportation providers in the region through an online questionnaire. Ms. Marmesh provided a quick demographic overview of the region.

- One out of every five Yuma County residents is a senior adult over the age of 65 (40,170 persons or 20 percent of the total population). The majority of these senior adults live in Fortuna Foothills or Yuma (70 percent).
- There are 25,773 disabled persons in Yuma County (13 percent of the total population).
- It is estimated that 18 percent of the Yuma County population lives below the federal poverty level (as defined by the US Census Bureau), which is a greater rate than the State of Arizona (12.8 percent).

According to the Yuma County Transit Needs Index, Somerton ranked the highest for the greatest concentration of persons with disabilities, persons below the poverty level, unemployed and zero-vehicle households. Demographics in Yuma, San Luis and Fortuna Foothills also indicated a moderate need after Somerton.

Ms. Marmesh said that based on the previous plan, data gathered from Stakeholder interviews, questionnaires and discussions with Mr. Gutierrez and Mr. Aguilar JR, the current Transit and Mobility needs are the following:

- More providers that will serve residents living in rural areas of Yuma County.
- Staffing and vehicle shortages causing lack of services.
- Driver and staff training around special clients (those who are living with disabilities such as Alzheimer's and dementia)
- Filling transportation gap with loss of NAZCARE and SAAVI services.
- Transportation services for non-medical related trips.

Ms. Marmesh also provided a Project Timeline for the next few months, which include an online community survey and two public engagement events on February 1, 2023, completion of Technical Memorandum 2 in late February, an additional RMC Workshop, Completion of Technical Memorandum 3 and Draft and Final Regional Coordinated Plan for April of 2023.

Mr. Gutierrez asked Ms. Marmesh when she would like comments from the TAC to be submitted regarding Technical Memorandum 1.

Ms. Marmesh said by mid-February.

Mr. Gutierrez suggested to the TAC that all comments and notes be submitted by February 2, 2023.

8. Call for Projects UPDATE

Mr. Gutierrez provided an updated STBG and CRP Funding amount for each year. Showing respective amounts for each year to include the Surface Transportation Block Grant (STBG) and Carbon Reduction Program (CRP) dollars.

Mark Hoffman, ADOT, asked why the STBG dropped after FY 2024 under the apportionment column.

Mr. Gutierrez said that was a mistake and should have been \$1,082,273.

Mr. Hoffman added that ADOT recently received notice that based on the US Census, there are two new urbanized areas over 50,000 that have been designated: Maricopa and Bullhead City, which may result in splitting the funding pot even more.

Mr. Sanchez asked if it is possible to update the amount an agency is scheduled to receive for a project with the funds that are being carried over from the previous year as construction prices have increased recently, and what was identified as needed two years ago has now changed due to the price increase.

Mr. Gutierrez thinks that the possibility will go to the TAC when the time comes.

Mr. Grant said that the Town of Wellton might change their project for FY 2026.

9. <u>YMPO FY 2023-2026 TIP Amendment #6</u>

Mr. Gutierrez stated that at the request of the City of Yuma and ADOT, a request to Amend the City of Yuma, Highway Safety Improvement Program (HSIP) project with 5 City Locations - Upgrade Pavement Markings on 5 Arterial Streets Revised. The change in the Project Schedule is the Construction Date, from FY 2024 to FY 2025.

Mr. Hoffman motioned to approve TIP Amendment #6. Ms. Albers seconded the motion. Motion approved.

10. RAISE GRANT 2023

The U.S. Department of Transportation has published a Notice of Funding Opportunity (NOFO) for \$1.5 billion in grant funding through the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) discretionary grant program for 2023. The popular program helps communities around the country carry out projects with significant local or regional impact.

Mr. Gutierrez presented the RAISE Grant opportunity, which all TAC member agencies can benefit from. RAISE discretionary grants help project sponsors at the State and local levels, including municipalities, Tribal governments, counties, and others complete critical freight and passenger transportation infrastructure projects. The eligibility requirements of RAISE allow project sponsors to obtain funding for projects that are harder to support through other U.S. DOT grant programs.

YMPO is submitting the RAISE for the US 95: Wellton-Mohawk canal to Aberdeen Road - DESIGN, along with the City of San Luis for Cesar Chavez Blvd and Yuma County for Avenue E. YMPO is requesting Letters of Support for YMPO's application.

YMPO Executive Director Crystal Figueroa added that YMPO has already received a Letter of Support from the City of San Luis.

Mr. Sanchez motioned to acknowledge that three member agencies will be applying for the RAISE grant and Letters of Support will be issued for them.

Mr. Grant seconded the motion. Motion carried.

11. Arizona Smart Fund

Mr. Gutierrez presented the AZ State Match Advantage for Rural Transportation (SMART) Fund program to the TAC. The SMART Fund program was created to address numerous new federal discretionary grant programs were created with the passage of the Infrastructure Investment and Jobs Act (IIJA, also known as the Bipartisan Infrastructure Act or BIL). The AZ SMART Fund was established by the Arizona Legislature in 2022 to assist eligible cities, towns, counties, and the Arizona Department of Transportation (ADOT) in competing for federal discretionary surface transportation grants. The Fund is administered by ADOT, the Arizona State Transportation Board (STB) must approve all AZ Smart Fund awards.

Mr. Gutierrez stated that applicants may request AZ SMART Funds for any of the following eligible uses associated with developing a project for, applying for, or providing a local, non-federal match on a federal grant.

- Reimbursement of up to 50% of the eligible costs associated with Grant Development and Submission of an application for a federal discretionary grant. Limited to counties with a population of less than 100,000 and cities and towns with a population of less than 10,000.
- Reimbursement of non-federal match for a federal grant.
- Reimbursement of design and other engineering services expenditures that
 meet federal standards for projects eligible for a federal grant. For the
 purposes of the AZ SMART Fund, design and other engineering services
 includes preliminary engineering through final design related to a road,
 bridge, rail or transit infrastructure construction project that the Applicant
 intends to submit for a federal grant in a future year.

Ms. Figueroa said that although YMPO is unable to apply for the grant, member agencies are encouraged to apply as it is something that can be utilized for aid on eligible costs associated with Grant Development and Submission.

12. Bridge Program

Mr. Gutierrez said that ADOT is adjusting the funding levels for the Off-System Bridge Program. ADOT has undertaken the Bridge Program and they are in the process of adjusting funding capacity due to the IIJA/BIL Legislation. There is no longer a cap for a million dollars for an Off-System Bridge Project. Mr. Gutierrez stated that he will be working with member agencies to check whether they are eligible for this program.

13. YMPO and ADOT

YMPO and ADOT staff will have the opportunity to update any other business that is or was not covered in the previous agenda items.

a. TAC & Executive Board Schedule - Calendar 2023

YMPO Bookkeeper and Administrative Assistant Norma Chavez presented the TAC meeting schedule for Calendar Year 2023. Ms. Chavez stated that the meeting dates would remain at the same time and days each month. The TAC will meet the second Thursday of each month, starting at 9:00 AM. In addition, the meetings will continue to be held at the YMPO office and virtually via the GoTo Meeting platform. The Executive Board meeting schedule was also presented for the TAC's reference. 

Arizona Border Master Plan

SUBJECT: Arizona Border Master Plan

SUMMARY:



The ASBIMP will develop a list of prioritized Arizona-Sonora border-related infrastructure projects or studies, and their readiness for funding and implementation. The ASBIMP study area extends along the entire 360-mile Arizona-Sonora border, which incorporates a wide range of international jurisdictions, including federal, tribal, state, county, and city governments on both sides of the border.

Updating the ASBIMP involves five phases and is scheduled for completion in mid-2023.

- Project Initiation
- Existing and Future Conditions
- Identify Operational and Infrastructure Needs
- Evaluate and Prioritize
- Prepare Draft / Final Report
- The project team began collecting and reviewing data in late 2021 and will continue into 2023. The plan will be approved in mid-2023. Data on existing conditions in the study area and projections for future conditions are currently under development. Sitespecific information on operations and infrastructure at each LPOE will also be updated.
- The identification of potential challenges that may arise within the border-related transportation networks (roadways, rail, and LPOEs) and development process of the BIMP will lead to ideas about improvement strategies. The challenges addressed earlier will be among the considerations for new and improved infrastructure and strategies. The BIMP will include a list of prioritized near-term and long-term transportation projects and strategies for the border region.

• The BIMP will compile all results into a comprehensive and integrated plan for phased improvements to LPOEs and related transportation facilities. This plan will be used by the cities in the border region, the states of Arizona and Sonora, and the federal governments in the United States and Mexico for planning, funding, and development of necessary infrastructure for the border region. Operational improvements and strategies may also be recommended
