# 1. <u>Call to Order and Declaration of Votes</u>

Chairman Eulogio Vera called the meeting to order at 9:00 A.M. The City of Yuma declared votes as Dave Wostenberg 2, Susan Cowey 2, and Jennifer Albers 1.

# 2. <u>Title VI of the Civil Rights ACT of 1964</u>

A brief Title VI Nondiscrimination Notice to the Public was read by YMPO Staff Jesus R. Aguilar Jr.

### 3. <u>Call to the Public</u>

There were no announcements from the public or TAC members.

#### 4. Approval of Minutes

The January 12, 2022 minutes were approved. Planning Director Eric Holland, Cocopah Indian Tribe, motioned for approval. Public Works Director Joseph Grant, Town of Wellton, seconded the motion. The motion carried.

#### 5. <u>Regional Coordination Plan Update</u>

Mr. Aguilar provided a brief update on YMPO's Regional Coordination Plan (RCP). Since January's TAC meeting, YMPO held two public engagement workshops on February 1, 2023, at the San Luis Library from 1:00 to 2:30 PM and the Yuma Main Library from 4:00 to 5:30 PM. In addition, public notices and survey links were announced and published in local radio stations, newspapers, and senior living communities in the region. LSC Transportation Consultants have presented Tech Memo #1 to the TAC and RMC providers for comments. Steps that follow are:

- LSC will continue working on Mobility Needs Assessment (Task 5)
- The Preferred Conditions (Task 6A)
- The Yuma Program Brochure (Task 6B)
- TAC recommends approval to the Executive Board in April or May 2023
- The Executive Board's approval in April or May 2023
- Submission to ADOT in May 2023

#### 6. <u>Call for Projects</u>

YMPO Senior Planning Manager, Charles Gutierrez, began his presentation by informing the TAC members that based upon the dollar amounts from last month's TAC meeting, the current funding availability for FY 2023 to 2027 is:

FY 2023 STBG - \$22,077 Carbon Reduction Program (CRP) - \$595,879

FY 2024 STBG - \$22,077 CRP - \$297,939

FY 2026 -STBG - \$387,573 CRP - \$273,765

FY 2027 STBG - \$938,742 CRP - \$273,765 The TAC member agencies are being asked to present their project for inclusion in the FY 2024 - 2028 Transportation Improvement Program (TIP) for the Yuma Metropolitan Planning Area. TAC Member Agencies are to submit their projects including the total cost and description for each project. The information will then be distributed within the TAC in 2 to 3 weeks. In next month's TAC meeting, the TAC will rate and prioritize all projects, and begin programming for them. If required, a project will go through the Air Quality Conformity analysis.

Mr. Grant said that upon the Town Manager's review of Town of Wellton's project, they have decided to switch out their current intersection widening project for the rehabilitation of William Street (North of Interstate 8 to Los Angeles Avenue). Mr. Grant emphasized the significance of William Street as it is the first impression individuals get of Wellton upon exiting the freeway. The street currently has edges that are broken off and without shoulders. Town of Wellton's current project is approximately \$561,000 for construction; however, the rehabilitation of William Street is approximately \$900,000. The Town of Wellton requested that the rehabilitation project be programmed for FY 2027.

Yuma County Engineer, Frank Sanchez, asked for confirmation from Mr. Grant that although the project has already been partially funded, all that is needed is to move the project to FY 2027?

Mr. Grant clarified that the Town of Wellton was funded for their current project but would need additional funding if they were to exchange it for their new proposed project, in addition to programing it for FY 2027.

Mr. Gutierrez said that once a project has been programmed and then replaced with a possible new project, the funding amount goes back into the pool and available to all member agencies.

Mr. Grant concluded by asking the TAC to please consider the Town of Wellton's project as they rarely propose a new project.

Mr. Holland submitted a possible project for the intersection light at the intersection of Cocopah Casino and Korner Street. According to the information provided by Yuma County Public Works, Cocopah Indian Tribe needs approximately \$95,000 for maintenance of the intersection light. Mr. Holland asked the TAC to please consider their project as Cocopah Indian Tribe has not had a project programmed in the TIP in years.

Mr. Gutierrez asked Mr. Holland whether there had been any major accidents at the intersection of Cocopah Casino and Korner Street.

Mr. Holland said he did not know of any accidents at the intersection.

Mr. Gutierrez said he would inquire about possible accidents in the intersection with Mike Blankenship from Greenlight Traffic Engineering.

Mr. Sanchez said Yuma County is looking at replacing the bridge on Somerton Avenue and 10 1/4. He stated that there was a recent accident on the bridge and was surprised the guard rail prevented the vehicle from going into the canal. The bridge is very old and constantly being maintained because farm vehicles regularly drive over the bridge causing it to flex and the asphalt to break. Mr. Sanchez said Yuma County will formalize and submit a Design Concept Report (DCR) with any additional documentation.

Next, Mr. Vera said that due to the Circulation Study and POE Expansion findings, the City of San Luis will request funding for a Traffic Signal on Main Street.

Mr. Sanchez asked if there have been fatalities on Main Street in San Luis?

Mr. Vera said there have been no fatalities on Main Street.

City Engineer Dave Wostenberg said the City of Yuma will not be requesting any funding at this time. However, the City is working with Yuma County and will include, in their TIP, the preliminary design funds in the outer year for design and environmental plans for County 14th to Foothills Boulevard.

City of Somerton Interim Community Development Director, Saul Albor, will request funding for the reconstruction of Main Street from Somerton Avenue to State Avenue. Mr. Albor stated that they have 100% design for the reconstruction, which includes new roads, new curb and gutter, and sidewalk widening for pedestrian path. Furthermore, the City of Somerton will be seeking funding for plans for the design of City Avenue to Union Avenue.

ADOT Senior Planner, Mark Hoffman, reminded the TAC that Transit projects are also eligible on the Carbon Reduction Program (CRP). Mr. Hoffman encouraged informing YCIPTA Transit Director, Shelly Kreger, that the funds are available.

Mr. Gutierrez said YMPO has spoken with Ms. Kreger and YCIPTA has contacted the City of Yuma about possibly placing more bus pull-outs.

Mr. Hoffman asked if YMPO anticipates authorizing CRP funds for FY 23?

Mr. Gutierrez said he wasn't sure.

Mr. Sanchez asked if traffic signals, or City of Somerton's walkway would qualify for CRP funds?

Mr. Hoffman said the walkway for pedestrians would qualify, however, would have to research whether the traffic signal project would also qualify.

# 7. <u>Arizona Border Master Plan</u>

Mr. Gutierrez provided a brief presentation on the Arizona Border Master Plan. The Arizona Department of Transportation (ADOT) and Federal Highway Administration (FHWA), working collaboratively with State of Sonora, the Mexican Federal Agencies, Secretaria de Relaciones Exteriores (SRE) and Secretaria de

Comunicaciones y Transportes (SCT), and several other local, state, and federal agencies in the United States and Mexico, have initiated the process to update the Arizona-Sonora Border Infrastructure Master Plan (BIMP). The original Border Master Plan was developed in 2012 and completed in February 2013.

The project team began collecting and reviewing data in late 2021 and will continue into 2023. The plan will be approved in mid-2023. Data on existing conditions in the study area and projections for future conditions are currently under development. Site-specific information on operations and infrastructure at each Land Port of Entry (LPOE) will also be updated.

The BIMP process will enable border stakeholders to consider the region's needs for the future. The updated plan will include a list of prioritized Arizona-Sonora border-related infrastructure projects or studies that need to be developed, expanded, modernized or improved.

#### 8. <u>AZ SMART Fund</u>

City of San Luis Assistant City Manager, Jenny Torres, informed the TAC that the City of San Luis is applying for the Arizona Smart Fund for the Cesar Chavez Blvd widening project. Ms. Torres stated that the City is considering using the AZ SMART Funds for the reimbursement of design and engineering costs of \$2.8 million. As part of the regulations of the AZ SMART Fund program, YMPO is required to approve the request for City of San Luis' submittal.

Mark Henige, ADOT, asked Ms. Torres for status on the acquisition of right-ofway.

Ms. Torres said the City of San Luis has acquired 16 acres of state right-of-way and approximately 60 acres of federal right-of-way. She added that the City is currently in negotiations with private property owners.

Mr. Gutierrez said that the City of San Luis is looking for recommendation to the Executive Board for YMPO Director Crystal Figueroa and Executive Board Chair to approve the letter to be sent to San Luis for support of their efforts for the SMART Fund for \$2.8 million.

Ms. Figueroa encouraged all member agencies to apply for AZ SMART Fund Program for reimbursement, design, or non-federal match purposes.

Mr. Vera motioned for approval. Mr. Holland seconded the motion. Motion carried.

#### 12. <u>YMPO and ADOT</u>

YMPO and ADOT staff will have the opportunity to update any other business that is or was not covered in the previous agenda items.

- a. Transportation Alternative Program For informational purposes, Mr. Gutierrez updated the TAC on the Transportation Alternative Program that is currently being redeveloped at ADOT. ADOT's objective is for a fair and equitable program that helps Arizona's local and tribal governments address their unique litany of transportation investment needs. The program's values are:
  - i. Provide technical assistance to equalize access to program resources for all Arizona communities.
  - ii. Investment should look 'beyond the car' to focus on safety, accessibility, and connections between public health and transportation.
  - iii. Program decisions should be transparent and incorporate the principles of diversity, equity, and inclusiveness.

More information to come.

b. ADOT MPD Update - Mr. Hoffman provided a brief update on the Arizona Border Masterplan. The project team finished up meeting with the border communities and finalizing their projects list that they want to include for scoring. The project team has reached out to the technical working group and policy group to get input on the waiting of the evaluation criteria to score each project under the categories.

ADOT has completed the needs and revenue analysis for the State Long Range Transportation Plan. They are currently getting ready for the public meetings scheduled for the end of February and beginning of March.

c. Mr. Henige mentioned to the TAC that the Off-System Bridge applications were submittal deadline was at the end of December. The Bridge Committee will provide an update on selection by the end of the week. Additionally, ADOT LPA will be sending out letters of notification, or following up with questions that the Committee might have with regards to cost on the projects.

Mr. Henige also mentioned that YMPO has submitted all member agency projects that were programmed for authorization for design for FY 23.

Mr. Hoffman asked if the 40th Street HURF Exchange project for FY 23 has been submitted to ADOT LPA? Dave Wostenberg said that there has to be a TIP change for the project due to the bridge construction needs to be completed first

Mr. Henige said he believed the construction was going to be removed from the TIP. Mr. Wostenberg mentioned that construction will take place but in a different year. Mr. Hoffman said there has been no TIP Amendment for that effort. Jennifer Hobert, ADOT, asked Dave if the design was going to be done with local funds, and if the City of Yuma would be pursuing a grant for construction? Mr. Wostenberg clarified by stating that there are three different elements to 40th Street. It was clarified that the City has reached out to YMPO already and a TIP amendment will be happening for this project as soon as possible. Charles Gutierrez, YMPO, assured the TAC and the city that there are already other requests for an amendment and that will occur at the next TAC meeting.

North Frontage Road from 10E to Fortuna - Expect to have final plans from Consultants soon.

#### City of San Luis: Mr. Vera said:

Cesar Chavez (Juan Sanchez) Boulevard - The City is working on right-of-way acquisitions.

County 24<sup>th</sup> Street - The project is currently out to bid.

# City of Yuma: Mr. Wostenberg said:

32<sup>nd</sup> Street Ave B-Ave D - Finalizing agreement from Bureau of Reclamation.

Avenue B - Reconstruction 24<sup>th</sup> Street-16<sup>th</sup> Street - 95% plans

18<sup>th</sup> St & Ave C - New signal, 90% plans and will have an open house on Monday, February 13, 2023.

28<sup>th</sup> Street Widening between 33<sup>rd</sup> drive-45<sup>th</sup> drive - Plans are 100% complete but need to negotiate some right-of-way issues.

#### City of Somerton: Mr. Albor said:

Avenue 1/2 and 1/4 - Improving roadway and plans are currently at 95% plans.

#### ADOT: Isabell Gracia, ADOT, said:

I-8 Sentinel Rest Area Project - Project is 98% complete. Contractor is working on installing electrical panels and then the ADEQ process will begin. Looking to open the rest area by May 2023.

I-8 MP 0.1 - 31 Various Bridges - Project is 95% complete. Contactor is placing pavement marking and working on punch list items.

I-8 Colorado River Bridge Repair Project - Project was awarded to Future Construction and Engineering.

I-8 Wellton-Ave 36E Pavement Life Extension Project - Project is 83% complete. Contractor is working on placing pavement markings.

I-8 W. of Aztec to E. of Aztec (MP 71-82) - Project bid opened, and the lowest bidder was FNF Construction Inc. Project will go before the Transportation Board on February 17th for award consideration.

US 95, Rifle Range Rd-Wellton-Mohawk Canal Bridge Project - Contractor is working on to procure the 96" pipe for the siphon.

US 95 MP 67-80 Pavement Life Extension Project - Project is 65% complete. This project is on winter shutdown until March when the contractor will come back and complete final pavement markings.

In accordance with the Stewardship and Oversight Agreement on Project Assumption and Program Oversight by and between Federal Highway Administration, Arizona Division and the Arizona Department of Transportation, dated April 9, 2015, Attachment A, page A-1, the Arizona Department of Transportation, Traffic Safety Section (TSS) has determined that Yuma County's request to utilize HSIP funds for a safety countermeasure (project) to install safety improvements as outlined below is eligible for the Highway Safety Improvement Program (HSIP) funding.

The safety improvements include the installation of a traffic signal at the intersection of County 14th St and Avenue G in Yuma County, to include left-turn lanes on County 14th St.

All work will be performed by contract and ground disturbing activities are anticipated. No utility relocations are anticipated.

ADOT has determined that, in accordance with 23 USC 148(a)(4))(A), this project is consistent with the State's 2019 Strategic Highway Safety Plan. It supports the "Intersections" emphasis area by implementing the "infrastructure upgrade or improvement" strategy.

During a 5-year period ending December 31, 2021, Yuma County experienced one fatal angle crash in this intersection. With the CMFs obtained from the Crash Modification Factors Clearinghouse and a

combined Crash Reduction Factor CCRF of 87% calculated below, Yuma County could see a 5-year reduction of 0.87 fatal crashes at this intersection. Based on the above CRF, a combined B/C ratio of 7.5 was calculated.

With the CRF of 77% obtained from the CMF Clearinghouse (CMF ID: 326), Yuma County could see a 5-year reduction of 1.54 fatal crashes. Based on the above CRF, a B/C ratio of 19.5 was calculated.

- The Town of Wellton would like to replace our current project on the 2022-2026 TIP, which was the enlarging of the intersection of Los Angeles Av and William St.
- The construction phase of this project was valued at \$ 561,169 STBG and it was scheduled for FY 2026.

## The New Request from the Town of Wellton

- The Town of Wellton would like to instead reconstruct William St. starting from the edge of the improved pavement at Sunset Av going south to the edge of ADOT's pavement on the north side of the I8 overpass. The overall length of the project is 1,907' and the total cost adjusted for inflation is \$ 921,000.
- The Town's engineer estimates the engineering portion at approximately 20% of the total, making that amount \$ 184,200. The Town of Wellton would like to do the engineering phase in 2026. There was \$ 561,169 allotted for the original project, the Town would like to apply that to the engineering portion leaving \$ 376,969 to be applied to the construction phase in 2027, this would leave a balance on the construction portion of \$ 359,831 hopefully to be funded by the TAC in 2027.
