6. Regional Bicycle Coordinator Need

7. 2023 RAISE Grant and Additional Funding Opportunities for US 95

On June 27, 2023, Arizona Senators announced the U.S. Department of Transportation RAISE grants awards for transportation projects in Arizona. One of the selected projects included safety improvements to U.S. Highway 95 along Wellton-Mohawk Canal to Aberdeen Rd in Yuma County for \$8.5M. YMPO Staff will provide an update of additional funding opportunities for US 95.

8. Possible Regional Project Priority List for 2024

The RTAC has reported that the budget surplus for the coming 2024 fiscal year is likely to continue. As a result, they have suggested that member agencies should develop another list of possible projects for consideration for state funding. A distribution of last year's projects and number one priority was distributed July 5, 2023, and members have been asked to review and submit their number one priority.

9. YMPO FY 2024 Title VI Update, Training and Guidance

YMPO Title VI Coordinator will update the Technical Advisory Committee (TAC) with the latest update in respect to the Title VI of the Civil Rights Act of 1964, Limited English Proficiency (LEP), and the Public Participation Plan.

Mr. Aguilar will make a presentation on the Title VI Package and will be available by July 10th on website; this item is on the agenda for, discussion, comment, and possible action to approve the detailed changes to the 2024 YMPO Title VI Report, contingent on no major comments or objections. 10. The Transportation Alternatives (TA) Program

Under the Bipartisan Infrastructure Law (BIL)'s Surface Transportation Block Grant (STBG) Program, the TA Program set aside provides funding for projects that help States build a variety of smaller-scale alternative transportation projects that achieve safer, connected, and equitable on-road networks for all users. The latest update from the developing program consultant indicates a call for projects will likely occur on July 17, 2023.

11. Rural and Tribal Assistance Pilot Program (RTAPP)

The BIL created the RTAPP, which makes \$10M available over years to provide states, local governments, and tribal governments with grants to support project development leading to future application to DOT grant programs. The Application

will be available on August 14, 2023, 11am Arizona time)

12. AZ SMART Fund

Funding for the AZ State Match Advantage for Rural Transportation (SMART) is still available to assist eligible cities, towns, counties, and ADOT in competing for federal discretionary grants. YMPO staff will provide an update on funding.

13. Call for Projects

The Bipartisan Infrastructure Law established the 5-Year Carbon Reduction Program formula funds for members to use on qualified projects in the region. Including FY22 and FY23 funding, there is approximately \$795,000 to be programmed in FY 24.

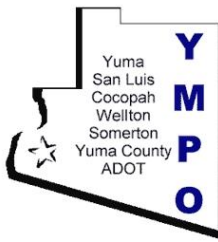

1. **Call to Order and Declaration of Votes.**

In the absence of the Chairman and Vice-Chairman, Dave Wostenberg, City of Yuma, called the meeting to order at 9:00 A.M. The City of Yuma declared votes as Susan Cowey (one vote), Erika Peterson (two votes), and Dave Wostenberg (2 votes). YMPO Executive Director, Crystal Figueroa, introduced and welcomed new TAC members: Erika Peterson, City of Yuma Associate Planner, Charles Gutierrez, City of Somerton Public Works Director, and Alan Heck, Cocopah Indian Tribe Planning Director.

2. **Title VI of the Civil Rights ACT of 1964.**

The YMPO Title VI Nondiscrimination Notice to the Public was read by YMPO Mobility Manager, Jesus Aguilar JR.

3. **Call to the Public**

Gene Dalbey, Yuma Region Bicycle Coalition, greeted everyone present.

4. **Approval of Minutes**

The May 11, 2023, TAC meeting minutes had been included with the agenda. Joe Grant, Town of Wellton, moved to approve the minutes and Frank Sanchez, Yuma County, seconded the motion, which was unanimously approved.

5. **Regional Project Priority List for 2023.**

Paul Ward introduced this item. Mr. Ward reminded the TAC that in recent years, the Arizona State Budget has provided surpluses and the State Legislature has consistently provided additional funds, over and above the normal HURF and Federal funds, to transportation projects throughout the state. During this time, YMPO developed prioritized lists of possible projects to be funded with these surplus state funds and the TAC was instrumental in this effort. The Rural Technical Advisory Committee (RTAC) collected similar lists of prioritized projects from around the state and submitted them to the legislature for consideration. Recently, the Governor signed HB 2543, which contained approximately \$39 million for projects in the Yuma region. Ms. Figueroa noted that \$33.3 million will be going toward the next phase of US-95 and approximately \$6 million will be going toward County 22nd Street and County 17th Street.

Mr. Gutierrez referred to Information Summary 5, which states that the \$33 million includes \$13 million that had been granted under previous years' allocations but has not already been spent. He questioned whether the State Legislature is swiping the \$13 million that was previously allocated.

Ms. Figueroa said that essentially that is what happened and learned about the adjustments made by State Legislature to several projects around the state from a presentation at the State Transportation Board Meeting.

Mr. Ward concluded this item by reiterating that approximately \$39 million was granted in allocations to the YMPO region, which included the \$13 million that had been granted last year.

6. Possible Regional Project Priority List for 2024.

Mr. Ward stated that RTAC has indicated that the Arizona budget appears to be producing surplus funds once again. They will continue efforts to try to increase State funding for local transportation projects in the rural areas of Arizona. RTAC proposed an increased, combined dollar limit of \$400 million statewide for their list. The population-based division of that amount estimated the possible allocation of funds to the YMPO region at just over \$48 million. As a result, they have suggested that member agencies should develop another list of possible projects for consideration for state funding for next year. Mr. Ward presented a tentative schedule for producing the YMPO region's priorities for this list:

Date	Likely Action Needed
Jul 1, 2023	Member agencies submit project requests to YMPO TAC meeting
Aug 10, 2023	The TAC recommends a draft list of prioritized projects
Aug 31, 2023	The Board approves a list of prioritized projects
Sep 4, 2023	The list is submitted to the RTAC for submittal to the AZ legislature

Ms. Cowey asked whether a project would get a higher priority ranking if agencies combine their efforts in a particular project.

Mr. Gutierrez mentioned that the reason why County 22nd Street and County 17th Street project was ranked higher was because it touched other local cities, such as the Cities of San Luis, Somerton, and Yuma. Therefore, the MPO, specifically the TAC, might favor a combined project as opposed to a project within a city.

Ms. Figueroa asked Ms. Cowey what project she was referring to. Ms. Cowey said the 40th Street Corridor encompasses Yuma County. Mr. Wostenberg continued by stating that the 40th Street project also relieves traffic from the Foothills area, and it is a direct access to Marine Corps Air Station (MCAS) Yuma.

Ms. Figueroa stated that the 40th Street project seems like a great candidate for the regional project priority list for FY 2024.

As information, Mr. Gutierrez said that last year, each agency produced its top 3 projects and eventually dwindled it down to its number 1 project.

Last year's regional project priority list was shown to the TAC.

Mr. Ward said the RTAC plans on presenting this list to the legislators at the Rural Transportation Summit being held in Yuma on October 18-19, 2023. Mr. Ward suggested that agencies may submit as many projects as they want but ultimately, the projects given to RTAC will be worth approximately \$48 million.

Ms. Figueroa recommended that all agencies send their projects in the fact sheet version.

Mr. Ward concluded this item by stating that further guidance on how member agencies will be submitting all the information needed to YMPO.

Mr. Dalbey asked TAC agencies to keep bicyclists in mind when dealing with their projects.

7. FY 2024-28 YMPO Transportation Improvement Program (TIP).

Mr. Ward presented this item. YMPO TAC members have submitted projects for consideration of, and possible inclusion in, the FY 2024-28 YMPO Transportation Improvement Program (TIP). The TIP is a continuously moving document and changes to projects are possible, even at this stage. The TIP contains all projects funded with Title 23 Federal Transportation funds within the YMPO region. Effectively, anything that changes the transportation model network, regardless of whether it is federally funded or not, should be on the TIP. Mr. Ward provided a copy of the draft version of the TIP to all TAC members, which includes an updated list of projects. Surface Transportation Block Grant Program (STBG) funds are available for programming and the process of selecting projects for those funds will be discussed in the upcoming TAC meetings. Additionally, Carbon Reduction Program (CRP) funds will also need to plan projects for, which some member agencies have already made their requests.

Mr. Ward informed the TAC that the TIP provided has not yet been presented as a document for approval; however, if the TAC feels it is appropriate to do so, the item is on the agenda for a recommendation for approval to the Executive Board on June 29, 2023, for possible approval and a Resolution of support. Following this, the TIP will be sent to the Governor for her approval (or her designee) and eventual inclusion into the State TIP, which is then reviewed by the various Federal authorities. Mr. Ward suggested the TAC hold a special meeting in two weeks to allow the TAC to review and revise the projects listed.

Mr. Wostenberg agreed to move forward and schedule a special meeting to provide time for any revisions needed by member agencies.

Ms. Cowey recommended that more time is needed to review the TIP.

Mark Hoffman, ADOT, said if there were to be conformity issues, then it would not be a conforming TIP and will be held up and not taken to the Executive Board for approval until that is completed.

Ms. Cowey moved to table the discussion for one week and hold a special meeting and Ms. Peterson seconded the motion, which was unanimously approved.

Mr. Sanchez asked if it was possible to have the special meeting on June 22, 2023, instead.

Mr. Wostenberg asked Ms. Cowey to amend her motion. Ms. Cowey moved to table the discussion for two weeks and schedule a special meeting for June 22, 2023, at 9:00 A.M. to discuss this item. Ms. Peterson seconded the motion which was unanimously approved.

8. Status of YMPO Federally Funded Projects.

This item was tabled to July's TAC meeting.

9. The Transportation Alternatives (TA) Program.

Ms. Figueroa introduced this item by informing the TAC that the TA Program (TA) Set-Aside from the STBG Program is being developed by ADOT. The TA provides funding for a variety of generally smaller-scale transportation projects such as pedestrian and bicycle facilities, safe routes to school projects, community improvements such as historic preservation and vegetation management, and environmental mitigation related to stormwater and habitat connectivity. Furthermore, the TA is a competitive grant program, which means that the process will allow eligible entities to submit projects for funding that achieve program objectives, and this process must include prioritization of project location and impact in high-need areas as defined by the State.

Mr. Ward began his presentation by explaining that the TA Program Call for Projects announcement is currently anticipated to take place in early June 2023. The 2-step application process consists of:

1. Project Screening
2. Project Evaluation

The screening application will open as soon as the call for projects is announced. ADOT will review on a tolling basis and notify Project Sponsors if their project can advance to Step 2: Project Evaluation. Project Sponsors will have up to 8 weeks to submit a screening application. However, submitting early will give more time to complete an evaluation application, should the project advance. The evaluation application will open as soon as projects start advancing from the screening phase

and will remain open until mid-August. Evaluation applications will be sent to the TAC for review. The TAC will have 4 weeks to complete reviews and provide input.

Mr. Ward said that although project eligibility/criteria was vague, he believed a project such as turning Cocopah Indian Tribe's rail line, which is no longer in use, into a multi-use path would be a good candidate.

Ms. Figueroa informed the TAC that ADOT is working on a TA Guidebook that will be solidified and sent out to all TAC members soon.

Mr. Ward suggested applications be submitted as funds available are from FY 2022-2024.

Mr. Gutierrez asked if there was any guidance as far as ranking internally through COGs/MPOs, including applications from non-profits within the YMPO region. Ms. Figueroa said the applications will be vetted through a TAC composed of COG/MPO Directors. As far as how to handle applicants in the YMPO region, that is something that will be determined internally.

Mr. Hoffman stated that non-profit entities are eligible applicants, which include local governments, transit agencies, natural resource and public land agencies, school districts, tribal governments, and any other local regional government entity that is responsible for oversight and transportation or recreational trails.

Mr. Wostenberg asked if an update could be provided in the June 22, 2023, special meeting.

Mark Henige, ADOT, directed all members to the FHWA website for more information on the TA Program. He also suggested that all applicants be cautious of costs escalating as this was an issue in prior years due to the local agency having to be responsible for the increase in cost. Based on the TA guidelines, the scoring will be based on schedule feasibility, meaning can the project be completed within two years, design feasibility that is not too complex, and community support. Additionally, if the project required right-of-way, the TA program funds would not be available as this incurs costs and requires more time for completion.

10. TAC Officers.

Mr. Ward introduced this item. Mr. Ward informed the TAC that Vice-Chairman Eric Holland no longer represents the Cocopah Tribe. The new Cocopah representative is Mr. Heck. Mr. Heck expressed his desire not to serve as Vice-Chair because he is not familiar with the TAC. Based on the YMPO TAC Officers calendar, it seems Yuma County would be next to serve as Vice-Chair. Mr. Ward

asked the TAC for input on this item. This item will be tabled until July's TAC meeting for possible nomination and action to appoint a Vice-Chair.

Mr. Sanchez stated he would have no issue with being Vice-Chair.

11. YMPO and ADOT.

- a. YMPO - Mr. Ward had no update for the TAC.
- b. ADOT MPD Update - Mr. Hoffman stated that ADOT is finalizing deliverables, such as the Funding Gap Analysis, and Resilience Analysis for the State System, as part of the State Long Range Transportation Plan. Additionally, ADOT is finalizing and working through the State Transportation Board to set the funding levels for the individual categories of preservation, modernization, and expansion, which will be used to develop the 5-year program each year. There will be a remaining 30-day public comment review period of the draft plan after it is presented to the Board.

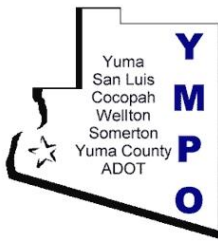

1. **Call to Order and Declaration of Votes.**

In the absence of the Chairman and Vice-Chairman, Dave Wostenberg, City of Yuma, called the meeting to order at 9:00 A.M. The City of Yuma declared votes as Dave Wostenberg (2 votes), Erika Peterson (2 votes), and Susan Cowey (1 vote).

2. **Title VI of the Civil Rights ACT of 1964.**

The YMPO Title VI Nondiscrimination Notice to the Public was ready by YMPO Administrative Assistant/Bookkeeper, Norma Chavez.

3. **Call to the Public**

Gene Dalbey, Yuma Region Bicycle Coalition (YRBC), expressed his appreciation for everyone's punctuality and attendance at the TAC meetings.

4. **FY 2024-28 YMPO Transportation Improvement Program (TIP).**

Paul Ward, YMPO Principal Engineer, presented this item. The FY 2024-28 YMPO TIP was on the agenda during the previous meeting, on June 8, 2023, for possible action to recommend to the YMPO Executive Board for approval at its June 29, 2023 meeting. The final copy of the TIP document was not available in sufficient time for TAC members to adequately review the document and, as a result, members deferred action until a Special meeting could be called on June 22, 2023. Mr. Ward began by displaying changes to the Transit projects that, in collaboration with YCIPTA, have been included in the TIP. The TIP was updated to include 2026-28 transit projects. Mr. Ward clarified that the apportionment year doesn't directly reflect the year in which the project sits due to transit operating on a grant basis.

Mark Hoffman, ADOT, asked how the recent 5310 awards will be added to the YMPO 2022-26 TIP? Mr. Hoffman stated that ADOT is requesting the 5310 awards for the region be added to the YMPO TIP for their grant application submittal and approval by FTA.

Mr. Ward said that the projects Mr. Hoffman is referring to are listed in the new TIP in FY 24.

Mr. Hoffman responded that ADOT is looking for the 5310 awards to be amended into the YMPO 2022-26 TIP and approved by the Executive Board so that ADOT can include them in the STIP quicker. Not doing so would delay funding.

Crystal Figueroa, YMPO Executive Director, confirmed that the 5310 awarded projects must be added to the current FY 2022-26 YMPO TIP.

Mr. Hoffman confirmed that the 5310 awards must be added to YMPO's FY 2022-26 TIP in the year 2023.

Charles Gutierrez, City of Somerton, said that in the past, the 5310 awards were immediately installed into the TIP as they were announced. Mr. Gutierrez asked that since the 27-28 TIP has not been filled in yet, when would the final DCR for the City of Somerton be reviewed for programming for the available 27-28 funding?

Mr. Ward said that hasn't been decided.

Mr. Gutierrez asked if this would be something that could be decided on during the meeting.

Mr. Wostenberg said that the item was not on the agenda for the current meeting and therefore could not be acted on.

Ms. Cowey motioned to hold a special session for the TAC to approve the 5310 awards.

Ms. Figueroa requested additional information regarding the project Mr. Gutierrez was referring to for the City of Somerton.

Mr. Gutierrez stated it was a redevelopment project that Saul Albor, City of Somerton, presented to the TAC.

Frank Sanchez, Yuma County, reported that the county also had a mini DCR ready for submittal, but was waiting until the TAC created a format on how to submit projects. Additionally, Mr. Sanchez asked if it was possible to take action on the addition of the 5310 awards to the TIP during this meeting.

Mr. Hoffman reiterated that the 5310 awards being added to the current TIP cannot be decided today as the item was not on the agenda. However, the awards must be amended to the current TIP as quickly as possible to be included in the STIP.

Mr. Hoffman suggested the deletion of YMPO's self-certification from the TIP document on page 45.

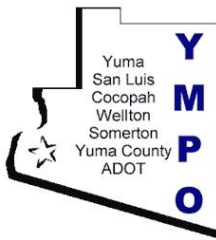

1. Call to Order and Declaration of Votes.

Chairman Eulogio Vera called the meeting to order at 9:00 A.M. The City of Yuma declared votes as David Wostenberg (two votes), Erika Peterson (two votes), and Susan Cowey (one vote).

2. **Title VI of the Civil Rights ACT of 1964.**

The YMPO Title VI Nondiscrimination Notice to the Public was read by YMPO Administrative Assistant/Bookkeeper, Norma Chavez.

3. **Call to the Public**

Charles Gutierrez, City of Somerton, congratulated YMPO for being awarded an \$8.5 million Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant for the widening project of US Highway 95. YMPO Executive Director, Crystal Figueroa, recognized Mr. Gutierrez's assistance in the grant process during his time with YMPO. Ms. Figueroa also announced that Paul Ward, former Principal Engineer at YMPO, was no longer with the organization due to personal reasons.

4. **FY 2022-26 YMPO Transportation Improvement Program (TIP) Amendment #8.**

Ms. Figueroa presented this item. The FY 2022-26 YMPO TIP was originally approved on July 29, 2021, and has since been amended seven times, most recently on March 30, 2023. Another TIP Amendment was necessary to add some FTA 5310 awarded projects funded for FFY 2023 for the region, which is year one of the two-year application cycle. Year two awards would be posted in 2024. This item was discussed during the previous TAC special meeting, on June 22, 2023, for possible action to recommend to the YMPO Executive Board for approval at its June 29, 2023, meeting. Ms. Figueroa presented the changes listed in the transit TIP tables provided, for FFY 2023.

Mr. Wostenberg motioned to recommend approval of the FY 2022-26 YMPO TIP Amendment #8. Mr. Gutierrez seconded the motion, and the motion was unanimously approved.

5. **FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) Amendment #1**

Ms. Figueroa presented this item. Ms. Figueroa stated that an amendment to the FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) was needed to allow the Yuma County Avenue E/D project to move forward with the design and right-of-way acquisition programmed in FY 24. Yuma County requested to extend the Avenue E/D project by two miles from County 18th to County 16th, which would require an update to the regional conformity analysis at an estimated cost of \$15,000. Since Avenue E/D is a federally funded project, ADOT will review the environmental clearance on the corridor as a whole.

Mr. Gutierrez asked if it was possible to wait until YMPO began updating their current LRTP, which was happening soon.

Ms. Figueroa stated that the two available options are to update the current LRTP or include the project in the new LRTP. Due to the approximate 18 months needed to update the LRTP, it was determined that the best choice would be to amend the current LRTP and update the regional conformity analysis.

Mr. Wostenberg asked, for informational purposes, why an update to the regional conformity analysis was needed when the project was only adding a center lane.

Ms. Figueroa clarified that an update to the Conformity Analysis was needed because the LRTP only identified up to County 18th, meaning that it did not include County Roads 16 and 17.

Ms. Figueroa concluded her presentation by stating that FY 2022-2045 YMPO LRTP Amendment #1 will be presented to the Executive Board for possible approval.

2023 RAISE Grant and Additional Funding Opportunities for US 95

DATE: July 13, 2022

SUBJECT: 2023 RAISE Grant and Additional Funding Opportunities for US 95

SUMMARY:

The Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Discretionary Grant program, provides Department of Transportation (DOT) an opportunity to invest in transportation infrastructure projects. In partnership with ADOT, the YMPO was the lead applicant for safety improvements to U.S. Highway 95 along Wellton-Mohawk Canal to Aberdeen Rd Planning Grant in Yuma County for \$8.5M. On June 27, 2023, Arizona Senators announced the Department of Transportation RAISE grants awards for transportation projects in Arizona and the safety improvements on US 95 project was selected; funding will facilitate full design of the remaining three segments of US 95 and make it shovel ready for construction.

To supplement the RAISE grant funding, ADOT has agreed to apply for \$4M of the ADOT AZ SMART Fund and is expected to go to the State Transportation Board for approval this month, or at the latest in August for possible approval.

Recently released on June 26, 2023, was the Multimodal Project Discretionary Grant (Mega, Infra, and Rural) program and was identified as a potential funding opportunity considering final design of US 95. It would allow for shovel-ready project for construction funds in the near future and the 2023 State Legislation funding available to match such grant.

YMPO Staff is currently in the consulting stages with Wilson and Company to seek feasibility of grant for US 95 widening project to write the grant application. The deadline for applications is on August 21, 2023.

PUBLIC INPUT:

No members of the public have commented on this request, to date.

TECHNICAL & POLICY IMPLICATIONS:

TECHNICAL: The 2023 RAISE Grant and AZ SMART funds will fully fund the design of the remaining phases of US 95. The project is anticipated to begin in August 2023 with a final design and be shovel ready for construction funding opportunity.

POLICY: The region utilized local funds to apply for federal Grants.

SUMMARY:

Following the previous successful 2023 State Legislative process of HB2543 for Greater Arizona Transportation Priority Projects by the Rural Transportation Advocacy Council (RTAC), which contained approximately \$39 million for projects in the Yuma region. The RTAC has reported that the budget surplus for the coming 2024 fiscal year is likely to continue. As a result, they have suggested that member agencies should develop another list of possible projects for consideration for state funding. A distribution of last year's projects and number one priority was distributed on July 5, 2023, and members have been asked to review and submit their number one priority.

RTAC had suggested an increased, combined dollar limit of \$400 million statewide for their list, plus \$100 million for the SMART Fund. The population-based division of that amount estimates the possible allocation of funds to the YMPO region at just over \$48 million.

A tentative schedule for producing the YMPO region's priorities for this list, is as follows:

Most importantly there is a community of houses west of 25E at Gila Ranch Road scattered west to the base of the Laguna mountains.
- Although, the military does most of the damage to this primitive road. They have shown no interest in improving the road or at least helping to maintain it.
- The road consists mainly of native sand and gravel which makes it impossible to keep in a safe passable condition. A Jeep recently broke a tie rod and rolled on the road injuring the driver, due to the wash boards.
- So, one can imagine how difficult this makes it to provide common services and especially emergency services to this area.
- This project is to realign and finish paving 25E from County 12th Avenue to County 14th Avenue.

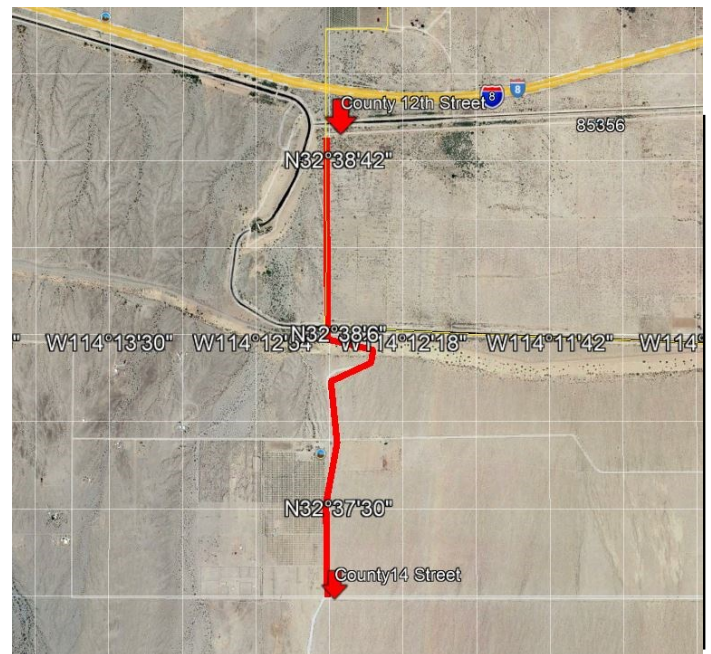

The Transportation Alternatives Program (TAP)

SUBJECT: The Transportation Alternatives Program (TAP).

SUMMARY:

The Transportation Alternatives Program or TAP program encompasses a variety of smaller-scale alternative transportation and related projects, these projects may include:

- Pedestrian and bicycle facilities
- Recreational trails
- Safe routes to school projects (SRTS)
- Other community improvements:
 - Historic preservation
 - Vegetation management
 - Environmental mitigation projects related to stormwater and the habitat

Previously TAP program funds were included within the STBG programs because the money available to the smaller MPOs and COGs wasn't significant enough to warrant being managed as a stand-alone TA program. As part of the Bipartisan Infrastructure Law the TAP funds have significantly increased. Now the TA Program is a 10% set-aside of the Surface Transportation Block Grant (STBG) Program and ADOT expects for FY 2022-2026 to receive an average of \$18.4 million annually for the TA program.

ADOT is designing and implementing an updated TAP program and guidebook. On July 12 ADOT has scheduled the launch of a TA website that will provide guidance, link to the application and other resources. The current communicated timeline is as follows:

SUBJECT: Rural and Tribal Assistance Pilot Program (RTAPP)

SUMMARY:

The U.S. Department of Transportation's (DOT's) Build America Bureau recently released a Notice of Funding Opportunity (NOFO) for a new pilot program created by the Bipartisan Infrastructure Law (BIL). The Rural and Tribal Assistance Pilot Program (RTAPP) offers technical assistance grants to rural and tribal communities. The grants can support legal, technical, and financial advisors to help advance infrastructure projects. The Program makes \$10 million available over five years to advance infrastructure projects in these communities. The NOFO combines two years of funding (Fiscal Years 2022 and 2023), \$3.4 million in total, to eligible applicants on a first-come, first-served basis. Individual awards will range in value up to the statutory limit of \$360,000. There is no local funding match required to participate in this program and no letters of support required.

The Bureau has created a simple, four-page funding application, and will begin accepting submissions at 2:00 p.m. ET on August 14, 2023. Application reviews will conclude once the full \$3.4 million has been awarded, or on September 27, 2023, 45 days after the application period opened.

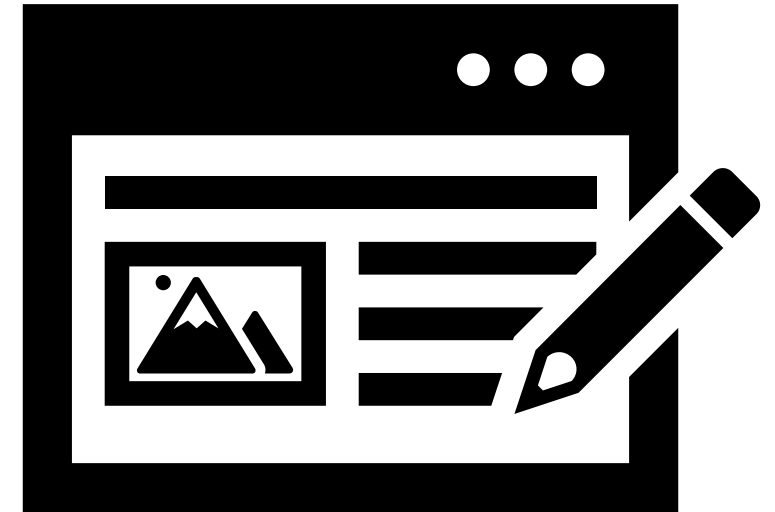

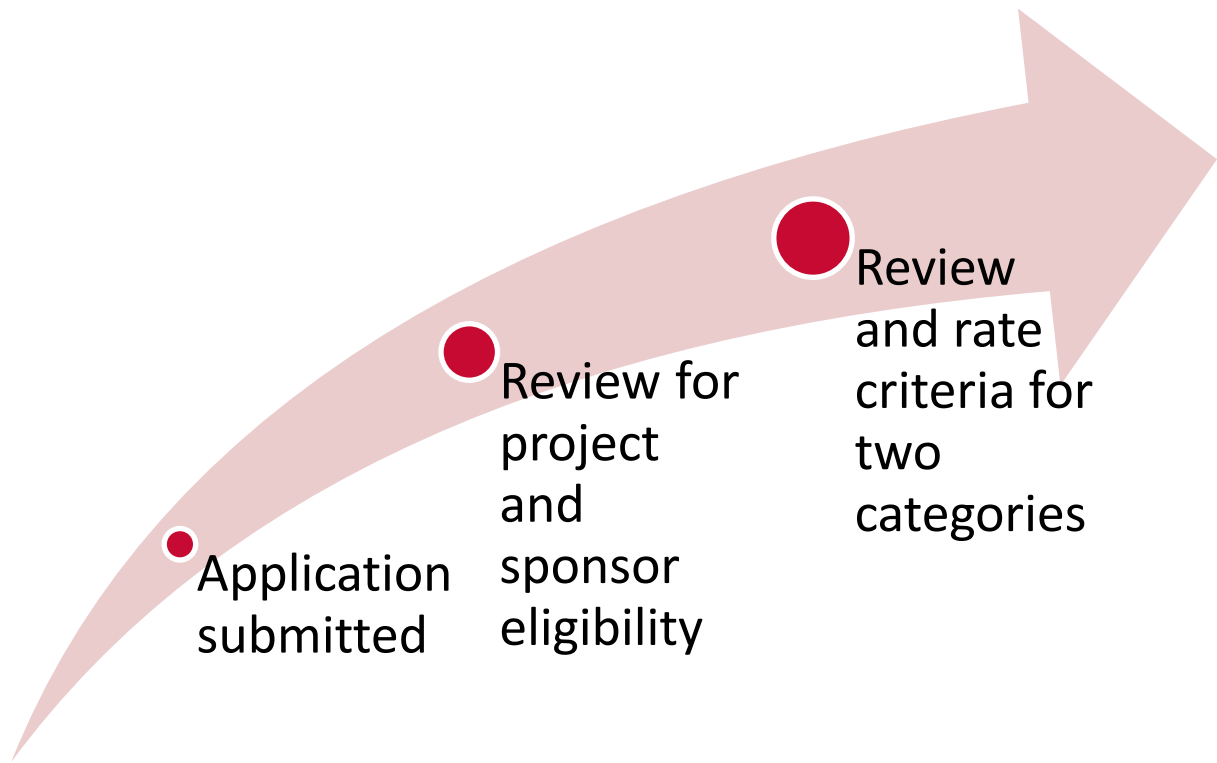

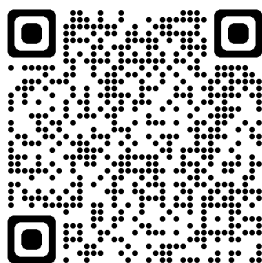

AZ SMART Fund Update

DATE: July 13, 2023

SUBJECT: AZ Smart Fund Update

SUMMARY:

During the January 12, 2023, TAC meeting, members were informed that the Arizona Legislature established the AZ State Match Advantage for Rural Transportation (SMART) Fund of \$50 million in state fiscal year 2023 to assist eligible cities, towns, counties, and ADOT in competing for federally discretionary grants. Applications to the AZ SMART Fund must first be approved by the applicant's Council of Government (COG) or Metropolitan Planning Organization (MPO). Furthermore, ADOT administers this fund, and the State Transportation Board (STB) approves all awards.

Since then, various projects have been approved and awarded across the State by the State Transportation Board, two of which are in the Yuma Region. As part of negotiations between the Governor and Legislative leaders, on May 11, the Governor signed a package of bills including funding for Transportation Infrastructure. Senate Bill 1722, Sec 15 appropriated \$12.5 million to the AZ SMART fund in the State Fiscal Year budget; and will add \$2.5 mil to each five applicant categories, effective July 1, 2023.

All our member agencies are eligible to receive such funds for the following uses associated with developing a project, applying for, or providing a local, non-federal match on a federal grant. In addition, applicants may be eligible for reimbursement for the following activities based on population criteria:

- Up to 50% of the eligible costs associated with Grant Development and submission of an application for federal grant limited to
 - Counties with population of less than 100,000 and
 - Cities/towns with population of less than 10,000
- Match for a federal grant.
- Design and other engineering services (preliminary engineering through final design related to a road, bridge, rail, or transit infrastructure construction project).

The following is the activity and available funds by category as of July 3, 2023, the latest projects are expected to be approved by the STB on July 21, 2023.

SUBJECT: CRP Call for Projects for the FY 2024-28 YMPO Transportation Improvement Program (TIP)

SUMMARY:

During prior TAC meetings, the Carbon Reduction program was introduced along with eligibility criteria and a call for projects was initiated. At this point, one Project Nomination Sheet and Mini Design Concept has been received. Many of you have expressed potential projects; however, we will still need a formal submittal, including total cost and description for each project, by July 31, 2023. The information will then be distributed within the TAC for review by the next TAC meeting on August 10. The TAC will then be able to rate, prioritize, and begin programming selected projects. Although there is not a fully established process for project programming, traditionally it involved submitting a Mini-DCR as an application for funding consideration. Until the Federally Funded Program is developed, we shall continue to utilize the established process.

The YMPO region, each year, generally receives about \$300 million in Carbon Reduction Program (CRP) funds specifically for programming projects in the region. This should be available at least through 2026.

To review, the Carbon Reduction Program provides funds for projects designed to reduce transportation emissions, defined as carbon dioxide (CO₂) emissions from on-road highway sources.

Some examples of eligible projects would include projects that support the reduction of transportation emissions, including, but not limited to:

- projects to establish or operate a traffic monitoring, management, and control facility or program, including advanced truck stop electrification systems
- public transportation projects eligible under 23 U.S.C. 142
- a transportation alternative project such as the construction, planning, and design of on-road and off-road trail facilities for pedestrians, bicyclists, and other nonmotorized forms of transportation

- projects for advanced transportation and congestion management technologies
- deployment of infrastructure-based intelligent transportation systems capital improvements and the installation of vehicle-to-infrastructure communications equipment
- projects to replace street lighting and traffic control devices with energy-efficient alternatives
- a project or strategy designed to support congestion pricing, shifting transportation demand to nonpeak hours or other transportation modes, increasing vehicle occupancy rates, or otherwise reducing demand for roads, including electronic toll collection, and travel demand management strategies and programs
- efforts to reduce the environmental and community impacts of freight movement
- a project that supports the deployment of alternative fuel vehicles, including the acquisition, installation, or operation of publicly accessible electric vehicle charging infrastructure or hydrogen, natural gas, or propane vehicle fueling infrastructure; the purchase or lease of zero-emission construction equipment and vehicles, including the acquisition, construction, or leasing of required supporting facilities
- a project described in 23 U.S.C. 149(b)(8) for a diesel engine retrofit
- certain types of projects to improve traffic flow that are eligible under the CMAQ program, and that do not involve the construction of new capacity
- any project that reduces transportation emissions at port facilities, including through the advancement of port electrification; and any other STBG-eligible project, if the Secretary certifies that the State has demonstrated a reduction in transportation emissions, as estimated on a per capita and per unit of economic output basis.

Next month the TAC will be asked to recommend a tentative list of projects considering the the funds available.
