1. <u>Call to Order and Declaration of Votes</u>

Chairman Eulogio Vera called the meeting to order at 9:00 A.M. The City of Yuma declared votes as Steve Wilson

2. <u>Title VI of the Civil Rights ACT of 1964</u>

The YMPO Title VI Nondiscrimination Notice to the Public was ready by YMPO Mobility Manager, JR Aguilar.

3. Call to the Public

There were no announcements from the public or TAC.

YMPO Executive Director, Crystal Figueroa, announced the arrival of Cocopah Indian Tribe Planner, Allen Heck, at 9:02 a.m. to the TAC meeting.

4. Approval of Minutes

The August 10, 2023, TAC meeting minutes had been included with the agenda. Frank Sanchez, Yuma County, moved to approve the minutes and Charles Gutierrez, City of Somerton, seconded the motion, which was unanimously approved.

5. <u>FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) Amendment</u> #1 and Air quality Conformity Update

Vamshi Yellisetty, Kittelson & Associates, provided an update to Amendment #1 to the previously adopted FY 2022-2045 LRTP to accommodate three new changes. The changes presented are already in the previously adopted LRTP but are in different construction horizon years. The changes presented are listed below with requests for each LRTP project listed under the comment section.

All three projects are significant enough to require an Amendment to the LRTP and an update Air Quality Conformity Analysis. An email was sent to the Inter Agency Council (IAC) informing them of the intent to update the LRTP and Air Quality Conformity Analysis. Once completed, the results will be presented to the TAC and sent to IAC, and eventually presented to the Executive Board for approval.

Mr. Sanchez asked for an approximate date of completion. Mr. Yellisetty said there is a two-week review period with the IAC upon submitting the air quality results, which is scheduled to be sent on September 25, 2023. If the IAC wishes to comment, then the process gets prolonged. Otherwise, the effort is likely to be completed by October 9, 2023.

6. Regional Project Priority List for 2024

Ms. Figueora presented this item. The Rural Transportation Advocacy Council (RTAC) reported that the State budget surplus for the coming 2024 fiscal year will likely continue. As a result, the RTAC Board agreed to pursue a \$400 million funding request for projects allocated to each region based on population for priority projects, with just over \$48 million for YMPO's region. The YMPO TAC developed a list of priority projects during their meeting on August 10, 2023, and considering there were more costs in projects than funds available, there was a consensus discussion on the prioritization of the list and to reduce ADOT's amount to include the City of Somerton's project for possible funding to signalize the intersection of Main Street (US 95) and Somerton Ave and other facility

improvements considering the Yuma Count Phase II pavement project from Count 17th Street to Avenue D.

Priority projects

During the August Executive Board meeting, various State Representatives were in attendance and were presented with YMPO's Regional Project Priority List for their support and recommended approval by the Board. The Board approved all three projects for inclusion into the RTAC statewide list. The YMPO RTAC Board members will have the opportunity to present one priority project at the Rural Transportation Summit in October.

7. FY 2022-26 Transportation Improvement Program (TIP) Amendment #10

YMPO Senior Transportation Planner, Fernando Villegas, presented this item. The FY 2022-26 YMPO TIP was initially approved on July 29, 2021, and has been amended ten times, most recently on August 24, 2023, through the Executive Board. The following changes are only administrative adjustments to include or update local fund contributions for the Pedestrian Hybrid Beacon project to include local fund contribution of \$121,000 for the design. The City of Yuma also requested a TIP amendment for the "A" Canal: 7E and 40th Street project local fund contribution of \$91,000 for design and \$986,488 for construction phases in the stated years. The changes are shown below in blue font.

8. FY 2024-28 YMPO Transportation Improvement Program (TIP) Amendment #2

^{*} Withdrew project, considering the City will pursue grant funding at later time.

Mr. Villegas presented this item. The FY 2024-28 YMPO TIP was originally approved on June 29, 2023, and has been amended one time, most recently on August 24, 2023. The City of Yuma has requested an adjustment to FY24 to update the local funds contribution for the "A" Canal Avenue 7E at 40th Street project. The new local fund contribution for the project is \$2,364,972.

Susan Cowey, City of Yuma, stated that the Project Description for "A" Canal Avenue 7E at 40th Street project should be updated from roadway to bridge.

Additionally, the TIP ID was corrected from YU-23-11X to YU-23-11C. Upon the TAC's recommendation in August, YMPO included the two Carbon Reduction (CRP) projects for the City of Yuma and one for Yuma County on the respective TIP tables. Updates are highlighted below in red and yellow.

Mr. Gutierrez motioned to approve the YMPO TIP Amendment #2 with modifications discussed by staff to the Yuma County project. Mr. Sanchez seconded the motion, which was unanimously approved.

Mr. Vera announced the arrival of Joe Grant, Town of Wellton, at 9:10 a.m. to the TAC meeting.

9. CRP and STBG Available Funding

Mr. Villegas presented this item. The YMPO region received approximately \$300,000 in Carbon Reduction Program (CRP) funds for programming each year, available for five years, FY 2022-20226. In last month's TAC meeting, the TAC recommended the following CRP projects for programming in the YMPO FY 2024-2028 TIP and previously presented for possible recommended approval by the Executive Board. The table presented shows the Unified Planning Work Program (UPWP) - Complete Streets Study, a Yuma County project, two City of Yuma projects, and available funding each fiscal year.

Mr. Sanchez agreed to reduce the programmed funding on the Avenue 3E Bridge over "A" canal to avoid the over programmed balance at the end of fiscal year 2025. However, Mr. Sanchez noted that he still would like to have the option to borrow from another COG or MPO to complete the construction in

FY2025. Ms. Figueroa said that she will try to find out from other MPOs if YMPO can get a loan.

Ms. Figueroa noted that Joe, from the Town of Wellton, has requested additional funds for the FY2026 project. Mr. Gutierrez said that he does not remember all the conversations.

Ms. Figueroa said that based on the available funds for FY 2027-2028, the TAC may submit another project for consideration, or do another round of Call for Projects for FY 2027-2028.

Mr. Sanchez recommended YMPO put out another Call for Projects.

10. <u>FY 2026-2049 Long-Range Transportation Plan Update</u>

Mr. Villegas presented this item. YMPO is required to update the LRTP every four years. YMPO is in the beginning stages of preparing the RFP and Scope of Work as the update must be finalized by June 2025. The LRTP provides a vision for the region's future transportation needs and guides the investment of public funds in transportation facilities over the next 20 years. The update includes:

- The current and projected transportation demand of persons and goods.
- Existing and proposed transportation facilities including pedestrian walkway and bicycle.
- Performance measures and performance targets.
- Improvements to the performance of existing transportation facilities to relieve vehicular congestion and maximize safety and mobility of people and goods.
- Transportation and transit enhancement activities.
- Aire Quality Conformity.
- Financial Plan.

YMPO plans to distribute the RFP and Scope of Work to the TAC for review, comments, and recommendations. Ideally, a consultant will be chosen by the TAC by the end of the year.

Ms. Figueroa commented that the previous LRTP had a safety component, and the Highway Safety Improvement Program (HSIP) applications were completed through the same process. During the upcoming update, YMPO plans to do the same as ADOT's Safety Department will be releasing their Call for Projects for HSIP projects in January 2024 for FY 2027/28.

Mr. Sanchez asked for the amount of funds available for the next round of HSIP projects.

Mark Hoffman, ADOT, stated that there is approximately \$40 million available, statewide, for HSIP projects.

11. <u>2023 Rural Transportation Summit (RTS)</u>

Norma Chavez, YMPO Administrative Assistant/Bookkeeper, presented an update to this year's RTS. YMPO is hosting this year's Summit at the Hilton Garden Inn Yuma Pivot Point on October 18-19, 2023. Currently, there are 216 people registered for the event, which includes 15 Arizona State Legislators. Ms. Chavez encouraged all TAC members to register for the event before the early bird discount ends on September 15, 2023.

Ms. Figueroa named keynote speakers for the event, such as Arlando Teller, US DOT Assistant Secretary, NADBank's Deputy Managing Director John Beckham, and Sonora State Government Representative in Arizona David Figueroa. Invitations to Arizona Governor Katie Hobbs and Arizona State Senator Mark Kelly have been sent, but have not received a response.

12. YMPO and ADOT

ADOT MPD Update - Mr. Hoffman stated that the State Long Range Transportation Plan (SLRTP) is nearing its end, but is currently in the public comment period and will then go to the State Transportation Board in October for final approval. The Arizona Sonora Border Master Plan has been completed and will be posted on the ADOT website soon. Additionally, the Transportation Alternatives (TA) Program application submittal period is still open.

Ms. Figueroa said the TAC of the TA Program application submittal deadline was extended to Augst 31, 2023. All submitted applications will then be reviewed and final applications are due by September 27, 2023.

13. <u>In-Kind Match Forms</u>

SUBJECT: STBG Call for Projects

SUMMARY:

STBG is a federal-aid highway flexible funding program that funds a broad range of surface transportation capital needs. YMPO programs STBG funds for primarily construction projects. Several projects have been programmed for FFY 2024 – 2028 to include LTAP. The remaining STBG funds highlighted are available for programming. Members are encouraged to look at projects that were developed during the YMPO 2022-2045 Long-Range Transportation Plan (LRTP) and included as part of the Air Quality Conformity Analysis (AQCA) at this stage. Project development should be a project that was submitted and had the Air Quality Conformity Analysis.

While STBG funding is generally flexible, there are some limitations. For example, STBG funded projects in general cannot be on local roads or rural minor collectors. The STBG funds can be used primarily on Major Collector and above or Urban Minor Collector classification on the Federal program YMPO receives.

YMPO has included as part of FY2024 \$44,154 for the Update of the Long-Range Transportation Plan (LRTP). The \$44,154 has reduced the available funding for the next fiscal year.

The table above shows the new available funding.

Yuma County agreed to reduce the requested HURF Exchange amount of the Avenue 3E Bridge over "A" canal from \$1,250,137 to prevent overprogramming of funds; however, YMPO staff is looking at the option to pursue a loan from another MPO in FY 2025 for repayment in later year. If the loan is secure, the available funds for a future year will be reduced.

SUMMARY:

The TA Program is a 10% set-aside of the Surface Transportation Block Grant (STBG) Program and ADOT expects for FY 2022-2026 to receive an average of \$18.4 million annually for the TA program.

The three projects that YMPO provided LOS (Letters of Support) for were accepted as part of the ADOT Screening Process and Evaluation Applications have been submitted.

Statewide there are 30 projects that are being evaluated and scored for the TA program funding for FY24. The total TA funding requests for the 30 projects requested is \$13M. The TA TAC is reviewing and scoring the projects from now through October 13th. ADOT will apply a scoring mechanism, the output of which will be a ranked list of the TA projects that will be submitted to the State Transportation Board for Review.
