Call to Order and the Pledge of Allegiance.

Chairman Gary Knight called the Executive Board (the Board) meeting of the Yuma Metropolitan Planning Organization (YMPO) to order at 1:30 p.m. He called on Supervisor Darren Simmons to lead the Pledge of Allegiance.

Declaration of Votes.

The Chairman submitted to Paul Ward, YMPO Executive Director, a proxy letter from Councilmember Jacob Miller and declared his proxy vote for a total of three votes for the City of Yuma.

3. Introduction of New Executive Board Members

The Chairman announced the new council member for the city of Yuma replacing Bill Craft as Karen Watts. Councilmember Watts was not present but was expected to arrive soon.

4. Call to the Public

No members of the public were present to address the Board.

5. Consent Agenda

The Chairman entertained a motion to approve for the consent agenda, as presented.

MOTION: Vice-Chair McCollough moved to approve the consent agenda, as presented. Supervisor Darren Simmons seconded, and the motion was unanimously passed.

Councilmember Karen Watts joined the meeting at 1:34 p.m. and was formally introduced by the Chairman as the new representative for the City of Yuma.

6. Annual Declaration of Votes

As required by YMPO By-Laws, the Chairman declared the annual votes for the City of Yuma for Calendar Year 2018 as follows: 2 votes for himself, 2 votes for Councilmember Watts and 1 vote for Councilmember Miller with a total of 5 votes for the City of Yuma.

7. Election of Committee Members

The Chairman recommended to defer agenda item to the next Board meeting until more members of the Board are present. Paul Ward agreed and continued by reporting that, in prior years, the State Transportation and RTAC Boards have had individuals nominated by YMPO as primary representatives. An alternate has also been identified in the past and suggested the possibility to regard all Board members as alternates for the State Transportation Board and similarly for the RTAC.

The Chairman entertained a motion to defer item to the next Board meeting.

MOTION: Supervisor moved to defer this item to the next Board meeting. Councilmember Watt seconded, and the motion was unanimously passed.

Vice Chairman J. Deal. Begay, representing the Cocopah Indian tribe, joined the meeting at 1:39 p.m.

8. FY 2018 YMPO Unified Work Program (UPWP) Amendment #1

Mr. Ward presented Amendment #1 of the FY 2018 YMPO Unified Planning Work Program (UPWP) and explained the reduction of federal funds available from \$1.5 million to \$1.2 million in detail.

The Chairman entertained a motion to approve the FY 2018 YMPO UPWP, Amendment #1.

MOTION: Vice-Chair McCollough moved to approve the FY 2018 YMPO UPWP Amendment #1. Supervisor Watts seconded, and the motion was unanimously passed.

9. Executive Director's Evaluation

The Chairman entertained a motion to recess to Executive Session.

MOTION: Vice-Chair McCollough moved to recess into Executive Session. Councilmember Watts seconded and the motion was unanimously passed.

10. Reconvene to Public Meeting

The Chairman entertained a motion to reconvene to Public Meeting at 2:16 pm.

MOTION: Vice-Chair McCollough moved to reconvene into regular session. Councilmember Watts seconded and the motion was unanimously passed.

11. Executive Director's Evaluation

The Chairman mentioned there was no need to discuss this item at this time, as action would be deferred to the next meeting. He moved onto the next item.

12. State Transportation Board (STB) Visit to the Yuma Region

The Chairman mention that he and Mr. Ward had attended the previous STB meeting in Sierra Vista earlier in the month and announced the next meeting will be held in Yuma on February 16, 2018, in the City of Yuma Council Chambers, starting at 9:00am.

Similar to prior occasions, Mayor Douglas Nicholls and the YMPO Executive Board will host the dinner for STB members, the evening before the meeting, February 15, 2018. He mentioned that the time and venue were still pending and would inform attendees as soon as that information became available.

The Chairman then announced that the Arizona Governor will also be in town on February 16th to give a 'State of the State' address at the Arizona Western College, starting at 11:30am. Due to the time in proximity of the meetings, he mentioned information would be conveyed to the STB accordingly and explained that STB meetings normally only last a couple of hours. The Chairman also mentioned a potential tour for Thursday of Yuma Proving Ground along with a helicopter ride over US Route 95 for STB members. More information to follow in due course.
