Declaration of Votes:

Councilmember Knight announced that he held a proxy for Councilmember Chris Morris,

#### 3. Title VI Declaration and Call to the Public

for a total of three votes for the City of Yuma.

DeLaurien McKenzie, YMPO Associate Planner, read the YMPO Title VI obligations. No members of the public addressed the Board.

#### 5. Possible New Offices for YMPO

The YMPO Executive Director, Paul Ward, started presenting on the possible new office at 230 West Morrison Street by providing some background information on the current lease and pointed out positive facts for purchasing the commercial property. He mentioned there would be more funds available to conduct studies and that members could possibly use depreciation as In-Kind matching funds, which means less cash from member agencies. Mr. Ward reviewed the steps needed to make the decision to purchase new offices. He showed Board members the possible new office location, layout plan, and parking spaces. Mr. Ward outlined decision-making pointers for the Board's guidance on possible new office acquisition and mentioned that, to preserve confidentiality in the acquisition process, members might wish to go into Executive Session for further discussion.

MOTION: Councilmember Knight moved to go into Executive Session. Supervisor Pancrazi seconded, and the motion was unanimously approved.

#### 6. **Executive Session**

The Board met in Executive Session to discuss the circumstances regarding possible acquisition of a commercial property. There are no minutes available for this period.

#### 7. Reconvene to Public Meeting

MOTION: Councilmember Gary Knight moved to reconvene to Public Meeting at 2:17 p.m. Vice-Mayor Cruz seconded, and the item was unanimously approved.

#### 8. Possible New YMPO - Open Discussion

Mr. Ward read Resolution 151 out loud, including some recommended changes.

MOTION: Supervisor Porchas moved to approve Resolution 151 which authorizes Mr. Ward to negotiate acquisition of the property as presented. Vice-Mayor Cruz seconded, and the item was unanimously approved.

MOTION: Councilmember Gary Knight moved to approve Resolution 151, as presented. Secretary/Treasurer, Supervisor Martin Porchas seconded, and the motion was unanimously approved.

MOTION: Councilmember Gary Knight moved to approve the consent agenda, as presented. Southwest District Engineer Paul Patane seconded, and the motion was unanimously approved.

#### 9. Steps to Achieve the 2020 Census

Mr. McKenzie provided the monthly update to the 2020 Census operations and confirmed there were six days left until September 30, 2020. He reviewed the most recent self-response percentages gathered per jurisdiction and reported on the lessons learned from the 2020 Census, to date. He mentioned that he is in constant communication with the State Demographer and will continue the effort for updates on the Tract and Boundary locations after the Census data collection period. Mr. McKenzie focused on how community involvement can help enhance the numbers during the next census cycle.

He mentioned that, towards the end of the current Census period, Ms. Albers, a Technical Advisory Committee representative from the City of Yuma, had a great idea to collaborate with YCIPTA to have Census representatives ride the bus for free as part of public participation efforts. Mr. McKenzie also mentioned that better identifying tracts and boundaries can help in the future census years. Mr. Ward added that YMPO is not directly involved in the Census count but can be - if local agencies ask for help - keeping in mind that there is constant communication with the State Demographer Jim Chang.

10. FY 2020-24 YMPO Transportation Improvement Program (TIP) - Amendment #2
Charles Gutierrez, Senior Planning/Mobility Manager reported on several changes to federal funded projects requested by three YMPO member agencies. In addition, YCIPTA also requested several changes to transit projects. He mentioned that the City of Yuma requested that the Surface Transportation Block Grant (STBG) funds for 8th Street Corridor project, programmed in FY 2023/24 be removed from that project and reprogrammed for their COY-23-10 16th Street Corridor project for Right of Way in FY 2023 and Construction in FY 2024. Further, he reported that the City of Yuma had already constructed the 8th Street project with other funds. Yuma County requested that the federal funds for their YC-20-01 mill and overlay project be deferred one year.

ADOT/Yuma County also requested the deferral of a bridge project by one year and a minor project name change.

MOTION: Councilmember Knight moved to approve requested changes to the FY 2020-24 YMPO Transportation Improvement Program – Amendment #2. Supervisor Porchas seconded, and the motion was unanimously approved.



#### **Declaration of Votes:**

Councilmember Knight declared a total of five votes for the City of Yuma. Two votes for himself, two votes for Deputy Mayor Watts, and one vote for Councilmember Morris.

#### Title VI Declaration and Call to the Public

Charles Gutierrez, YMPO Senior Planner/Mobility Manager, read the YMPO Title VI obligations. No members of the public addressed the Board.

#### 4. Possible New Offices for YMPO

Mr. Ward reported that, during the previous Board meeting on September 24, 2020, the Board approved a resolution authorizing him to negotiate with the owner of the commercial property at 230 West Morrison Street, Yuma, Arizona 85364. Mr. Ward reported that he met with the owners and obtained a verbal agreement for a purchase price of \$525,000, with an initial \$25,000 deposit to be placed in escrow and the remaining balance at closing on, or about, November 2, 2020. Mr. Ward mentioned that an detailed property inspection would be scheduled for the property within the allowed inspection period. He requested an amendment to the FY 2020-2021 Unified Planning Work Program (UPWP) FY 2021 only, to include local funds for the real estate purchased price plus additional funds for possible building improvements upon acquisition.

Since the item was not listed in this way on the agenda for action, Councilmember Knight recommended the deferral of the UPWP Amendment request to the next Board meeting or if needed, to schedule a special meeting. The Chair agreed and directed Mr. Ward to include this possible action for the next Board meeting agenda.

MOTION: Councilmember Knight moved to approve confirmation of the offer made by Mr. Ward to purchase the 230 West Morrison Street, Yuma, Arizona 85364 property for \$525,000 with an initial deposit to escrow for \$25,000. Vice-Mayor Cruz seconded, and the motion was unanimously approved.

### 5. Adjournment.

There being no further business to discuss, the meeting was adjourned at 2:05 p.m.
