Amendment #4 to the Fiscal Year 2020-21 YMPO Unified Planning Work

Program (UPWP) and Annual Budget, changes pertain to FY 2021 only.

The following is a list of the changes being requested to the FY 2021 of the FY 2020-21 YMPO UPWP under UPWP Amendment # 4:

- 1. Brought forward \$13,771.53 of FY 2020 Local funds under T-500 Special Project > for consulting work performed for the US-95 2020 BUILD Grant Application.
- 2. Increased the Capital Expenditure budget line item by \$600,000 of Local funds for the acquisition of the New Office Building for up to \$550,000; in addition, \$50,000 to carry out needed configuration changes to the interior and exterior of the property, for a total of \$600,000.
- Increase the T-100 budget by \$6,000 in Local Funds for Staff Training and 3. Education tuition reimbursement purposes.

The amount of the total (Federal & State Funds) budget for FY 2021 of the FY 2020-2021 UPWP has not changed; however, the amount of Local Area Funds has increased from \$42,388 to \$662,160, which represents a total increase of \$619,772. Therefore, the total amount of Federal, State and Local funds in the budget for FY 2021 has increased from \$1,622,274 to \$2,242,046.
