#### 6. <u>FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) Amendment</u> <u>#1 and Air Quality Conformity Status Update</u>

The consultant Kittleson and Associates continues to work on the FY 2022-2045 YMPO LRTP Amendment #1 and Air Quality Conformity update. A build/no build interim budget test for each analysis year for conformity purpose has been submitted to the Interagency Consultation (IAC) for review.

The Environmental Public Agency (EPA) submitted a list of questions and corrections to the consultant. The consultant resubmitted a revised document for review.

#### 7. FY 2026-2050 Long-Range Transportation Plan Kick-Off

A Notice to Proceed was issued to Kittelson & Associates in early January, with a development timeframe of sixteen months to complete the FY2026-2050 YMPO LRTP update. A kickoff meeting with YMPO staff was held. Collaboration from each YMPO member is encouraged during the LRTP update process.

TAC members will have the opportunity to involve staff from their respective agencies to participate in a technical working group during the update of the LRTP.

Consultant will provide a presentation with additional details.

#### 8. FY 2022-26 Transportation Improvement Program (TIP) Amendment #12

The FY 2022-26 YMPO TIP was initially approved on July 29, 2021, and has since been amended eleven times, most recently on December 14, 2023, through the Executive Board. Yuma County requested to increase the federal funding for the Avenue 3E Bridge over the "A" Canal and ADOT has requested a list of administrative changes to the TIP table.

This item is on the agenda for information, discussion, and possible action to recommend the FY2022-26 YMPO TIP Amendment #12 for approval by the Executive Board. #### 9. <u>Transportation Alternatives (TA) Program Update</u>

The TA program is a 10% set-aside of the Surface Transportation Block Program (STBG) Program established under the Bipartisan Infrastructure Law (BIL). The TA program provides funding for generally smaller-scale alternative transportation projects. The State Transportation Board approved all three YMPO projects on November 17, 2023.

#### 10. 2024-2025 CO2 Emission Targets

The Federal Highway Administration (FHWA) released the final greenhouse gas (GHG) rule on November 22, 2023. The final rule requires the State Department of Transportation set a declining carbon dioxide (CO2) emissions target for the National Highway System (NHS) by February 1, 2024.

ADOT requests a letter within 180 days of this notification indicating whether YMPO supports ADOT's 2024 CO2 target or identify a CO2 target for the YMPO region.



#### 1. <u>Call to Order and Declaration of Votes</u>

Chairman Eulogio Vera called the meeting to order at 9:00 A.M. The city of Yuma declared votes Dave Wostenberg (2 votes), Erika Peterson (2 votes), Susan Cowey (1 vote). Yuma County declared votes Frank Sanchez (1 vote) and Kelly Fricke (1 Vote).

#### 2. <u>Title VI of the Civil Rights ACT of 1964</u>

The YMPO Title VI Nondiscrimination Notice to the Public was read by YMPO Mobility Manager, JR Aguilar.

#### 3. <u>Call to the Public</u>

There were no announcements from the public or TAC.

#### 4. Approval of Minutes

December 14, 2023, TAC meeting minutes had been included with the agenda. Dave Wostenberg, City of Yuma, moved to approve the minutes and Frank Sanchez, Yuma County, seconded the motion, which was unanimously approved.

#### 5. <u>Election of Officers</u>

YMPO Senior Transportation Planner, Fernando Villegas, informed members about the process of electing the officer structure for the year and according the according to YMPO Bylaws. Mr. Villegas also informed members that the Executive Board meeting coming up will also have the Election of Officers. Mr. Villegas presented a possible rotation table included on the agenda. Mr. Villegas explained that the rotation table shows Charles Gutierrez, City of Somerton, was up next for Vice Chairman. Mr. Villegas continued stating that Chairman, Eulogio Vera, has the option to elect today for Vice Chairman or to wait for Executive Board to elect their new Vice Chairman.

Member Charles Gutierrez asked what the rotation was currently at for the Executive Board.

Crystal Figueroa, YMPO Executive Director, stated Gary Knight, City of Yuma, as Chairman, Cecilia McCollough, Town of Wellton as Vice Chairman and Maria Cruz, City of San Luis, as Treasurer. Ms. Figueroa continued to explain that the rotation would be Vice Chairman, Cecilia McCollough, to Chairman and Treasurer Maria Cruz, to Vice Chairman. Ms. Figueroa continued to state that the rotation for TAC would be Vice Chairman Frank Sanchez, Yuma County, to Chairman and Member Charles Gutierrez, City of Somerton, to Vice President.

Mr. Villegas recommended a motion to elect the Vice Chairman. Eulogio Vera, City of San Luis, asked if there was a motion to elect new Chairman and Vice Chairman. Dave Wostenberg, City of Yuma, moved to approve election of Vice Chairman Frank Sanchez for Chairman and Charles Gutierrez for Vice Chairman. Charles Gutierrez second the motion which was unanimously approved.

Dave Wostenberg asked if the decision had to be waited on for confirmation from the Executive Board. Charles Gutierrez answered that in the past, the transition was made at that moment with no need for confirmation or approval from the Executive Board.

#### 6. <u>FY 2022-2045 YMPO Long-Range Transportation Plan (LRTP) Amendment</u> <u>#1 and Air Quality Conformity Status Update</u>

YMPO Senior Transportation Planner, Fernando Villegas, informed members that Vamshi Yellisetty, consultant at Kittleson and Associates was giving the update on the amendment. Mr. Yellisetty informed the committee that they did submit the LRTP Amendment #1 and the corresponding Air Quality conformity to the interagency council and stated it was due at the end of December but there was an approved extension until January 12<sup>th</sup>. Mr. Yellisetty informed members that there were two comments from ADEQ, but EPA had initiated a call a couple of days prior with Crystal to discuss potential revisions. Mr. Yellisetty continued informing members that EPA will summarize their comments and then send it back to them by the end of the following day. Mr. Yellisetty stated that they aren't sure what the comments are, but they don't think that will change the direction of the project but will continue to keep everyone informed.

#### 7. STBG Available Funding

Fernando Villegas presented this item informing members that the Town of Wellton first made a request to withdraw their project from Fiscal Year 2026, but they decided to keep the project on. Mr. Villegas continued by stating that after he checked the numbers on TIP Amendment #11, he noticed a change. Mr. Villegas informed members that in FY 2024, City of Yuma has the bridge over 40<sup>th</sup> street and Avenue 7E project and any available funding after that fiscal year is going to be moved to the next year for the construction of two projects, City of Yuma 40<sup>th</sup> Street and the Yuma County bridge over "A" Canal and Avenue 3E.

Mr. Villegas explains that before amendment #11 this Yuma County project had STBG fundings in two different fiscal years for construction, so he informed Yuma County that they needed to move the construction funding to one fiscal year. In result of the STBG funds in two fiscal years, when amendment was done, the additional money was not removed and created the balance at the end of fiscal year 2025. Mr. Villegas continued to inform members that before the amendment, they were searching for a possible loan and one MPO offered \$104,359.00 but since there were STBG funds available the loan possibly was not needed.

Mr. Villegas then informed members that in Fiscal Year 2026 there is some available funding, like the Town of Wellton who kept their project on, as an option but to go after the MPO loan, they must create an amendment for the cost of the Yuma County project.

Mr. Sanchez agreed that if available balance from fiscal year 2025 could be applied to the Yuma County 3E bridge project, to be able to ask for the loan for fiscal year 2025.

Mr. Villegas informed Mr. Sanchez that as of right now, the additional \$41,412.00 could be used along with the Sierra Vista MPO loan that is being offered and include it as part of the Yuma County 3E bridge project. Mr. Villegas informed Mr. Sanchez that the total amount of \$145,771.00 included available funding and Sierra Vista MPO loan. Mr. Villegas asked Mr. Sanchez if he wanted him to continue to look for loans with other MPOs or if that available amount would suffice.

Mr. Sanchez stated he would like to get the Sierra Vista MPO loan and to continue to look for other MPOs for loans.

Mr. Villegas said he would look for additional funding options with other MPOs. He also informed Mr. Sanchez that an amendment needs to be done for the Yuma County Avenue 3E bridge project to be able to go after the MPO loans. Mr. Villegas included that he needed an email from Yuma County with the change in the Yuma County Avenue 3E bridge project federal funding request amount, and the amendment will be presented to the TAC members at the following TAC Meeting.

Ms. Figueroa stated this item will be presented to the Chairman for the amendment, action, and consideration of all TAC members at the next TAC meeting.

#### 8. <u>Transportation Alternatives (TA) Program Update</u>

YMPO IT Manager/Associate Planner Jeff Heinrichs presented this item. Mr. Heinrichs informed TAC members that the project initiation step was due by December 31<sup>st</sup>, 2023, and the three projects in the YMPO region have submitted their projects to ADOT and received approval to move forward. Mr. Heinrichs continued to inform members that the next deadline is on January 31<sup>st</sup>, 2024 to have the IGA's in place with ADOT. Mr. Heinrichs adds that he is looking forward to the next Call of Projects for the new projects that were discovered to be able to do something for historical preservation for Hotel Del Sol.

Ms. Figueroa addressed members and stated that she spoke with the TA TAC Chair, Irene Higgs, and she stated to her that the next call would be in June.

#### 9. FY 2026-2050 Long-Range Transportation Plan Update

Crystal Figueroa presented this item informing members that since there was one proposal release received for the FY2026-2050 LRTP, members can review its ranked scores and recommend contract award to the qualified consultant Kittleson & Associates, Inc to the YMPO Executive Board contingent on negotiations with consultant to reduce cost proposal.

Ms. Crystal Figueroa added that she has successfully negotiated the cost and an agreement has been reached. Ms. Figueroa explained that the reduced cost came in under the budget amount for the LRTP of \$412,000.00 to not exceed that amount. Ms. Figueroa added that this effort is primarily funded with FHWA Metropolitan Planning funds, some FTA 5305d Consolidated Planning Grant fund, and STGB funds. Ms. Figueroa added that the agreement to proceed has been issued to the consultant, and a scope of work was added to the agenda for the TAC to review the project. Ms. Figueroa added that the consultant will be in her office next month for the final scope of work. Ms. Figueroa explained that in her scope of work draft included in the agenda, any boxed items are the items that changed to reduce the scope of work cost, which was discussed at the prior TAC meeting in December and asked for any feedback on the scope of work documentation.

Ms. Figueroa asked Vamshi Yellisetty to provide a summary of what members could expect with the Highway Safety Improvement program applications.

Mr. Yellisetty informed members that the new HSIV Call for Projects has been released and part of the LRTP update, they have in their scope to develop up to seven HSIP applications. Mr. Yellisetty informed members that the process they would be following Michael from Greenlight will lead that effort for them and he will be reviewing the crash data for the last five years; based on the crash data, he will identify potential hot spots that could be good candidates for the HSIP applications. Mr. Yellisetty continues by stating once that crash data is collected, Greenlight will be in contact with each member to discuss if that would be a good project to proceed with. Mr. Yellisetty added that if there are more than seven good candidates, he will work with Crystal to see how they can accommodate that but if it's up to seven, it's within the scope. Mr. Yellisetty then continued to inform members that once the draft application is completed by Mike, it will be sent to members for review and Crystal would submit to ADOT. Mr. Yellisetty added that the applications are due in May 2024.

Mr. Sanchez asked if this item will be sent to the Executive Board for approval.

Ms. Figueroa answered that the Executive Board already approved the contract contingent on negotiation.

Dave Wostenberg, City of Yuma, addressed the committee and stated that he had previously spoke with Michael at Greenlight regarding systemic improvements that included flashing left turn signals and asked Mr. Yellisetty if improvements such as those would be included in this type of project or just as a hot spot location.

Mr. Yellisetty answered that from his understanding, if the project benefit costs exceed the minimum, it ends up being a good project, but systemic projects are qualifying type of projects. Mr. Yellisetty added that they could talk about those projects furthermore in the future.

#### 10. Mobility Management Update and PASS Training

YMPO Mobility Manager, JR Aguilar, presented this item. Mr. Aguilar informed members that this FY in October the contracts were signed for providers in the 5310 Program, receiving their portions of capitol or operating funds and they await their vehicles that are supposed to be disbursed by the FTA which is causing a delay in delivery. Mr. Aguilar added that the Mobility Management grant is coming up and says that between January and February, the NOFA for the Mobility Management Grant will be active in E-grants. Mr. Aguilar also stated that YMPO will be submitting the grant in early March but will continue to wait for ADOT to issue the NOFA.

Mr. Aguilar also informed the committee that the PASS training that was sought after last year, had completed its first class in November 2023 with a total of ten students that attended and received their certifications. Mr. Aguilar described PASS training as providing drivers with the forefront knowledge of what it is to be passenger assistance safety & sensitivity towards their passengers. Mr. Aguilar also added that a new PASS training class is set up on January 26, 2024, where they will also have ten spots open for the drivers of the region to attend. Mr. Aguilar also stated that this program is through RTAP with ADOT to receive scholarship money to make sure this class is offered to providers for free.

Ms. Figueroa addressed the committee stating that PASS training classes might possibly be offered in other parts of the region.

Mr. Aguilar agreed and stated that is one of the goals of the PASS Training; to be able to provide this class in other parts of the state.

Chairman Sanchez asked how the turnover for drivers was.

Mr. Aguilar responded that right now providers are having a hard time keeping drivers, especially in the medical field such as drivers who service people with disabilities or limitations and older adults. Mr. Aguilar added that in hopes of having a higher driver retention rate, PASS training certification lasts three years and gives drivers the motivation to continue with their job.

#### 11. RAISE GRANT 2024

Ms. Figueroa presented this item stating that the RAISE Grant NOFO was released and the deadline for the application is February 28<sup>th</sup>. Ms. Figuroa continued by stating that YMPO was notified by Yuma County that we intend to purse a RAISE Grant for Ave D alignment. Ms. Figueroa informed the committee that in their agenda there is a letter of consideration that was prepared to review. Ms. Figueroa then asked the committee of any of its members and their jurisdictions were actively seeking a RAISE grant as well. No other entity responded. Ms. Figueroa then continued by stating that if members found no error in grammar or information on the letter of recommendation, it could be presented to the Executive Board.

Chairman Sanchez stated the letter looked fine and no changes need to be made.

Charles Gutierrez, City of Somerton, addressed the committee with some grammatical errors in the letter and confirmed that Crystal will make sure those changes are updated before submitting. Mr. Gutierrez also questioned paragraph 4 of the letter. Mr. Gutierrez stated that SR-195 and US-95 operated at poor levels of service during peak periods. Mr. Gutierrez stated that SR-195 has not changed to poor levels of service.

Chairman Sanchez agreed and stated that that part of the letter should be US-95 and Ave B not SR-195.

Mr. Gutierrez added that he wrote his grammatical error finding in the GOTO Meeting chat for correction.

Ms. Figueroa stated she will have the errors revised.

Mr. Vera motioned to approve the letter of recommendation with corrections. Mr. Wostenberg 2<sup>nd</sup> the motion. The motion was unanimously approved.

#### 12. Safety Action Plan Collaboration

Ms. Figueroa presented this item stating that the City of Yuma applied for and was awarded a FY23 SS4A Planning and Demonstration Grant to develop a comprehensive Safety Action Plan. Ms. Figueroa continued by informing members that YMPO last performed a strategic transportation Safety Action Plan for the region in 2019 using crash data from 2014-2018. Ms. Figueroa added that YMPO currently has funding in the Unified Work Program to carry out a safety update for the region. Ms. Figueroa continued to state that in order to avoid duplication of efforts and to consider the SS4A grant that was awarded to the city, to include the rest of the region in the action plan but at a cost to YMPO via an intergovernmental agreement is viable per communication with city staff.

Ms. Figuroa also stated that SS4A program requires an eligible Action Plan to pursue funding for the implementation of projects and strategies which is the second grant option under SS4A.

Mr. Wostenberg addressed the committee stating that the Safety Action Plan must be updated every five years to remain eligible for those additional grants for the design and implementation. Mr. Wostenberg added that they also have some demonstration grant money available and stated that the City of Yuma is looking at doing the Safety Action Plan to be eligible for additional SS4A for planning and design. Mr. Wostenberg also stated that currently, the City of Yuma is working with FTA who is the direct recipient. Mr. Wostenberg also stated they are working with Federal Highway Administration (FHWA), for training on January 23<sup>rd</sup> for the SS4A grant and will start the writing on the grant there after, taking about 3-6 months. Mr. Wostenberg informed the committee that the City of Yuma is looking at receiving the grant by May. Mr. Wostenberg also stated City of Yuma is at \$600,000.00 for \$480,00.00 as a 20% match would be \$120,000.00 beyond what the cities portion is would be to come from YMPO or other agencies.

Ms. Figueroa asked Mr. Wostenberg if the City of Yuma will have to go through the bidding process.

Mr. Wostenberg answered yes that once City of Yuma gets the award, they will do an RFQ to bring in their consultant and will then negotiate the scope of fees and at that point, they will need to have their IGA with YMPO in place.

Chairman Sanchez asked Mr. Wostenberg if he recalls who did their last scope.

Mr. Wostenberg answered that they did not have a previous Safety Action Plan.

Ms. Figueroa asked Mr. Wostenberg for clarity that the City of Yuma did meet with FHWA to ensure collaboration.

Mr. Wostenberg answered yes and stated that it was back in November 2023, and they said yes, they would be able to go ahead and expand it for the region. Mr. Wostenberg also informed the committee that in order to be eligible for SS4A, YMPO must have adopted Vision Zero and stated that the city council had adopted Vision Zero back in September.

ADOT Senior Planner, Mark Hoffman, addressed the committee by asking if its anticipated that the scope of the action plan under SS4A will be similar to what was completed in the last regionals.

Ms. Figueroa answered that she was not aware but would have to investigate that.

Mr. Vera moved to approve the possible collaboration with the City of Yuma for the safety action plan. Ms. Fricke 2<sup>nd</sup> the motion. Motion was unanimously approved.

#### 13. <u>YMPO and ADOT</u>

Mr. Villegas presented this item to the committee stating the update on the B-Canal bridge on Ave 4E, north of 32<sup>nd</sup> street, asking for scoping at \$160,000.00 including ADOT fee. Mr. Villegas continued by stating update on the 3<sup>rd</sup> St bridge on 1<sup>st</sup> St and Ave A, also asking for scoping for \$153,000.00. Mr. Villegas stated that only two applications were received for the City of Yuma, and they were submitted to ADOT for review.

Mr. Villegas also stated that the HSIP Call for Projects has a webinar on January 18<sup>th</sup>.

Chairman Sanchez asked Mr. Villegas for the details of quantities mentioned earlier.

Mr. Villegas answered stating the first application on the B Canal bridge on Ave 4E, they requested \$30,000.00 STBG program funding for the ADOT fee and an additional \$129,500.00 for the scoping on the bridge and that the amount is close to \$160,000.00. Mr. Villegas continued stating that for the second application, 3<sup>rd</sup> St bridge on 1<sup>st</sup> St. \$30,000.00 for the ADOT fee and \$122,500.00 for scoping on the 3<sup>rd</sup> St bridge.

Chairman Sanchez stated that he was not aware that just for the scoping of these projects there was a charge.

ADOT LPA, Mark Hennig, addressed the committee stating that ADOT is struggling with PDA costs and trying to keep them low. Mr. Hennig added that with the bridge, the scoping is going up too because of the preliminary engineering. Mr. Hennig continues to state that the inflation cost on unit prices of all materials needed to grow, reconstruct, or rehabilitate or replace a bridge structure is high. Mr. Hennig informs members that the PDA is anticipated to move forward with these projects and to final design as best as possible.

Chairman Sanchez asked Mr. Hennig if an agency goes through that whole process and we use STBG Funds to pay for the PDA costs and scoping letters, would that guarantee that the project would get funded.

Mr. Hennig states that ADOT cannot give that guarantee and states that ADOT's goal is that any bridge structure that is in poor or fair condition to use funds from the IGA to bring them up to good condition. Mr. Hennig also stated that if the program does not get approved to move forward with the next bill to get approved for transportation, they will use STBG funds. Mr. Hennig continues by stating that there is pressure internally and they do adjust internally for when it makes sense and that sometimes they must go out and check in person the soil, dirt, and area and that it is not only always just a scoping letter. Mr. Hennig added that it is scoping up to 30%.

There was no update from ADOT Mark Hoffman on the MPD.

#### 14. In-Kind Match Forms

Mr. Villegas stated that everyone has their In-Kind forms in person and for virtual attendees, he would email In-Kind forms to them.

Town of Wellton: No projects listed.

#### Yuma County:

Chairman Sanchez provided these updates:

Avenue D/E Corridor: 16th Street to 23rd Street – waiting on amendment.

Red Cloud Mine Road – WHS came to an agreement with a contractor, working on awarding project.

North Frontage Road: Avenue 10E to Fortuna Road – Contractors continuing with storm drain along north Frontage Rd and along with that started to place AB. Will start paving the north side of road in early February. About 40% complete.

Chairman Sanchez asked Fernando Villegas to add the Ave 3E and County 14 1/2 St Bridge to County of Yuma's list of current projects.

#### City of San Luis:

Mr. Vera provided these updates:

Cesar Chavez (Juan Sanchez) Boulevard Improvements – working with some of the private landowners, working with ADOT for final design, will be ready in about 10 months or so.

10<sup>th</sup> Avenue Los Alamos St. Curve Realignment – working with consultant.

US95-County 20 ½ St.-County 22<sup>nd</sup> Raised Medians – approved by council prior night so will begin project.

County 22<sup>nd</sup> and 4<sup>th</sup> Avenue Intersection Improvements – In the works, design is about 80-90% complete.

County 22<sup>nd</sup> and Sidewinder Rd. Traffic Signal Implementation – Intersection improvements have been completed and are now working on traffic signal and have ordered the equipment to start construction.

#### City of Yuma:

Mr. Wostenberg provided these updates:

North End Pavement Replacement – 60% percent complete, hoping to wrap up in April.

Pavement Marking Upgrade, Citywide – HSIP design this year, construction next year.

Avenue B Reconstruction, 24th St to 16th St – Bids were rejected and will continue to negotiate with bidders in April for rebid.

40th Street Construction, 7 1/2E to 10E – Really should be 6E to Fortuna, in construction, DCR working to finalize scoping fees, working with Yuma County for IGA. Trying to get fee down \$500,000.00.

Bridge - Ave 7E & 40th St over A Canal – under construction, hopefully completed in May or June.

28th St Widening, 45th Ave to 33rd Dr. – relocation work in progress by water users.

28th St Reconstruction, 8th Ave to Madison Ave and Virginia, 28th St to 27th St – Out for bid.

18th Street and Avenue C Traffic Signal – On hold, not sure if signal is needed. Traffic Signal Flashing Yellow Turn Arrow Installation – HSIP design this year, construct next year.

Traffic Signal, Pedestrian Hybrid Beacons (5 Locations) – HSIP design this year, construction next year.

Traffic Signal, Pedestrian Hybrid Beacons (3 Locations) – HSIP design this year, construction next year.

Hotel Del Sol Multimodal Center – Writing paper grant, working with consultant to get another P3 RFQ. Expecting to have grant in place about April and have a sturdy schedule in for design and construction.

Avenue 3E and 32nd Street Median Landscape – Still working on design. Traffic Operations Center – Meeting to see if HD camaras can be installed.









## 1. SUMMARY OF CHANGES IN AMENDMENT 1

Since the completion of the Yuma Metropolitan Planning Organization's (YMPO) 2022-2045 Long-Range Transportation Plan (LRTP) in July 2021, some project needs have changed; and YMPO and its member agencies have been successful in securing additional funding to advance some projects. To accommodate these changes, YMPO is amending the 2022-2045 LRTP to include the following revisions to the original LRTP.






Figure 8.3. Roadway Improvement Needs



### **Newly Paved Roads**

In addition to the emissions reduction sources described above, there will be emissions reductions gained through newly-paved roads and widened roads that are recommended in the 2022–2045 LRTP. Emissions reductions were estimated by analysis year for these paving improvements.

## **Results and Conclusions**

**PM10:** Since the completion and conformity determination of the 2022-2026 YMPO TIP and 2022-2045 LRTP, EPA rescinded its previously issued clean data determination (CDD) for the Yuma, Arizona "Moderate" nonattainment area for the 1987 24-hour NAAQS for PM10. This was effective June 17, 2022. In addition to rescinding the CDD, the EPA also did an inadequacy finding for the previously submitted budgets, effective June 16, 2022 (87 FR 29830). As a result, the proposed 2022-2045 LRTP Amendment #1 determines conformity for PM10 using interim emission test as outlined in 40 CFR 93.119, instead of the past maintenance plan Motor Vehicle Emissions Budgets (MVEBs).

**Ozone:** No budgets are currently established for the Yuma 2015 ozone nonattainment area. Since a budget has not been set for ozone, the baseline year test was used to demonstrate conformity. The baseline year is defined as the most recent year for which EPA's Air Emissions Reporting Rule requires submission of on-road mobile source emissions inventories as of the effective date of designation, which is 2017 for the 2015 8-hour ozone NAAQS.

Results from the PM10 interim emissions test (Build Vs No-Build) analysis are summarized in Table 10.1.

Emissions estimates from MOVES3.0.1 were determined for ozone for the years 2025, 2035, and 2045 and compared to the baseline year of 2017. Ozone is modeled for its precursors: NOx and VOC. **Table 10.2** shows the mobile source emissions results for the baseline year 2017 and analysis years for NOx and VOC.

The air quality analysis performed demonstrates conformity between the 2022-2026 Transportation Improvement Program, the 2022 - 2045 Long-Range Transportation Plan Amendment #1, and the interim emissions test (Build Vs No-Build). As illustrated in Tables 12 and 15, the analysis indicates that the projected emissions levels based on projects contained in the YMPO LRTP Update 2022-2045 Amendment #1 meet the applicable conformity tests. Therefore, it is the determination of this analysis that this plan conforms under the 1987 PM<sub>10</sub> and the 2015 8-hour ozone National Ambient Air Quality Standards.

YMPO Responsibilities:

The 2022 baseline is 16.75 million metric tons of CO2 emissions on the Arizona NHS and the Arizona Department of Transportation (ADOT) has established a State target of -0.1% reduction in CO2 emissions.

Metropolitan Planning Organizations (MPO) can either adopt the State target or establish a target for their region within 180 days of the State adoption of the target. If the MPO elects to establish their own target they may calculate the baseline and subsequent GHG metrics by either using the MPO share of State vehicle miles traveled (VMT) as a proxy for the MPO share of CO2, VMT estimates along with MOVES emission factors, the FHWA Energy and Emission Reduction Policy Analysis Tool, or other method that the MPO can demonstrate has valid and useful results for CO2 measurement.
